Note 1. DESCRIPTION OF THE PLAN

The following description of the IMS Recycling Services, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was adopted by IMS Recycling Services, Inc. ("IMS Recycling") on January 1, 1965, and was most recently amended and restated effective January 1, 2015. The Plan provides retirement benefits to the employees of IMS Recycling and its affiliates: CP Manufacturing, Inc., MSS, Inc., Material Sales, Inc., and IMS Electronics Recycling, Inc. (collectively referred to as the "Company"). The Plan is a defined contribution retirement plan of the profit-sharing type containing a cash or deferred arrangement described in Internal Revenue Code ("IRC") Section 401(a). All full-time employees of the Company are eligible to participate in the Plan provided they are at least age 18. Certain classes of employees as defined by the Plan document are excluded from participating in the Plan. Participants may enter the Plan on the first day of the month following eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and certain provisions of the IRC.

Plan Administration

The Company is the administrator of the Plan. As administrator, the Company has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan (including the authority and responsibility to invest, manage, and control the assets of the Plan specifically allocated to the trustee). Charles Schwab Trust Bank is the appointed trustee for the Plan and acts at the direction of the Plan's administrator.

Contributions

Employees who elect to participate in the Plan may contribute a portion of their eligible compensation pursuant to Code Section 401(k) up to the limits imposed by Section 402(g) of the IRC. Participants who have attained age 50 before the end of a calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate.

Contributions (continued)

Automatically enrolled participants have an initial deferral rate of 5% of compensation, and their contributions are invested in a designated fund until changed by the participant. On January 1<sup>st</sup> of the year after which the participant attains one year of participation in the Plan, the pre-tax deferral rate for automatically enrolled participants is increased by 1%, to a maximum deferral rate of 6%.

The Company may make discretionary matching and/or profit-sharing contributions to the Plan. Participants are eligible to receive Company contributions if they have completed 12 months of service and are employed on the last day of the Plan year. The Company made matching contributions of \$266,890 and \$249,307 for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions, an allocation of Company contributions, and the earnings or losses from their investment account.

Certain fees are charged to the Plan's investments and are presented as a reduction of investment earnings as reported in the statements of changes in net assets available for benefits.

Vesting

Participants are immediately vested in their contributions and related actual earnings. Vesting in the Company's contributions and related actual earnings is based on years of service. Participants are 100% vested in Company matching contributions after one year of credited service. Participants are 100% vested in Company profit-sharing contributions after six years of service.

Forfeited Accounts

Forfeitures can be used to reduce expenses related to the administration of the Plan or to reduce Company contributions. The Plan did not have any forfeitures or forfeiture activity during the years ended December 31, 2024 and 2023.

Investment Options

Upon enrollment in the Plan, a participant may direct his or her contributions in percentage increments into a series of mutual funds, interest-bearing cash, and a common/collective trust offered by the Plan. Participants may change their investment options as of the first day of each month.

Participant Notes Receivable

Participants are allowed to borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participant notes receivable provide for periodic repayment through automatic deductions through regular payroll and are repaid over a reasonable period of time. Participant notes receivable bear a reasonable rate of interest, commensurate with what would be charged by a lending institution providing similar loans, as determined by the plan administrator at the time the loan originates. Interest rates on participant notes receivable ranged from 5.25% to 10.50% as of December 31, 2024 and 2023.

Payment of Benefits

Upon retirement or termination of employment, participants (or their beneficiaries) may receive the value of their vested account balance in a lump-sum or in installments over a period of not more than their assumed life expectancy. In-service withdrawals (must have attained age 59½) and hardship withdrawals are also permitted.

Note 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

Investment Valuation

Investments in mutual funds are stated at fair value based on quoted market prices in active markets. Investments in the common/collective trust are stated at fair value based on the fair value of the underlying investments in the trust.

Participant Notes Receivable

Participant loans are classified as notes receivable and are stated at their unpaid principal balance plus any accrued but unpaid interest.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Company.

Note 3. INVESTMENT IN COMMON/COLLECTIVE TRUST

The Plan invests in the Morley Stable Value Fund, which is a common/collective trust. The investment objective of the Morley Stable Value Fund is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile, and liquidity for benefit payments. Withdrawals from the Morley Stable Value Fund for benefit payments and participant transfers to noncompeting options are made to Plan participants promptly upon request but in all cases within 30 days after written notification has been received. All Plan sponsor-directed full or partial withdrawals are subject to a twelve month advance written notice requirement, though the Morley Stable Value Fund may waive this requirement at its discretion.

Note 4. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value. Generally accepted accounting principles establish a fair value hierarchy that prioritize the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are defined as follows:

*Level 1 Fair Value Measurements*

Inputs are unadjusted quoted market prices available in active markets for identical assets on the reporting date.

*Level 2 Fair Value Measurements*

Inputs are quoted prices for similar instruments in active markets, or quoted prices for identical or similar instruments in markets that are not active. The fair value of the investment in the common/collective trust is based on the value of the underlying investments held by the trust.

*Level 3 Fair Value Measurements*

Inputs are unobservable where there is little or no market activity and assumptions are based on internally derived information.

Note 6. PARTY-IN-INTEREST

Certain expenses of the Plan are paid for by the Company. The Company is the sponsor of the Plan and, therefore, these transactions qualify as party-in-interest. The most significant of these costs are the salaries for the employees responsible for Plan administration and fees paid to a third-party administrator.

Certain Plan investments are managed by Charles Schwab Trust Bank, the trustee of the Plan. All purchases and sales of these investments are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan, and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Fees paid by the Plan to parties-in-interest for administrative services amounted to \$26,479 and \$24,425 for the years ended December 31, 2024 and 2023, respectively.

Note 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. TAX STATUS

The Plan is operated under the terms of a non-standardized prototype plan offered by Tri-Ad Actuaries, Inc. The prototype plan received a determination letter from the Internal Revenue Service dated March 31, 2014, indicating that the plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The prototype plan has been amended since receipt of the determination letter. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for an uncertain position if it is not more likely than not that the position would be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Note 9. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 10. SUBSEQUENT EVENTS

Effective June 30, 2025, the Plan changed its name from IMS Recycling Services, Inc. 401(k) Profit Sharing Plan to CP Manufacturing, LLC 401(k) Profit Sharing Plan. The name change was made to reflect a change to the Plan sponsor from IMS Recycling Services, Inc. to CP Manufacturing, LLC. The Plan provides retirement benefits to the employees of CP Manufacturing, LLC and its affiliates: IMS Recycling Services, Inc., MSS, LLC, and Material Sales, Inc. There were no other changes to the Plan, its operation, or the number of participating employees as a result of the name and Plan sponsor changes. The changes have no impact on the financial position of the Plan as of December 31, 2024, or the changes in its net assets available for benefits for the year then ended.

Subsequent events were evaluated for accrual and disclosure through September 4, 2025, which is the date the 2024 financial statements were available to be issued.
