## **INDEPENDENT AUDITOR'S REPORT**

To the Administrator and Board of Trustees of  
Óptima Seguros Profit Sharing & Savings Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Óptima Seguros Profit Sharing & Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Óptima Seguros Profit Sharing & Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Óptima Seguros Profit Sharing & Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 - DESCRIPTION OF PLAN**

The following brief description of Óptima Seguros Profit Sharing & Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of Óptima Seguros, Colonial Insurance Agency, Inc. and New Century Finance, Corp. (the Sponsor), who have completed six (6) months of continuous service. The Plan became effective on May 1, 2010. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Participants may contribute a percentage of their compensation, as defined in the Plan, not exceeding the maximum deferral amount specified by local law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions limited to \$1,500 per Plan year commencing in 2013 and thereafter, or such other amendment of the Puerto Rico Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified plans. The Sponsor shall contribute as a matching employer contribution an amount equal to fifty cents for each dollar of participants' pretax contribution up to a maximum participant contribution of six percent (6%) of salary. The Sponsor may make a discretionary profit-sharing contribution, which is limited to the lesser of fifteen percent (15%) of participants' compensation. Contributions are subject to certain limitations.

**Participants' accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Sponsor's contribution and, (b) Plan earnings. Allocations are based on participant's earnings, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTE 1 - DESCRIPTION OF PLAN - CONTINUED**

**Vesting**

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Sponsor's contributions portion on their accounts, plus earnings thereon, is based on years of continuous service as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
At least 1	0%
At least 2	25%
At least 3	50%
At least 4	75%
At least 5	100%

**Participants' notes receivable**

Participants may borrow from their funds a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The notes receivable are secured by the balance in the participant's account and bear interest at one percent over prime rate determined monthly, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

**Payment of benefits**

On termination of service due to death, disability or retirement, a participant or the participant's beneficiaries may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or periodical installments over a certain number of years not to exceed a ten-year period. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Forfeitures**

Upon participant's termination from employment or withdrawal from the Plan for any reason other than death, retirement or disability, the employer contributions on behalf of the participants not then vested are forfeited accounts, which may be used to reduce the Sponsor's contribution to the Plan or payment of expenses of the Plan. At December 31, 2024 and 2023, balances in the forfeiture account were \$5,137 and \$8,512, respectively.

**NOTE 1 - DESCRIPTION OF PLAN - CONTINUED**

**Plan expenses and administration**

The Sponsor is responsible for the general administration of the Plan and for carrying out the provisions thereof. Sponsor's contributions are held and managed by Banco Popular de Puerto Rico (the Trustee), who manages cash received and interest income. Certain administrative functions are performed by officers or employees of the Sponsor. No such officers or employees receive compensation from the Plan. All reasonable expenses related to the Plan administration will be paid by the Sponsor.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of accounting**

The financial statements have been prepared in accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Accounting policies**

**Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investments valuation and income recognition**

The Plan's investments are stated at fair value. The Plan presents in the statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consist of the realized gains or losses and the unrealized appreciation (depreciation) on them.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded when received.

**Payment of benefits**

Benefits are recorded when paid.

**Participants' notes receivable**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED**

**Fair value measurements**

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements are based upon observable and unobservable inputs. Observable inputs reflect market data obtained from independent sources while unobservable inputs reflect the Plan's view of market assumptions in the absence of observable market information. The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. In determining fair value, the Plan uses various methods including market, income and cost approaches.

The Plan categorizes its fair value measurements into a three-level hierarchy based on the priority of the inputs to the valuation technique. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). If the inputs used to measure fair value fall within different levels of the hierarchy, the category level is based on the lowest priority level input that is significant to the fair value measurement of the instrument in its entirety.

The Plan categorizes assets and liabilities carried at fair value in the accompanying statement of net assets available for benefits as follows:

- Level 1 - Unadjusted quoted prices accessible in active markets for identical assets or liabilities at the measurement date and mutual funds where the value per share (unit) is determined and published daily and is the basis for current transactions.
- Level 2 - Unadjusted quoted prices for similar assets or liabilities in active markets or inputs (other than quoted prices) that are observable or that are derived principally from or corroborated by observable market data through correlation or other means. Primary inputs to this valuation technique may include comparative trades, bid/asks, interest rate movements, U.S. Treasury rates, London Interbank Offered Rate ("LIBOR"), prime rates, cash flows, maturity dates, call ability, estimated prepayments, and/or underlying collateral values.
- Level 3 - Prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. Inputs reflect management's best estimate about the assumptions market participants would use at the measurement date in pricing the asset or liability. Consideration is given to the risk inherent in both the method of valuation and the valuation inputs. Primary inputs to this valuation technique include broker quotes and comparative trades.

Changes in observability of significant valuation inputs identified during these reviews may trigger reclassifications. Reclassifications are reported as transfers at the beginning of the period in which the change occurs.

**NOTE 3 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts and benefits will be payable strictly under the terms of the Plan.

**NOTE 4 - INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S TRUSTEE (UNAUDITED)**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8.

Accordingly, the trustee of the Plan, Banco Popular de Puerto Rico (the Trustee), has certified as to the completeness and accuracy of all investment related information reflected in the accompanying financial statements of as December 31, 2024 and 2023, and for the year ended December 31, 2024, and the related notes to the financial statements, and the Schedule H, Part IV, line 4i - Schedule of Assets (Held at end of year) as of December 31, 2024. The Trustee maintains all records, executes investment transactions, and holds all the assets of the Plan.

**NOTE 5 - TAX STATUS**

The Plan is subscribed under the Trustee’s prototype master plan (the Master Plan), which has been qualified under the appropriate sections of the Puerto Rico Internal Revenue Code (the Code). The Trustee obtained its latest determination letter dated May 22, 2012, in which the Commonwealth of Puerto Rico tax authorities stated that the Master Plan, as then designed, was in compliance with the applicable requirements of Section 1081.01 of the Code.

The Plan received a determination letter dated September 5, 2012 qualifying the Plan within the Master Plan as submitted to the Puerto Rico Treasury Department. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code, and therefore believes that the Plan is qualified and tax exempt.

**NOTE 6 - FAIR VALUE MEASUREMENTS**

The Plan’s investments are reported at fair value in the accompanying statements of net assets available for benefits. The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The Plan uses appropriate valuation techniques based on available inputs to measure the fair value of its investments.

The following table sets forth by level, within the fair value hierarchy, the Plan’ assets at fair value as of December 31, 2024 and 2023.

**NOTE 7 - SPONSOR'S CONTRIBUTIONS**

The Sponsor's contributions may be paid in lump-sum or installments, but the total amount should be paid to the Trustee not later than the earlier of, the time (including extensions thereof) prescribe by law for filing the Employer's Puerto Rico income tax return for its taxable year ending with or, within the plan year.

**NOTE 8 - RELATED PARTY TRANSACTIONS**

The Sponsor provides to the Plan certain accounting and administrative services for which no fees are charged.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**NOTE 10 - DISCRIMINATION TEST AND EXCESS CONTRIBUTIONS PAYABLE**

Participants who make excess contributions will have them refunded or reclassified as an after-tax contribution. If the sponsor decides to refund the excess contributions, it is recorded as a liability in the accompanying statements of net assets available for benefits and as a reduction of participant-directed contributions for the year. If the sponsor decides to reclassify the contribution after taxes, no adjustment is made to the net assets available for benefits, but the employees' W-2 forms must be amended.

During the year ended December 31, 2024, the Plan failed the discrimination test. The Sponsor elected to refund \$743 and reclassify \$853 of excess pre-tax contributions made by Highly Compensated Employees to after-tax. The 2024 non-compliance event was corrected in February 2025.

During the year ended December 31, 2023, the Plan failed the discrimination test. The Sponsor elected to refund \$2,957 and reclassify \$5,528 of excess pre-tax contributions made by Highly Compensated Employees to after-tax. The 2023 non-compliance event was corrected in February 2024.

**NOTE 11 - PARTIES-IN-INTEREST TRANSACTIONS**

Section 3 (14) defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Accordingly, the auditor, loans to participants and transactions with investment funds managed and held by the Trustee are considered party-in-interest transactions. Fees paid by the Sponsor to the trustee and the auditor were approximately \$29,000 and \$26,000 and \$13,300 and \$11,700, respectively, for the year ended December 31, 2024 and 2023.

**NOTE 12 - SUBSEQUENT EVENT AND DATE OF MANAGEMENT'S REVIEW**

As of March 31, 2025, total distributions paid to participants amounted to approximately \$35,000.

Management has evaluated subsequent events through September 22, 2025, which is the date the financial statements were available to be issued.
