Note 1 – Plan Description

The following description of the Watauga Orthopaedics, PLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Watauga Orthopaedics, PLC (the “Company”), excluding leased employees, residents of Puerto Rico, and part-time employees or PRN employees who have not obtained age 21 and completed at least 1,000 hours of service during a Plan year. Eligible employees can begin participating in the Plan immediately upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year participants may contribute pre-tax and Roth deferrals as defined in the Plan, up to the maximum allowable limit under *Internal Revenue Code (IRC)*. Participants may also contribute amounts representing distributions from other qualified plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. The Company provides a 100% safe harbor matching contribution equal to the first three percent of the eligible employee’s compensation and 50% of the next two percent. Additional discretionary contributions may be contributed by the Company each plan year. Participants are eligible to receive the Company’s discretionary contributions if they have completed one year of service with at least 1,000 hours and are employed on the last day of the Plan year, as defined. There was no discretionary contribution in 2024. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s contributions, an allocation of earnings, and charged with an allocation of administrative expenses. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their voluntary contributions and rollover contributions plus actual earnings thereon. Vesting in the Company’s matching and discretionary contributions and earnings thereon are 100% vested after three years of credited service.

Payment of Benefits

Upon termination of service, death, or disability, a participant may elect to receive either a lump-sum amount or installment payments equal to the value of the participant’s vested interest in his or her account. In service withdrawals are available to participants age 59½ and for hardship.

Notes from Participants

Participants may borrow from their account balance up to a maximum equal to or the lesser of \$50,000 or 50% of the participant's vested account balance. Only one loan may be outstanding to a borrower at any time. The term of repayment of a loan must not be less than one year nor greater than five years or a reasonable time for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at prime rate plus one. At December 31, 2024, interest rates on loans ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$32,557 and \$47,436, respectively. The forfeited accounts may be used to pay Plan administrative expenses or reduce employer contributions. During 2024, a total of \$62,891 was used to reduce employer contributions.

Administrative Costs

Plan fees and administrative expenses are paid by the Plan and Company on a discretionary basis.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from Participants

Notes from participants are reported at their unpaid principal balance plus any accrued but unpaid interest.

Benefit Payments

Benefits are recorded when paid.

Reclassification

Certain items in the prior year financial statements may have been reclassified to conform to current presentation.

Subsequent Events

Subsequent events have been evaluated through September 25, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 consists of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The Fidelity Stable Value II Fund is a collective investment trust fund owned at December 31, 2024 and 2023. This investment is composed primarily of investment contracts and security-backed contracts and is valued at the net asset value of units of the fund. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

Note 4 – Investment Contracts

The Plan has investments in the Fidelity Stable Value II Fund. The fund primarily invests in investment contracts and security-backed contracts issued by insurance companies and other financial institutions. These contracts are considered to be benefit-responsive and are required to be stated at fair value. The average yield for these funds was approximately 1.63% and 1.59% for 2024 and 2023, respectively.

The objective of the fund is to provide investors with the preservation of capital along with a competitive level of income over time. However, there is no assurance that this objective will be achieved.

Note 5 – Related Party Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan participants may choose to invest in funds issued and managed by the Plan Trustee. Investments in funds issued and managed by the Trustee are considered related party transactions. Fees paid to the trustee by the Plan for investment management and trust services amounted to \$68,023 for 2024.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7 – Tax Status

The company has adopted a non-standardized pre-approved profit-sharing plan sponsored by Fidelity Management Trust Company. The Internal Revenue Service has determined by an opinion letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the *IRC*. The Plan has been amended; however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
