Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of FMSbonds, Inc. Employees' 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of FMSbonds, Inc. Employees' 401(k) Profit Sharing Plan & Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3(b) to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Responsibilities of Management for the Financial Statements



NOTES TO FINANCIAL STATEMENTS

NOTE 1. DESCRIPTION OF THE PLAN

General

The following description of FMSbonds, Inc. (the "Company" or "Sponsor") Employees' 401(k) Profit Sharing Plan & Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan, which was formed on January 1, 1979, is a defined contribution plan covering all eligible employees. Employees are eligible to participate in the Plan following the completion of one hundred sixty-seven hours of service within two months of the date of their employment and are over age eighteen. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may elect to reduce their compensation by a specific percentage or dollar amount up to the maximum statutory amount allowed as an elected deferral. Effective January 1, 2024, Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may make discretionary matching contributions to the Plan up to 50% of the first \$2,000 of compensation that a participant contributes to the Plan. For the year ended December 31, 2024, the Company elected to contribute \$36,142. The Company may also make a discretionary profit-sharing contribution in an amount to be determined annually. For 2024, the Company elected to make a discretionary profit-sharing contribution of \$370,683. In order to be eligible for the matching contribution and discretionary profit-sharing contribution, participants must attain the age of 18 and complete twelve (12) months of service with a minimum of 1,000 hours of service. Each year following that, participants must work at least 1,000 hours of service and must be employed by the Company as of the last day of the Plan year. Participants who are not employed on the last day of the year are eligible to share in the allocations if the cause is due to death or termination of employment on or after normal retirement age.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Sponsor's matching contribution and allocations of Plan earnings, net of any administrative expenses directly chargeable to a participant's account. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1. DESCRIPTION OF THE PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, the Sponsor's matching contribution and allocations of Plan earnings, net of any administrative expenses directly chargeable to a participant's account. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Plan participants are 100% vested in the full value of their contributions plus actual earnings. Vesting in the Company's matching and profit-sharing contributions is based on years of continuous service. A participant is fully vested after six years of continuous service.

Forfeitures

Forfeitures are those amounts of the Employer's matching contributions in which a participant is not fully vested at the time of termination. These amounts are used to reduce future employer contributions or administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,956 and \$2,143, respectively. During the 2024 plan year, forfeitures of \$2,143 were used to reduce employer contributions.

Plan Administration

The Plan is administered by the Company and investments are maintained in a trust by the Company (the "Trustee") which has been appointed as Trustee by the Plan. The Trustee is responsible for the management and control of the Plan's assets. The Plan assets are maintained by its custodians, John Hancock Life Insurance Company U.S.A. ("John Hancock") and First Clearing, LLC ("First Clearing"). Sentinel Benefits & Financial Group ("Sentinel Benefits") serves as the record keeper for the Plan.

Investment Options

Upon enrollment in the Plan, a participant may direct the investment of their contributions in any of the various investment options, including self-directed brokerage accounts. Participants may change their investment options daily.

Notes Receivable from Participants

A participant may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of 50% of a participant's vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 1%, at the time of application. Principal and interest are paid ratably over a period up to 60 months, or up to 120 months if loans are to purchase a primary residence, through payroll deductions.

NOTE 1. DESCRIPTION OF THE PLAN (Continued)

Payment of Benefits

On any termination of service, whether due to death, disability, retirement, or other termination of employment, a participant is entitled to the value of the participant's vested interest in his or her account (the "Vested Balance"). If the participant's Vested Balance is less than or equal to \$5,000 at the date of termination of service, the participant receives either a single lump-sum payment or rollover into an IRA. If the participant's Vested Balance is greater than \$5,000 at the date of termination of service, the participant may elect to receive a distribution of the vested account balance in a single lump-sum payment in cash or in property, depending upon investment option.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their allocation of employer contributions.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value. The Plan's investments in pooled separate accounts are stated at the net asset value as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments less its liabilities. The guaranteed interest accounts are included on the financial statement at fair value which approximate contract value as reported to the plan by the custodian. Transfers and withdrawals from the guaranteed interest accounts are subject to certain restrictions and the administrative guidelines of John Hancock.

The self-directed brokerage accounts are recorded at the fair value of the individual investments held in the brokerage account. Equity securities are valued at quoted market prices of the individual securities. The fair value of municipal bonds is estimated using recently executed transactions, market price quotations and pricing models that factor in, where applicable, interest rates, bond or credit default swap spreads and volatility. Corporate bonds are valued using recently executed transactions, market price quotations (where observable), bond spreads or credit default swap spreads. When observable price quotations are not available, fair value is determined based on cash flow models with yield curves, bond, or single name credit default swap spreads and recovery rates based on collateral values as key inputs.

Security transactions are recorded on a trade date basis, which is the date the order to buy or sell is executed. Interest income is accrued on a daily basis. Dividend income is recorded on the ex-dividend date.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Benefit Payment

Benefit payments to participants are recorded when paid.

Plan Expenses

Certain administrative functions are performed by employees of the Sponsor. No such employees receive compensation from the Plan. Administrative expenses, such as professional fees, are paid directly by the Company. Fees related to distributions and loans are paid by the participant engaging in any such transaction and are recorded when incurred.

Party-In-Interest Transactions

Certain plan investments are units of pooled separate accounts and guaranteed interest accounts managed by John Hancock. In addition, the Plan has a cash account managed by John Hancock and, therefore, these transactions qualify as party-in-interest transactions. The Plan also has notes receivable from participants that qualify as party-in-interest transactions. John Hancock is a custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Risk and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Concentrations

Substantially all the Plan's assets are held by John Hancock, located in Buffalo, New York, and First Clearing, located in St. Louis, Missouri.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 3. INVESTMENTS

Information related to the investments held by the Plan as of December 31 is as follows:

- a) Investments in self-directed brokerage accounts aggregate \$45,889,650 and \$37,328,810 at December 31, 2024 and 2023, respectively.

During 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) held in self-directed brokerage accounts appreciated in value by \$6,347,982. In addition, for the year ended December 31, 2024, interest and dividends relating to the Plan's investments, as well as interest on notes receivable from participants held in self-directed brokerage accounts amounted to \$1,297,690 and \$22,133 respectively. Notes receivable from self-directed account participants aggregated \$253,747 and \$206,370 at December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, the interest rate on participant loans ranged between 4.25% - 9.50%.

- b) The following information about the Plan's pooled separate account investments, guaranteed interest accounts investments and notes receivable from participants included in the accompanying financial statements and supplemental information is unaudited and was obtained from data that has been prepared and certified to as complete and accurate by the Plan's custodian, John Hancock.

Investments in pooled separate accounts aggregate \$16,627,517 and \$13,606,767 at December 31, 2024 and 2023, respectively.

Investments in guaranteed interest accounts aggregate \$81,042 and \$100,885 at December 31, 2024 and 2023, respectively.

During 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) in pooled separate accounts and guaranteed interest accounts appreciated in value by \$2,656,849. In addition, for the year ended December 31, 2024, interest on notes receivable from participants held by John Hancock amounted to \$5,904. Notes receivable from participants held by John Hancock aggregated \$118,088 and \$80,547 at December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023 the interest rate on participant loans ranged between 4.25% - 9.50%, and 4.25% - 9.25%, respectively.

NOTE 4. FAIR VALUE MEASUREMENT

Fair value is measured by a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A description of the valuation methodologies the Plan uses for assets measured at fair value is included in Note 2. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methodologies may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. INCOME TAX STATUS

The Plan obtained its latest opinion letter on November 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although, the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

The Plan assesses its tax positions in accordance with “*Accounting for Uncertainties in Income Taxes*” as prescribed by the *Accounting Standards Codification*, which provides guidance for financial statement recognition and measurement of uncertain tax positions taken or expected to be taken in a tax return for open tax years (generally a period of three years from the later of each return’s due date or the date filed) that remain subject to examination by the Plan’s major tax jurisdictions.

The Plan assesses its tax positions and determines whether it has any material unrecognized liabilities for uncertain tax positions. The Plan records these liabilities to the extent it deems them more likely than not to be incurred. Interest and penalties related to uncertain tax positions, if any, would be classified as a component of income tax expense.

The Plan believes that it does not have any significant uncertain tax positions requiring recognition or measurement in the accompanying financial statements.

NOTE 6. SUBSEQUENT EVENTS

The Company has evaluated subsequent events through September 26, 2025, which is the date the accompanying financial statements were available to be issued.
