Opinion

We have audited the financial statements of the Corbion America Employee Welfare Trust Fund Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and statements of plan benefit obligations as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits and statements of changes in plan benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan and plan benefit obligations as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and its changes in plan benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS

(1) Description of plan

The following description of the Corbion America Employee Welfare Trust Fund Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions, which are available from the plan administrator.

General - The Plan provides health and other benefits sponsored by Corbion America Holdings, Inc. (the “Company”) for the benefit of full-time employees of the Company and its subsidiaries (Caravan Ingredients, Inc., Purac America, Inc., and Corbion Biotech, Inc.) who work a minimum of 40 hours per week.

Certain plan assets are held in a voluntary employees’ beneficiary association (“VEBA”) trust. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974, as amended (“ERISA”).

Plan changes - Effective April 1, 2024, the Company divested the emulsifier business which impacted participants located at the Grandview and Dolton locations and some Caravan administrative personnel. As of this date, the plan document was restated and Union employees at these locations are no longer eligible for benefits under the Plan.

Benefits - The Plan provides health benefits (medical, vision, dental, and prescription drugs), life insurance, long-term disability benefits, business travel accident benefits, an employee assistance program, accidental death and dismemberment benefits, health care and dependent care flexible spending accounts and legal services. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (“COBRA”).

Insured benefits - The Plan fully insures the dental benefits, vision benefits, life insurance benefits (basic, supplemental, and dependent), long-term disability benefits, business travel accident benefits, employee assistance program benefits, medical benefits abroad, group legal services, and accidental death and disability benefits (basic, supplemental, and spousal). The Company purchases annual insurance contracts for these insured benefits.

Stop loss coverage - The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). For the years ended December 31, 2024 and 2023, the stop loss coverage begins at \$225,000 per person per year. Any claim exceeding the stop loss dollar threshold is paid directly by Aetna Life Insurance Company (“Aetna”).

Refunds - Refunds due from the Plan’s pharmacy benefit manager are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$1,173,581 and \$1,028,622 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

(1) Description of plan (continued)

Self-insured benefits - All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only arrangements. The claims processors pay claims directly to or for participants and are then reimbursed by either the Plan's VEBA trust or the general assets of the Company. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Contributions - In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of supplemental and dependent life insurance, supplemental accidental death and dismemberment insurance, and legal service programs based on the current group rate premium cost. The Company pays the full cost of basic life insurance, basic accidental death and dismemberment insurance, and stop loss insurance. The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions.

(2) Summary of significant accounting policies

Basis of accounting - The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, claims incurred but not reported ("IBNR") and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions - Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Payment of benefits - Premiums paid by either the Company or the VEBA trust are recorded as premium payments in the accompanying statements of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims administrator. Amounts due to claims administrators that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of plan benefit obligations. Premiums not yet paid at year end are included as an amount currently payable in the accompanying statements of plan benefit obligations.

Stop loss - Premiums for stop loss insurance are included in premium payments in the accompanying statements of changes in net assets available for benefits. Claims totaling \$1,194,707 and \$1,500,849 were paid directly by Aetna on behalf of participants who exceeded the stop loss threshold for the years ended December 31, 2024 and 2023, respectively. Those claims paid are not included in the accompanying statements of changes in net assets available for benefits.

(2) Summary of significant accounting policies (continued)

Administrative expenses - The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses. All other administrative expenses are paid by the Company on behalf of the Plan.

(3) Claims incurred but not reported

Claims incurred but not reported Plan obligations at December 31 for claims incurred but not reported are estimated based on claims data provided by the Plan's third-party claims administrator. These amounts are paid by the Plan only if claims are submitted and approved for payment.

(4) Related party transactions and party-in-interest transactions

As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

(5) Plan termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

(6) Tax status

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service ("IRS") dated October 17, 2002, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code ("IRC"). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC, and therefore, believes the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
