**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Skirball Cultural Center Defined Contribution Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

**A. General**

The Plan is a defined contribution plan adopted by the Skirball Cultural Center ("Skirball") to provide benefits to eligible employees as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

**B. Administration and Expenses**

The plan administrator has responsibility for the administration of the Plan. Teachers Insurance and Annuity Association of America ("TIAA") and College Retirement Equities Fund ("CREF") (collectively, "TIAA-CREF") serves as the Plan custodian. TIAA-CREF and its affiliates also provide administrative and recordkeeping services.

Investment management fees and operating expenses are netted against investment income. Other costs of administering the Plan may be paid from the Plan or paid by Skirball at the discretion of the plan administrator.

**C. Eligibility**

Skirball employees are eligible to participate in the Plan and make elective deferrals starting on their date of hire. Eligible Skirball employees will be able to participate in the Plan for purposes of nonelective contributions once twelve months have passed from their date of hire.

**D. Contributions**

*Employer:*

Effective January 1, 2019, employer contribution rates are as follows:

Effective January 1, 2023, a matching contribution will be made equal to 100% of each participant's elective deferrals, but not as to elective deferrals exceeding 4% of the participant's compensation.

*Employee:*

Participants may defer up to 100% of pre-tax annual compensation, as defined in the Plan, subject to Internal Revenue Code limitations.

**E. Participant Accounts**

Each participant's account is credited with the participant's elective deferrals, rollovers, employer contributions and an allocation of Plan earnings. Earnings or losses are allocated to participants' accounts based on the proportion each account bears to the total of all account balances within each investment fund. Plan assets are invested among Plan investment options based on participant instructions.

**F. Vesting**

Participants are 100% vested in elective deferrals, employer contributions, rollover contributions, and earnings thereon.

**G. Forfeitures**

In the event that a forfeiture occurs as a result of the inclusion of an ineligible employee, such forfeiture shall be used to reduce future employer contributions, or to pay reasonable Plan fees and expenses. As of December 31, 2024, there were no forfeitures included in Plan assets.

**H. Payment of Benefits**

Upon termination of service, death, retirement or attainment of age 59½, a participant may elect to receive benefits equal to the value of the vested interest in his or her account. Participants may elect to receive benefits from among one of the payment options offered under the Plan. Hardship distributions are permitted under limited circumstances, as defined in the Plan. Benefits are recorded when paid.

**I. Participant Loans and Notes Receivable from Participants**

Loans were available to participants through TIAA-CREF. These loans are neither Plan assets nor Plan liabilities and loan defaults are treated as distributions from the Plan. A participant may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his or her vested account balance at a reasonable rate of interest. Loans are secured by a collateral account comprising a portion of the participant's Plan account held in the Insurance Company General Contract. The minimum loan repayment period is five years, or 15 years for a loan used to purchase the participant's primary residence. At December 31, 2024, participants had outstanding loan balances, net of deemed distributions totaling \$47,400, due to TIAA-CREF totaling \$2,262 with interest rates ranging from 4.00% to 5.73%.

Effective December 4, 2020, TIAA-CREF discontinued its collateralized loan program and the Plan transitioned to a new retirement plan loan program, which will fund loans directly from participants accounts. Loans issued prior to the implementation of the new loan program will remain in effect until they are paid off and will not be affected by the change. These loans followed the same terms as those detailed in the previous paragraph. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50%.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The Plan's financial statements are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

**C. Investment Valuation and Income Recognition**

GAAP establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are quoted prices in active market.

Level 2 – Inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Level 1 investments consist of mutual funds valued at quoted market prices. Level 3 investments consist of an insurance company general contract valued at the fair value determined using a market value formula factor that is determined by TIAA-CREF and is based on unobservable inputs. The CREF investments classified as mutual funds and the pooled separate account are valued at net asset value. Shares may be redeemed any time. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares of the CREF mutual funds or the pooled separate account. Purchases and sales of investments are recorded on the trade-date basis. Interest and dividends are recorded on the accrual basis.

**D. Risks and Uncertainties**

Plan investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

**NOTE 3 - INSURANCE COMPANY GENERAL CONTRACT**

The Plan maintains the Insurance Company General Contract (the "Contract"), a non-benefit and benefit responsive investment contract with TIAA-CREF. TIAA-CREF maintains the contributions to the Contract in a general account. When participants choose to allocate a portion of their retirement savings to the Contract during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rates schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA-CREF's claims paying ability. The Contract also provides the potential for additional interest if declared by TIAA-CREF's Board of Trustees. As of December 31, 2024, the crediting rate was 5.25%.

Loans issued to participants through TIAA-CREF are collateralized by a portion of the participant's Plan account held in the Contract. The collateralized portion of a participant's account will remain in the Contract until the outstanding loan is repaid.

**NOTE 4 - INCOME TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the Code. The terms of the Plan have been prepared to conform to the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the Code to maintain its tax-exempt status under Section 403(b). The plan administrator believes that the Plan is currently designed and operating in accordance with the applicable requirements of Section 403(b) of the Code and, therefore, believes that the Plan is qualified, and exempt from taxation. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

**NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIAN**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information provided to the plan administrator and certified as complete and accurate by TIAA-CREF, the custodian of the Plan.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, Skirball has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. Upon termination of the Plan, participants remain 100% vested in their accounts and Plan assets will be distributed based upon the participants' account balances at the time.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments may be issued by the custodian or an affiliate. Purchases and sales of these investments are considered party-in-interest transactions under ERISA regulations, but such transactions are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**NOTE 8 - PLAN TRANSFERS**

On November 5, 2024, the HUC Skirball Cultural Center Plan transferred assets totaling \$37,205 into the Plan.
