Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Clayton Foundation for Research Employees' 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Clayton Foundation for Research Employee's 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Clayton Foundation for Research Employees' 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Clayton Foundation for Research Employees' 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of Plan

General

The Clayton Foundation for Research Employees' 401(k) Plan (Plan) is a defined contribution plan covering the employees of Clayton Foundation for Research (Foundation).

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for more complete information. All employees of the Foundation are eligible to participate in the Plan commencing on the date on which the employee first completes one hour of service. After attainment of the retirement age of 65, employees, without retirement or severance of employment, have the right to elect to receive up to 100% of the balance in their retirement plan account. The Plan provides for retirement, disability and death benefits up to 100% of the account balance and is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions and allocation of earnings

The Plan is funded by Foundation contributions and employees who elect to contribute. Every year, participants may contribute up to 100% of pretax annual compensation subject to Internal Revenue Service limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Foundation is required to contribute to the Plan an amount equal to 3% of the employee's annual compensation excluding bonuses and subject to Internal Revenue Service limitations. Additionally, the Plan requires the Foundation to make an employer supplemental contribution of 12% of covered compensation. Contributions are allocated to the participant's account when received by the Plan trustee. Earnings are allocated daily to each participant's account based on the shares held in each account.

Investment Options

The Plan administrator provides participants a selection from a wide range of up to thirty mutual funds, a collective investment trust, and an insurance company general fixed asset account in which to invest their portion of the Foundation's contributions to the Plan, their elected contributions, their account balance, and the earnings thereon.

Benefits

The Plan provides full vesting to all eligible employees. Accordingly, there are no nonvested forfeitures of account balances.

Generally, participants who retire or terminate their service with the Foundation are given the option, with spousal consent, of receiving a lump sum settlement. Otherwise, the Plan will purchase the participant a joint and survivor annuity contract.

Plan Termination

The Foundation intends to continue the Plan indefinitely but reserves the right to terminate it at any time. Upon termination of the Plan, or upon complete discontinuance of contributions, the net assets of the Plan would be allocated among the participants and beneficiaries of the Plan.

(2) Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Mutual funds and the collective investment trust held in participant's accounts are valued daily at the net asset value as reported to the National Association of Securities Dealers. The current value approach is used in determining realized and unrealized investments, gains and losses, a calculation based on revalued costs.

Payment of Benefits

Benefits are recorded when paid. During the year ended December 31, 2024, participants requesting withdrawal of funds from their accounts received such funds in 2024.

(3) Organization of the Plan

The Plan Administrator is Clayton Foundation for Research. Voya Retirement Insurance and Annuity Company (VRIAC) is a contract plan administrator and Voya Institutional Trust Company has custody of the Plan assets. Substantially all Voya Plan administrative expenses are allocated to and paid by Plan participants. Any administrative expenses not paid by Voya are paid by the Foundation.

(4) Fully Benefit-Responsive Guaranteed Investment Contract

The Plan has entered a fully benefit-responsive guaranteed investment contract (Voya Fixed Account), a traditional investment contract, with VRIAC. VRIAC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by VRIAC, represents contributions made under the contract, plus earnings, less participant withdrawals. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Voya Fixed Account provides stability of principal and credits interest daily on all amounts allocated to this option. Rates of interest are subject to a minimum of 1% and a maximum of 3%. Amounts allocated to the Voya Fixed Account are held in VRIAC's general account which supports insurance and annuity obligations. VRIAC's general account is managed on an aggregate basis and supports all of the financial commitments. No portion of the general account is attributable to a particular plan nor do plans have any undivided ownership interest in general account assets. Withdrawals from the Voya Fixed Account for other than payment of benefits to participants are subject to market value adjustments and surrender charge. The interest rate guarantees under the contract are subject to VRIAC claims-paying ability. The VRIA's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

(4) Fully Benefit-Responsive Guaranteed Investment Contract (continued)

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (4) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include, (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

(5) Plan Loans

The Foundation Plan does not provide for participant loans.

(6) Tax Status

The Plan obtained the last required determination letter dated April 11, 2014, in which the Internal Revenue Service stated that the Plan was following the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan has no uncertain tax positions and the last four years are subject to audit.

(7) Data Certified by Trustee

Data included in the financial statements and schedules was based on information supplied by the trustee. The value of investments held by VRIAC at December 31, 2024 and 2023 was \$19,490,363 and \$17,746,542, respectively. The net investment earnings for 2024 and 2023 was \$2,406,220 and \$2,701,459, respectively. The amounts distributed from the Plan including benefits paid and participant fees for 2024 and 2023 was \$1,207,906 and \$946,089, respectively.

(8) Party-In-Interest Transaction

During 2024 and 2023, certain mutual funds were under a VRIAC Group Annuity contract, and as such, transactions in these funds qualify as party-in-interest transactions, as well as transactions in the Voya Fixed Account.

(9) Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

(10) Fair Value Measurements

Fair value measurements, as defined in professional standards, establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs are inputs other than quoted prices included in Level 1 that are observable for the asset, either directly or indirectly, and Level 3 inputs are unobservable. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The Plan measures fair value of mutual funds and collective investment trust using Level 1 inputs. There are no Level 2 or 3 inputs.

(11) Risks and Uncertainties

The Plan invests in various securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported.

(12) Subsequent Events

Subsequent events were evaluated through the date of the independent auditors' report, the date that the financial statements were available to be issued.
