Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Zoho Corporation 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Zoho Corporation 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established in 2003 by Zoho Corporation (the “Company” or “Employer”) to provide benefits to eligible employees as defined in the Plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (“IRC”), as amended, and the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Administration

The Company has appointed a Plan Administrator to manage the operation and administration of the Plan. The Company has contracted with Fidelity Management Trust Company to act as the trustee and Fidelity Recordkeeping Services as a third-party administrator to process and maintain the records of participant data.

Eligibility

Employees of the Company who are over the age of 21 are eligible to participate in the Plan immediately upon hire.

Participant Contributions

Each year, participants may contribute a specified dollar amount or percentage of their eligible compensation, not to exceed the effective deferral limits imposed by the Internal Revenue Service (IRS). Participants may elect to have the Company contribute up to 100% of their eligible pre-tax compensation and/or Roth contributions to the Plan up to the amount allowable under the Plan document and current income tax regulations. Participants who have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Participants who have attained the age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions withheld are invested in accordance with the participant’s direction. Effective June 1, 2023, The Plan was amended to add an automatic enrollment contribution provision. Newly eligible employees will be automatically enrolled into the Plan 30 days after the date of hire with an initial pre-tax deferral contribution of 3% of compensation unless the employees elect differently.

Participants can make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant’s direction and the Plan’s provisions.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Employer Contributions

The Company provides a safe harbor matching Employer contribution to each eligible participant equal to 100% of the first 3% of participant contributions and then 50% of the next 2% of participant contributions up to \$13,800. The match is deposited every pay period. However, at the end of the Plan year, the Company will adjust the safe harbor matching contributions based on each participant's contributions and compensation for the entire Plan year. For the year ended December 31, 2024 and 2023, the Company recorded a true-up contribution for the safe harbor matching of \$24,259 and \$56,366, respectively, which is included in the Employer contribution receivable at December 31, 2024. The matching contributions are invested in the same manner that the participant directs his or her investments. The Company may also make discretionary matching and non-elective Employer contributions to eligible employees. In 2024, the Company did not make discretionary matching and non-elective Employer contributions.

Vesting

Participants are vested immediately in rollover contributions, deferral contributions, safe harbor matching Employer contributions plus actual earnings thereon. Any Employer discretionary matching and nonelective contributions and earnings vest in accordance with the following schedule:

3 but less than 4 years	40%

Forfeitures

Forfeited non-vested accounts may be utilized to pay Plan expenses and/or used to reduce Employer matching contributions under the Plan or used to restore previously forfeited accounts. Forfeitures shall be used in accordance with the terms of the Plan no later than the end of the Plan year following the Plan year in which the forfeiture occurs. During the year ended December 31, 2024, no forfeitures were used for Employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,406 and \$3,193, respectively.

Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, rollovers from qualified plans of the participant's previous employers, employer contributions and allocations of the Plan's earnings and administrative expenses.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Investment Options

Participants must direct their salary deferral contributions and Employer contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options any time throughout the year via the Internet website or by using the automated telephone system offered by the trustee.

Payment of Benefits

Upon termination, death, retirement or disability, the participants or beneficiaries may elect to leave their account balance in the Plan or receive their total benefits in a lump-sum amount equal to the value of the participant's interest in their account. The Plan allows for the automatic cash-out distribution of participant account balances under \$1,000. The plan allows automatic rollover of participant account balances between \$1,000 and \$5,000 into an Individual Retirement Account.

Financial Hardship Distributions

The Plan allows hardship withdrawals in accordance with Internal Revenue Service ("IRS") regulations. Among other things, the withdrawal must be necessary in light of immediate and heavy financial needs of the participant and is limited to certain purposes.

Notes Receivable from Participants

The Plan allows participants to borrow up to the lesser of \$50,000 or 50% of their account balance. The minimum loan amount that a participant may request is \$1,000. Participants may have one outstanding loan as long as the loan repayments are submitted through payroll deduction. The notes are secured by the participant's balance. Such notes bear a reasonable rate of interest as determined by the Plan Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The interest rate shall remain fixed throughout the duration of the loan. The notes receivables from participants must be repaid to the Plan within a five-year period, unless the note is used for the purchase of a principal residence, in which case the maximum repayment period may be longer. The specific terms and conditions of such notes are established by the Company. Outstanding notes receivable from participants at December 31, 2024 and 2023, carry interest rates ranging from 4.25% to 9.5%, and mature through 2032.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates

The preparation of financial statements in conformity with the U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan’s gains and losses on investments bought or sold as well as held during the year. Management fees charged to the Plan for investments in registered investment companies are based on assets invested and are deducted on a daily basis. Management fees are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document. There were no delinquent notes receivable from participants as of December 31, 2024 and 2023. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Benefit Payments

Benefit payments are recorded when paid.

Plan Expenses

The Company currently pays for most of the Plan’s expenses and these expenses have been excluded from the Financial Statements. Plan expenses not paid by the Company, will be charged on a pro-rata basis to the value of the participants’ account balances.

Risks and Uncertainties

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants’ account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Income Taxes

The Plan has adopted a non-standardized pre-approved plan. The pre-approved plan has received an opinion letter from the Internal Revenue Service (“IRS”) as to the pre-approved plan’s qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC. Therefore, no provisions for income taxes have been recorded in the Plan’s financial statements.

NOTE 3 – FAIR VALUE MEASUREMENT

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted, quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets,
- Quoted prices for identical or similar assets or liabilities in inactive markets,
- Inputs other than quoted prices that are observable for the asset or liability and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 3 – FAIR VALUE MEASUREMENT (Continued)

Following are descriptions of valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Self-directed brokerage accounts

Valued at the daily closing price as reported on the active market on which the individual securities are traded.

Registered investment companies (mutual funds)

Valued at the daily closing price as reported by the fund. Mutual funds invested in by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collect trust

Units held in common collect trust (“CCT”) are valued using the net asset value practical expedient (NAV practical expedient) of the CCT as reported by the CCT managers. The NAV practical expedient is based on fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The NAV of a CCT is calculated based on a compilation of primarily observable market information. The CCT has daily redemption frequency, daily redemption period, no restrictions and has no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments, notes receivable from participants and interest income from participants are managed by an affiliate of Fidelity Management Trust Company, the trustee of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 5 – CERTIFIED INFORMATION

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the United States Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified the completeness and accuracy of:

- Investments and notes receivable from participants reflected in the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, dividend and interest income and interest income on notes receivable from participants reflected in the accompanying statement of changes in net assets available for plan benefits for the year ended December 31, 2024;
- Assets reflected in the supplemental schedule, Schedule H, line 4i, Schedule of Assets (Held at End of Year) as of December 31, 2024.

NOTE 6 – UNCERTAIN TAX POSITIONS

U.S. GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS or the DOL. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in question.

NOTE 7 – PLAN TERMINATION OR MODIFICATION

The Company intends to continue the Plan indefinitely for the benefit of its participants; however, it reserves the right to terminate or modify the Plan at any time by resolution of its Board of Directors and is subject to the provisions of ERISA. Upon termination of the Plan, further contributions to the Plan shall cease and all participants who are affected by such termination shall become 100% vested. Net assets available for benefits would be distributed to the participants based on each participant’s interest in the Plan.

NOTE 8 – NON-EXEMPT TRANSACTIONS

During 2023, the Plan sponsor failed to deposit \$66,299 of participants' contributions and loan repayments within the required timeframe as defined by the United States Department of Labor's regulations. The delay in remitting the contributions and loan repayments to the custodian was due to an administrative error. The Company deposited the contributions and the loan repayments to the custodian in 2023. The Company deposited the lost earnings on the participants' contributions into the affected participants' accounts in 2024 to correct the error.

During 2024, the Plan sponsor failed to deposit \$226,504 of participants' contributions and loan repayments within the required timeframe as defined by the United States Department of Labor's regulations. The delay in remitting the contribution and loan repayments to the custodian was due to an administrative error. The Company has deposited the contributions and loan repayments with the custodian in 2024. The Company will deposit the lost earnings of the participants' contributions and loan repayments into the affected participants' accounts in 2025 to fully correct the error.
