Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

The information included in the supplementary information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Plan Description

---

The following description of the Nelnet 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering employees of Nelnet, Inc. (the Company) and its wholly-owned subsidiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. General administration of the Plan is the responsibility of the Retirement Advisory Committee of the Company.

Employees are eligible to make pre-tax and Roth after-tax salary deferral contributions and receive safe harbor matching contributions and discretionary non-elective contributions after six months of service. Eligible employees become participants on the first day of the month following the date on which the entry requirements are fulfilled.

In August 2023, the Plan completed the mergers of the GRNE Solutions, LLC 401(k) Plan (GRNE Plan) and the NGWeb Solutions, LLC 401(k) Plan (NGWeb Plan). As a result, certain participants and plan assets of \$3,109,018 were transferred from the NGWeb Plan and \$696,442 were transferred from the GRNE Plan into the Plan. Assets transferred into the Plan totaled \$3,805,460 for the year ended December 31, 2023.

In January 2025, certain participants and plan assets of approximately \$42,263,000 were transferred to the ALLO 401(k) Plan as a result of a spin-off from the Company.

#### *Contributions*

Each year, participants may make voluntary pre-tax and Roth after-tax salary deferral contributions up to 100% of their eligible compensation, up to the maximum amount allowed by law. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions. All employees are automatically enrolled with a 5% deferral contribution once they become eligible for the Plan. At any time, a participant may elect not to contribute or may increase or decrease his or her deferral rate. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Company makes safe harbor matching contributions of 100% of the first 3% of eligible compensation and 50% of the next 3% to 5% of eligible compensation that a participant contributes to the Plan. The Company may also make discretionary non-elective contributions. Contributions are subject to certain limitations.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's safe harbor matching contributions, (b) the Company's discretionary non-elective employer contributions and (c) Plan earnings and losses. The Company's safe harbor matching contributions are allocated among participants based upon each participant's elected salary deferral. The Company's discretionary non-elective contributions are allocated among participants based upon each participant's eligible compensation. Plan earnings and losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by Union Bank & Trust Company (UBT).

### ***Vesting***

Participants are immediately 100% vested in all salary deferral contributions, safe harbor matching contributions, and discretionary non-elective contributions.

### ***Notes Receivable from Participants***

Notes receivable from participants are not permitted under the Plan. The existing notes receivable from participants were transferred into the Plan during 2023 (see "General" section in Note 1) and are secured by the balance in the participant's account and bears an interest rate which is commensurate with local prevailing rates. Principal and interest payments are repaid through payroll deductions.

### ***Payment of Benefits***

Upon termination, retirement, disability, or death, the participant or beneficiary may elect to receive a lump-sum or installment payments equal to the value of the vested funds allocated to the participant's account. Upon attainment of age 59 1/2, a participant may withdraw all or a portion of the contributions made to the Plan in which they are 100% vested. The Plan requires mandatory distribution payments between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024) be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. The Plan also allows for hardship distributions. Benefits are recorded when paid.

## **2. Summary of Significant Accounting Policies**

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

### ***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America.

### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### ***Other***

Administrative, investment management and record-keeping expenses are paid by the Plan and are included in administrative expenses. Other expenses specifically incurred or attributable to individual participants are paid from the applicable participants' accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### ***Reclassifications***

Certain reclassifications have been made to the 2023 financial statements to conform to the 2024 presentation.

### *Subsequent Events*

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through September 17, 2025. See "General" section in Note 1 for a description of a subsequent event.

### 3. Information Certified by UBT

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by UBT, except for comparing such information certified by the custodian and trustee to information included in the Plan's financial statements and supplementary information.

### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds and Money Market Fund:* Valued at the daily closing price as reported by the funds. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Common Collective Trusts:* Valued at NAV based on the fair value of its underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV per unit to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that these funds meet those requirements. Participants can redeem the trusts at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023.

*Annuities:* Valued at the cash surrender value provided by UBT, which approximates fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Related Party Transactions

---

The Plan's cash is held and managed by UBT, the custodian and trustee of the Plan. Fees paid by the Plan to UBT for plan and investment management services amounted to \$736,190 and \$876,531 for the years ended December 31, 2024 and 2023. As such, UBT qualifies as a party-in-interest to the Plan. UBT is an entity under common control with the Company. Michael S. Dunlap, a substantial shareholder and executive chairman of the Company, is on the board of directors of UBT. Angela L. Muhleisen, a substantial shareholder of the Company, is the president, chief executive officer, and chairperson of the board of directors of UBT, and is Mr. Dunlap's sister.

### 6. Tax Status

---

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 7. Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, distribution to the participants of the account balances would be made as soon as practicable after the termination date.
