Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of KTA Super Stores 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974, as amended (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

NOTES TO THE FINANCIAL STATEMENTS

For the Years Ended December 31, 2024 and 2023

NOTE A – DESCRIPTION OF PLAN

The KTA Super Stores 401(k) Profit Sharing Plan (Plan) was established in 1991 by Puna Plantation Hawaii, Limited, which does business as KTA Super Stores (Company), to enable its employees to share in the growth and profitability of the Company and to enable eligible employees to save for retirement. The following is a description of the plan that provides only general information. The Plan was amended and restated effective January 1, 2023. Participants should refer to the plan agreement for a complete description of the Plan's provisions.

General

The Plan is a profit sharing and salary deferral plan, also known as a 401(k) plan, covering all eligible employees of the Company (excluding employees governed by a collective bargaining agreement, nonresident aliens, leased employees, and independent contractors) who have one year of qualifying service and have attained the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan was amended to adopt certain interim provisions relating to the SECURE Act of 2019 and the CARES Act, and for certain interim provisions relating to the Secure 2.0 Act of 2022.

Contributions

Participants may make employee salary deferral contributions to the Plan up to the lesser of 100% of their eligible compensation or \$23,000 and \$22,500 in 2024 and 2023, respectively, adjusted annually for the cost of living, plus an additional \$7,500 in 2024 and 2023 for employees age 50 and over. The Company may also elect on a year-to-year basis to match in whole or in part each employee's salary deferral contribution as determined by the Board of Directors. The Company, at the discretion of its Board of Directors, may also make a discretionary contribution. There were no Company contributions for the years ended December 31, 2024 and 2023. Total contributions to each participant's account may not exceed the lesser of \$69,000 (\$76,500 with the catch-up contribution) in 2024 and \$66,000 (\$73,500 with the catch-up contribution) in 2023, or 100% of annual compensation, as defined. Excess contributions are refunded in accordance with provisions of the Internal Revenue Code (IRC).

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions; plus, an allocation based on participant earnings or account balances of the Company's discretionary contribution, the forfeitures of terminated participants' nonvested benefits, and the Plan's net earnings; less an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants become fully vested in the employer matching and discretionary employer contributions upon normal retirement (age 65) or death.

Participants that were in the Plan on December 31, 2012, and perform at least one hour of service on or after January 1, 2013, are 20% vested in employer discretionary contributions after two years of continuous service and 100% vested after three years of service. Participants are 20% vested in employer matching contributions after two years of service and vest an additional 20% per year, obtaining a fully vested interest after six years of continuous service. Participant voluntary contributions and the earnings thereon are always 100% vested.

Payment of Benefits

The vested amount in each participant's account is payable upon normal retirement, death, permanent disability, or termination of employment. Participants may receive the entire value of their accounts in a single lump-sum payment or in periodic payments over their life expectancy. Account balances of \$1,000 or less at the time of separation of the participant may be automatically disbursed to the participant. Account balances of \$7,000 or less at the time of separation will be paid as a lump sum unless an election is made to roll over the balance to an individual retirement account or another qualified plan.

Withdrawals

Active participants may withdraw all or a portion of their account balances as hardship withdrawals, by submitting a written application that is approved by the plan administrator. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Services (IRS).

Forfeitures

Termination of employment for reasons other than retirement, disability, or death results in a forfeiture of the nonvested portion of the participant's account balance. Forfeitures may be applied to administrative expenses of the Plan, used to reduce employer matching contributions, and/or re-allocated among the participants. Forfeitures amounted to \$556 at December 31, 2024 and 2023. There were no forfeitures applied to administrative expenses of the Plan and/or re-allocated among the participants during the years ended December 31, 2024 and 2023.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

U.S. GAAP requires the plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates, it is reasonably possible that such estimates may change within the near term, and such differences could be material to the financial statements.

Investment Valuation and Income Recognition

Investments are stated at fair value, except that investments in guaranteed interest accounts are stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by investment advisors and the Plan's insurance company. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Contributions receivable are recognized for amounts due from the employee or employer remitted to the Plan after year-end. Contributions receivable from the employee are recorded in the year in which participant compensation is earned.

Management has evaluated the collectability of employee and employer contributions receivable in accordance with Accounting Standards Update No. 2016-13, *Financial Instruments – Credit Losses (Topic 326)*, and determined that no allowance for credit losses is necessary as of December 31, 2024 and 2023. The Plan considers the Company's historical payment experience, current and future financial condition, and the legally binding nature of the contribution obligation in making this assessment.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Expenses are recognized when the related liability is incurred. The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Investment related expenses are included in net appreciation of fair value of investments. Expenses that are paid by the Company are excluded from these financial statements.

NOTE C – CERTIFICATION FROM QUALIFIED INSTITUTION

Certain information related to investments, excluding noninterest-bearing cash, disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) (John Hancock), the qualified institution of the Plan. The contract value of the guaranteed interest account was also certified by the qualified institution.

NOTE D – FAIR VALUE MEASUREMENTS

U.S. GAAP provides a hierarchy that prioritizes the inputs to the valuation methodologies used to measure fair value. There are three levels of the fair value hierarchy. Level 1 inputs consist of unadjusted quoted prices for identical assets or liabilities in active markets that the entity has the ability to access. Level 2 inputs include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. Level 3 inputs are unobservable and significant to the fair value measurement. The fair value measurement level of an asset or liability within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation methodologies used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

At December 31, 2024 and 2023, total investments at fair value, consisting solely of investments in pooled separate accounts, amounted to \$35,405,136 and \$32,777,963, respectively. Investments in pooled separate accounts area valued at the net asset value (NAV) of unit shares held by the Plan at year-end. The NAV, as provided by John Hancock, is used as a practical expedient, which is based on the underlying assets of the pooled separate accounts, including registered investment companies. There were no investments requiring the use of Level 1, Level 2, or Level 3 inputs at December 31, 2024 and 2023. Furthermore, while the Plan believes its valuation methodology is appropriate and consistent with the other market participants, the use of a different methodology or assumptions to determine the fair value of investments could result in a different fair measurement at the reporting date. The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

NOTE E – GUARANTEED INTEREST ACCOUNTS

The John Hancock guaranteed interest accounts are not an investment contract but are an investment option offered under the John Hancock group annuity contract and are held in the John Hancock general accounts. There is no contract rate and no minimum or “floor” rate under these guaranteed interest accounts and John Hancock does not calculate or provide an average yield. Transfers from guaranteed interest accounts may be subject to a market adjustment, a redemption fee, and a contract termination charge. At December 31, 2024 and 2023, the guaranteed interest accounts amounted to \$381 and \$378, respectively.

The guaranteed interest accounts are nontradable obligations of John Hancock. Thus, the investment contracts or proceeds cannot be assigned or sold to another party without the consent of John Hancock. The repayment of principal and interest credited to participants holding the investment is a financial obligation of John Hancock. The terms of the accounts require all permitted participant-initiated transactions involving the investment to occur at contract value with no conditions, limits or restrictions. Permitted participant-initiated transactions are those allowed by the underlying Plan such as withdrawals for benefits, loans, or transfers to other investment choices within the Plan.

The Plan’s ability to receive amounts due in accordance with the fully-benefit responsive investment contract is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer. Such events include amendments to the plan documents including complete or partial plan termination or merger with another plan, bankruptcy of the plan sponsor or other plan sponsor events such as divestiture of a subsidiary that cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include an uncured violation of the Plan’s investment guidelines, a breach of material obligation under the contract, a material misrepresentation, and a material amendment to the agreement without the consent of the issuer.

NOTE F – TAX STATUS

In a letter dated January 5, 2011, the IRS granted a “favorable determination” because the Plan met the qualification requirements established by Section 401(a) of the IRC. The Plan has been restated and amended since the determination letter. However, the plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable provisions of the IRC. Therefore, the plan administrator believes the Plan was qualified and the related trust was tax exempt as of and for the years ended December 31, 2024 and 2023.

NOTE F – TAX STATUS (Continued)

U.S. GAAP requires uncertain tax positions to be recognized in the financial statements if they are more likely than not to fail upon regulatory examination. The plan administrator evaluated the Plan's tax positions as of December 31, 2024 and 2023 and for the years then ended, and determined that the Plan had no uncertain tax position to be reported in accordance with U.S. GAAP. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any open tax periods.

NOTE G – RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The Plan's investments are managed by John Hancock Asset Management, a sister company to John Hancock; therefore, these transactions qualify as party in interest transactions.

NOTE H – ADMINISTRATION OF PLAN ASSETS

Certain administrative functions are performed by officers or employees of the Company, who receive no compensation from the Plan. Other administrative expenses are paid either by the Plan or by the Company, as provided in the Plan document.

NOTE I – TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their accounts.

NOTE J – RISK AND UNCERTAINTIES

The Plan invests in various investment securities, including investments in shares of registered investment companies and guaranteed interest accounts. In general, investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the financial statements.

The Plan and Company operate in the State of Hawaii. Local, national, and international events can have severe, adverse effects on economic conditions in Hawaii. These financial statements do not include the adjustments that would result if the Plan were to account for future losses or asset impairments, as the effects on the financial statements of the Plan from such changes in economic conditions are not presently determinable.
