We have performed audits of the financial statements of 2H Offshore, Inc. 401(k) Profit Sharing Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Note 1 – Plan Description

The following description of the 2H Offshore, Inc. 401(k) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) profit-sharing plan that provides retirement savings benefits to all eligible employees of the 2H Offshore, Inc. (the “Company” or “Employer”). The Plan commenced effective December 1, 2000, and was amended and restated effective January 1, 2022, to comply with the latest rules and regulations. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

Plan Custodian and Trustee

Voya Retirement Insurance and Annuity Company (“Voya,” “VRIAC,” or the “Custodian”) is the Plan Custodian. The Custodian maintains custody of all investments held by the Plan, maintains the Plan’s participant account balances, and provides recordkeeping services to the Plan. Among other duties, the Custodian receives contributions, holds and invests the fund assets in accordance with the directions of participants, and makes distributions as directed by the Plan Administrator. An officer of the Company serves as trustee of the Plan.

Eligibility and Plan Entrance Date

Union employees, nonresident aliens, and leased employees are not eligible to participate in the Plan. All other employees of the Company aged 21 or older become eligible to participate in the Plan upon hire.

Contributions

Participants may elect to contribute, on a pre-tax and Roth basis, up to 100% of their annual compensation as defined by the Plan, subject to the annual deferral limit established by the IRC, which was \$23,000 for 2024. Participants who are at least 50 years of age before the end of the Plan year are eligible to make catch-up contributions up to the maximum amount allowed annually, which was \$7,500 for 2024. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

Employer matching contributions are discretionary as determined by the Employer’s management. During 2024, the Employer matched 100% of the first 6% of each participant’s eligible compensation contributed to the Plan as employee contributions. In addition, the Employer may make discretionary profit-sharing contributions, as determined by the Employer. Participants may share in any such discretionary profit-sharing contributions if the participant is employed on the last day of the Plan year and has completed 1,000 hours of service during the Plan year. No such profit-sharing contributions were made to the Plan in 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Employer’s contributions, allocations of Plan earnings, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Note 1 – Plan Description (continued)

Participant-Directed Investments

All assets of the Plan are participant-directed investments. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. Participants may direct their account balances to one or more of these investment options, which vary in types of investments, rates of return, and investment risk.

Vesting

Participants are vested immediately in their own contributions plus actual earnings thereon. Employer contributions are 0% vested until the participant completes two years of credited service, whereupon such contributions become 100% vested.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1% above Prime, as defined. Principal and interest are paid ratably through payroll deductions not less frequently than quarterly.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant receives a lump sum amount equal to the value of the participant's vested interest in his or her account. Distributions to a terminated employee with a vested account balance equal to or less than \$5,000 are made as a lump sum distribution as soon as administratively possible following the participant's termination of employment. The participant may elect whether to receive the distribution directly or rollover the distribution into another retirement plan. If the vested account balance is less than or equal to \$5,000, the Plan permits involuntary lump sum cash distributions. A participant may withdraw all or a portion of their vested account balance in the event of a financial hardship, as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age 59 ½.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$88, respectively. During the year ended December 31, 2024, forfeitures of \$88 were used to pay Plan expenses.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Note 2 – Summary of Significant Accounting Policies (continued)

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as those held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Agreement.

Payment of Benefits

Benefits payments are recorded when paid.

Administrative Expenses

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Pooled Separate Accounts** – Valued using the net asset value (“NAV”) of units held by the Plan at year-end as provided by the Custodian. The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee, and is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the pooled separate account, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations are carried out in an orderly business manner. Participant transactions (purchases and sales) may occur daily, and there are no significant restrictions on participant redemptions or any unfunded commitments.

Note 5 – Guaranteed Investment Contract with Insurance Company

The Plan maintains a traditional, fully benefit-responsive guaranteed investment contract-related investment option, the Voya Fixed Accounts (the “Fixed Accounts”), issued by VRIAC. The contract issuer is contractually obligated to repay principal and interest at a specified interest rate guaranteed to the Plan. The Fixed Accounts minimum guaranteed interest rate, which is guaranteed for the lifetime of the contract, is 1.0 - 3.0%. The contract cannot be terminated before the scheduled maturity date.

The contract underlying this investment option meets the fully benefit-responsive investment contract criteria; as such, the investment contract is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdraws and administrative expenses. The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contract is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include: (a) the Company providing effective communication to the Custodian that the agreement will be fully or partially terminated as of a date selected by the Company, which will be no earlier than thirty days after the Company provides effective communication to the Custodian; (b) failure of the Plan to meet the requirements of any applicable Code provision; (c) termination or partial termination of the Plan; (d) breach of a provision of the agreement by the Company; (e) the Custodian providing effective communication to the Company that the agreement will be terminated as of a date at least ninety days after the Custodian provides effective communication to the Company. The Plan Administrator does not believe any events which would limit the Plan’s ability to transact with the contract issuers that would also limit the ability of the Plan to transact at contract value with the participants are probable of occurring.

Note 6 – Related Party and Party-in-Interest Transactions

Certain Plan investments are units of pooled separate accounts. These and the fully benefit-responsive investment contract are both managed by Voya, the Plan Custodian; as such, these transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

The Plan has notes receivable from participants at December 31, 2024 and 2023. These receivables and all related transactions qualify as party-in-interest transactions and are exempt from being prohibited transactions under ERISA.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

Note 8 – Tax Status

The Plan operates under an adoption agreement in connection with a non-standardized, preapproved profit-sharing plan and custodial document sponsored by The Allocation Company. The Internal Revenue Service (“IRS”) has determined and informed The Allocation Company, by a letter dated October 20, 2021, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has not filed individually with the IRS for a letter regarding the Plan’s qualified tax status, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and thus believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 – Subsequent Events

The Plan has evaluated subsequent events through September 14, 2025, the date the financial statements were available to be issued.
