### 1. Description of Plan

The following brief description of The Will Group Profit Sharing Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** – The Plan is a Section 401(k) defined contribution plan with salary deferral provisions which was established on July 1, 2003. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Under the Plan, other than union employees and non-resident aliens, all employees of The Will Group, Inc. (Company) who are at least 21 years old and have one month of service are eligible to defer to the Plan starting on the first day of each month after those requirements are met.

The Plan's participating employers include:

- Lyons View Manufacturer & Supply, Inc.
- Electrical Resource Management, Inc.
- Rib Mountain Aggregate, Inc.
- Sustainable Energy Solutions, LLC
- Murray Food Services, Inc.
- Lighting Solutions of Illinois, Inc.
- Industrial Electric Supply, Inc.
- TWiG Technologies, LLC
- Volunteer Supply Industries, LTD.

**Contributions** – Pre-tax or post-tax deferred savings contributions in the form of salary reductions by participants are allowed. The amount contributed is determined by the participant, subject to statutory limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1, 2023, the Plan added an automatic deferral arrangement, whereby eligible participants hired on or after January 1, 2023, will have 3% of their compensation deferred each pay period unless the participant makes a contrary election.

The Company may make a discretionary nonelective contribution to the Plan. An employee must be at least age 21 and have one year of service to be eligible for this contribution starting on the first day of the first month and seventh month of the Plan year after those requirements are met. In addition, an eligible participant must be working as of the last day of the Plan year, unless termination occurs due to death or disability. The Company agreed to contribute 3.50% of all eligible participants' compensation as a nonelective contribution for the year ended December 31, 2024.

1. **Description of Plan** (cont'd)

**Participants' Accounts** – Each participant's account is credited with the participant's contributions and Company discretionary nonelective contributions, and gains and losses from the investment funds elected. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – A participant is fully vested in their elective deferrals and rollovers, plus actual earnings, gains and losses thereon, at all times. Discretionary nonelective contributions vest in accordance with the following schedule:

Years of Vesting Service	Vested Percentage
Less than 2 years	0%
At least 2 years but less than 3 years	20%
At least 3 years but less than 4 years	40%
At least 4 years but less than 5 years	60%
At least 5 years but less than 6 years	80%
6 years or more	100%

**Notes Receivable From Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 1 percent above the prime rate, as defined, and were between 4.25% and 9.50% at December 31, 2024. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits** – A participant's account balance may be withdrawn upon retirement, death, disability, or termination of employment as defined by the Plan. Benefits are payable in either a single lump-sum amount, or installment payments equal to the value of the participant's account. In-service withdrawals from transfer accounts and hardship distributions are also allowed by the Plan.

**Plan Termination** - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**Forfeited Accounts** – At December 31, 2024, forfeited non-vested accounts total \$1,586 (\$3,044 at December 31, 2023). These accounts can be allocated as an additional Company nonelective contribution, reduce future Company nonelective contributions or pay reasonable plan expenses. During the year ended December 31, 2024, the Plan used \$8,668 from forfeited non-vested accounts to pay plan expenses.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting** – The accompanying financial statements have been prepared on the accrual basis of accounting.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits** – Benefits are recorded when paid.

**Expenses** – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Plan Amendment** – On March 27, 2020, President Trump signed into law the Coronavirus Aid, Relief, and Economic Security Act, (CARES Act). As a result, changes were made related to Plan withdrawals and loans to participants, for impacted participants, their spouse and dependent(s) who have been diagnosed with virus SARS-CoV-2 or with COVID-19, as well as participants that have experienced adverse financial consequences.

**Plan Amendment (cont'd)** – The changes applicable to the Plan are summarized below:

- Impacted participants may receive up to \$100,000 in aggregate withdrawals before December 31, 2020.
- 10% penalty tax for early withdrawal is waived.
- Mandatory 20% withholding on distributions will not apply.
- No limit to the number of withdrawals an impacted participant can make.
- Repayment of withdrawal amount is permitted if repayment occurs within three years of the distribution.
- Impacted participants may borrow up to the lesser of \$100,000 or 100% of their vested balance for 180 days beginning March 27, 2020.
- Impacted participant loan payments due from March 27, 2020 through December 31, 2020, including those due following a severance from employment, may be delayed for one year.
- Required Minimum Distribution (RMD) rules for distributions required for the 2020 calendar year are temporarily waived.

On December 20, 2023, the IRS issued Notice 2024-2, which extends the deadlines for qualified retirement plans to adopt amendments reflecting certain optional and required changes under the SECURE, SECURE 2.0, CARES, and Miners Acts. Plan sponsors of defined contribution plans generally now have until December 31, 2026, to amend their plans if they took advantage of benefit changes permitted by these laws, including changes allowed by the CARES Act as part of COVID-19 relief.

The Plan will formally adopt an amendment to address these changes at a later date in accordance with applicable law and IRS guidance.

**3. Information Prepared and Certified by Sub-Custodian and Custodian**

The Company, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the unaudited information regarding the Plan as of December 31, 2024, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedules, that was prepared by or derived from information prepared by American Trust Company, as sub-custodian to, and on behalf of, Trust Company of Illinois, the custodian, and furnished to the Company.

**4. Fair Value Measurements**

Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 820, "Fair Value Measurements and Disclosures," provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

**Level 1** – Valuations are based on unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

**Level 2** – Valuations are based on quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are not active; and model-derived valuations whose significant inputs are observable.

**Level 3** – Valuations are based on unobservable inputs for the asset or liability that reflect the reporting entity's own data and assumptions that market participants would use in pricing the asset or liability. These unobservable inputs are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**4. Fair Value Measurements (cont'd)**

Following is a description of valuation methodologies used for investments measured at fair value on the statement of net assets available for benefits, and the classification of such investments pursuant to the valuation hierarchy.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. These assets are categorized in Level 1 of the fair value hierarchy.

**5. Related-Party and Party-in-Interest Transactions**

Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the Trust Company of Illinois, of \$66,034 for the year ended December 31, 2024. The Trust Company of Illinois is the custodian as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. The Company pays directly any other fees related to the Plan's operations.

**6. Tax Status**

The Plan has adopted the Trust Company of Illinois Defined Contribution Pre-Approved Basic Plan Document. The Internal Revenue Service has determined and informed the Trust Company of Illinois, by a letter dated June 30, 2020, that the Basic Plan Document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by federal and state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**8. Delinquent Participant Contributions and Loan Repayments**

Delays in remitting contributions and loan repayments to the Plan constitute prohibited transactions. Related excise taxes will be paid by the Company. During 2024, the Plan had a late deposit totaling \$146. Corrections for this late deposit are pending.

**10. Subsequent Events**

In January 2025, the Plan was amended to become a safe harbor 401(k) Plan. The eligibility requirements for this contribution type are the same as elective deferrals. The safe harbor matching contribution is 100% of each participant's elective deferral up to 3% and 50% of deferrals from 3% to 5%, for a maximum of 4%.

In February 2025, the Plan was amended to allow in-service withdrawals after a participant reaches normal retirement age.

Subsequent events have been evaluated through September 19, 2025, which is the date the financial statements were available to be issued.
