INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of
Travelport Employee Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Travelport Employee Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control related matters that we identified during the audit.

Other Matter

1. DESCRIPTION OF PLAN

The following description of the Travelport Employee Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the official Plan document for complete information.

General

The Plan is a defined contribution plan that provides Internal Revenue Code (IRC) Section 401(k) employee salary deferral benefits and additional employer contributions for eligible employees of Travelport Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Travelport Employee Benefits Committee controls and manages the operation and administration of the Plan. Fidelity Management Trust Company (the Trustee or Fidelity) is the Trustee.

Eligibility

Each full-time employee of the Company, as defined by the Plan document, is eligible to participate in the Plan following the later of commencement of employment or the attainment of age 18. Each part-time employee of the Company, as defined by the Plan document, is eligible to participate in the Plan following the later of one year of eligible service or the attainment of age 18. Effective January 1, 2024, the Plan was amended relative to a long-term part-time employee (LTPT employee). Based upon the terms of the amendment, an LTPT employee is defined as any employee who has completed at least 500 hours of service in each of three consecutive 12-month periods beginning after December 31, 2020, and who is not yet a participant in the Plan. For Plan years beginning on or after January 1, 2025, the previous sentence shall be applied substituting “two consecutive 12-month periods” for “three consecutive 12-month periods, as defined.” For this purpose, 12-month periods shall be measured beginning on the employee’s commencement date.

Contributions

Participants in the Plan may elect to make pretax contributions, Roth after-tax contributions, or a combination of both, of up to 75% of their eligible compensation in 1% increments, as defined by the Plan document, subject to the IRC limitations. Participants who have attained age 50 before the end of the Plan year are eligible to contribute additional amounts in pretax contributions, Roth after-tax contributions, or a combination of both, as catch-up contributions, in accordance with Internal Revenue Code regulations. Eligible employees are automatically enrolled at a 3% pretax contribution deferral following 30 days of his or her employment commencement date. Absent an election by the participant, the 3% pretax contribution deferral will automatically increase 1% per year up to 6% on the fourth anniversary date up to a maximum of 10% of pay.

The Company will match 100% of an employee’s contribution up to 3% of the employee’s eligible compensation and then 50% of an employee’s contribution up to the next 2% of the employee’s eligible compensation.

Rollover contributions are amounts transferred to the Plan from retirement plans in which certain employees previously participated. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's contribution, the Company's matching contribution and an allocation of Plan earnings, net of losses and management and administrative expenses. Allocations of Plan earnings are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in the value of their accounts, which includes participant and Company contributions and related earnings thereon.

Investments

Participants direct the investment of their contributions and Company matching contributions into various investment options offered by the Plan. The Plan is intended to be a participant-directed Plan under Section 404(c) of ERISA, which means participants are responsible for the results of their investment decisions.

Notes Receivable from Participants

The Plan allows participants to borrow from their vested account amounts not to exceed the lesser of 50% of the participant's balance or \$50,000. The maximum term of such loans is five years, except for a loan for the purchase of a primary residence, which has a 15-year maximum term. The loans are collateralized by the balance in the participant's account and bear interest at rates commensurate with the prime rate, plus 1%. Principal and interest are paid ratably through payroll deductions. There is a maximum of two outstanding loans at any time.

A participant may repay any portion of their outstanding loan balance at any time. Except for the final payment, doing so will not decrease the payment amount of future loan installments.

A participant may suspend their loan payments for a period of up to one year while on a leave of absence without pay or at a pay rate that is less than the amount of their loan payments. While payments are suspended, interest on the participant's loan continues to accrue. When a participant resumes making payments, their loan payments cannot be less than they were before the suspension. Further, suspension of loan payments cannot extend the term of the loan beyond five years (or 15 years if the loan was used to buy or build the participant's primary residence).

Payment of Benefits

Participants are entitled to withdraw all or any portion of their vested accounts in accordance with the terms of the Plan and applicable laws. Participants may make full or partial withdrawals of funds from their pretax or Roth after-tax contribution accounts upon attaining the age 59½ or for hardship in certain circumstances, as defined in the Plan document, before that age.

A terminated participant with an account balance of \$1,000 to \$5,000, excluding rollover source balances, will be rolled into an IRA with Fidelity if the participant does not elect to have their account distributed. A terminated participant with an account balance less than \$1,000 will automatically receive a lump-sum distribution.

Administrative Expenses

For the year ended December 31, 2024, a majority of the administrative expenses of the Plan were paid by the Company, with the exception of transaction fees charged directly to participants and an annual administrative fee for core services relative to the recordkeeping and Trustee services of the Plan. The balance in the payment account as of December 31, 2024 and 2023, was \$339,458 and \$379,468, respectively. During 2024, \$58,950 was applied to pay administrative fees of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan's investments include mutual and money market funds and a common collective trust fund. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual and Money Market Funds: Valued at the daily closing price as reported by the fund. Mutual and money market funds held by the Plan are open-ended mutual and money market funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual and money market funds held by the Plan are deemed to be actively traded.

Common Collective Trust Funds: Valued at NAV as determined by the issuer of the collective trust funds based on the fair value of the underlying investments. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

Participant transactions (purchases and sales) may occur daily. All the common collective trust funds can be redeemed daily. There are no unfunded commitments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

3. FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, are described as follows:

- Level 1 – Observable inputs such as quoted prices in active markets;
- Level 2 – Inputs, other than quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3 – Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used to measure fair value during the year ended December 31, 2024.

5. RELATED PARTY TRANSACTIONS

Certain Plan investments are shares or units of investment funds managed by Fidelity. Fidelity is the Trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid for investment advisory services and recordkeeping fees are included within administrative fees on the statement of changes in net assets available for benefits for the year ended December 31, 2024.

The Trustee and recordkeeper provide certain administrative services to the Plan pursuant to trust and recordkeeping agreements with the Company. In the normal course of business, Fidelity receives revenue from certain mutual fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services provided to the Plan. If the revenue received by Fidelity from such mutual fund service providers were to exceed the amount owed under the trust agreement, Fidelity would remit the excess to the Plan's trust and such amounts could be applied to pay Plan administrative expenses or allocated to the accounts of participants. As of December 31, 2024 and 2023, there was a balance in the revenue credit account of \$47,411 and \$16,881, respectively. For the year ended December 31, 2024, the revenue credit account was used to pay \$28,990 in administrative fees. These transactions qualify as exempt party-in-interest transactions.

6. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company reserves the right under the Plan to discontinue its contributions at any time or to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their account balances.

7. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter, dated December 18, 2013, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. The Plan has been amended since receiving the determination letter; however, the Company and Plan management believe that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. SUBSEQUENT EVENTS

Management has evaluated events through August 29, 2025, which is the date that the financial statements were available to be issued, and has determined that there are no subsequent events that require disclosure under FASB ASC Topic 855, *Subsequent Events*.
