The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Note 1: Description of Plan

The following description of the Mason Companies Retirement and Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all employees of Mason Companies, Inc. (the "Company"), except casual/seasonal and temporary employees, who have attained the age of 18. Employees must have 90 days of service to be eligible for participant deferrals and Company safe harbor matching contributions, and one year of service and be employed on the last day of the Plan year to receive the discretionary non-elective contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

In December 2022, Setting Every Community up for Retirement Enhancement Act (SECURE 2.0) was signed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Plan management will determine the optional provisions to elect in the future.

#### Contributions

Each year, participants may contribute up to 50% of annual compensation, as defined in the Plan, up to the annual maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan also has an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the plan at a fixed 6% deferral rate unless the participant makes a contrary election. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a safe harbor matching contribution equal to 100% of the first 4% of compensation that a participant contributes to the Plan plus 50% of the next 2% of compensation that a participant contributes to the Plan. Additional discretionary non-elective amounts may also be contributed at the discretion of the Company's Board of Directors. During the year ended December 31, 2024, the Company made safe harbor matching contributions of \$839,788. There were no discretionary non-elective contributions to the Plan for the year ended December 31, 2024. Contributions are subject to certain IRS limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Company safe harbor matching contributions, and allocations of (a) the Company's discretionary non-elective contribution and (b) Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their voluntary contributions and safe harbor matching contributions plus actual earnings (losses) thereon. Vesting in the Company's discretionary discretionary non-elective contribution portion of their accounts plus actual earnings (losses) thereon is based on years of service. Participants become fully vested after three years of service.

#### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum or partial withdrawals amount equal to the value of the participant's vested interest in his or her account or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution or partial withdrawals. Participants with accounts under \$1,000 upon termination will receive a lump sum payment if a direct rollover to another plan or individual retirement account is not elected. The Plan also allows for in-service distributions upon attaining age 59 1/2.

#### Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$54,389, respectively. These accounts can be used to reduce future Company contributions, to pay administrative expenses, or can be allocated to participants as an additional discretionary non-elective contribution in accordance with the Plan document. For the year ended December 31, 2024, \$51,226 from forfeited nonvested accounts was used to pay administrative expenses and \$126,368 were used to pay Company contributions.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

### Note 2: Summary of Significant Accounting Policies (Continued)

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Trustee, investment advisory, Plan administration, and audit expenses are paid directly from the Plan's assets.

#### Subsequent Events

The Plan has evaluated subsequent events through September 29, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value collective trust fund:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities' liquidations will be carried out in an orderly business manner.

*Common collective trust fund:* A collective investment trust fund is comprised of pooled accounts held by the trust company, which invests primarily in equity securities that seek long-term growth of capital. These funds are valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value.

Certain information disclosed in the accompanying financial statements, including investments held at December 31, 2024, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company ("FMTC"), the "Trustee" of the Plan. Certain information disclosed in the accompanying financial statements including investments held and non interest bearing cash at December 31, 2023 were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Matrix Trust Company, the "Trustee" of the Plan.

### Note 5: Related-Party Transactions and Party-in-Interest Transactions

FMTC is the Trustee and record keeper as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the Trustee were included in administrative expenses for the year ended December 31, 2024.

Francis Investment Council is the investment advisor for the Plan. For the year ended December 31, 2024, fees paid by the Plan to Francis Investment Council were included in administrative expenses.

Wipfli LLP is the Plan's external auditor. The Plan has elected to have fees associated with the annual Plan audit paid directly from the Plan. Expenses are included in administrative expenses for the year ended December 31, 2024.

### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company discretionary discretionary non-elective contributions.

### **Note 7: Tax Status**

The Company adopted a non-standardized defined contribution pre-approved plan document with an IRS opinion letter, which states the Plan was in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter; however, the Plan administrator believes the Plan was designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
