Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Peoples Bank 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of July 24, 2024 and December 31, 2023, the related statements of changes in net assets available for benefits for the seven months ended ended July 24, 2024 and year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C), pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statement or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by a bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the seven months ended July 24, 2024 and year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of Peoples Bank 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan, available to substantially all employees of Peoples Bank (the "Company" or "Plan Sponsor") who are aged twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Ameritas Life Insurance Corporation (the "Custodian" or "Ameritas") is the custodian of the Plan. The Plan's assets are held by the Custodian of the Plan. Company contributions are held and managed by the Custodian, which invests cash received, interest, and dividend income and makes distributions to participants. Dyatech, LLC ("Dyatech") is the third-party administrator of the Plan. The Company's Board of Directors oversees the governance of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance. The Plan is administered by the Plan Administrator who is appointed by the Board of Directors of the Company.

Contributions

Participants may contribute any amount up to one hundred percent of their compensation subject to regulatory limitations, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans ("rollover"). Participants direct the investment of their contributions into various options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at three percent of eligible compensation.

The Company contributes a discretionary match equal to fifty percent of the participant's deferral contribution, up to a maximum of three percent. Additional profit-sharing amounts may be contributed at the option of the Company's Board of Directors. There were no profit-sharing contributions made by the Company during the seven months ended July 24, 2024, and year ended December 31, 2023.

Participant Account

Each participant's account is credited with the participant's contributions and allocations of (1) the employer's contributions and (2) Plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation or account balances as defined by the Plan. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their own contributions plus actual earnings. Vesting in the employer contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is one hundred percent vested after three years of credited service for matching contributions.

Note 1. Description of the Plan - continued

Payment of Benefits

Either a lump-sum or equal installment distribution of benefits will be made, in accordance with the various forms of payment set forth in the Plan, upon determination of the Plan Administrator that a participant is eligible to receive payment of his or her account. Distributions for employees having obtained the age of required minimum distribution are calculated and distributed annually.

Participant Loans

The Plan does not allow participants to borrow from their fund accounts.

Forfeited Accounts

The Plan accumulates forfeitures until the earlier of either (1) the last day of the Plan year in which former participants incur five consecutive one-year breaks in services, or (2) the distribution of the entire vested portion of the former participant's account balance. The Plan uses forfeitures to reduce employer contributions and pay administrative expenses as elected under the Plan Agreement. At July 24, 2024 and December 31, 2023, forfeited, nonvested accounts totaled \$53,834 and \$51,662, respectively. For the seven months ended July 24, 2024, and year ended December 31, 2023, \$9,203 and \$9,831 of administrative expenses were reduced from forfeited, nonvested accounts, respectively. For the seven months ended July 24, 2024, and year ended December 31, 2023, no employer contribution was reduced from forfeited, nonvested accounts.

Plan Conversion

Effective July 24, 2024, the Plan converted to a Pooled Employer Plan ("PEP") structure sponsored by Lincoln Financial Group. As a result of this change, the Plan is now administered as part of a larger pooled arrangement, allowing unrelated employers to participate in a single, consolidated retirement plan. The Pooled Plan Provider, Lincoln Financial Group, assumed responsibility on July 24, 2024, for key administrative and fiduciary functions. All Plan participants were informed of the change prior to the transition, and no material changes to participant rights or benefits occurred as a result of this transition.

Additionally, as a result of the conversion to the PEP, the accompanying financial statements present the financial position and changes in net assets available for benefits as of and for the seven months ended July 24, 2024, while the prior year's financial statements present the financial position and changes in net assets available for benefits for the full year ended December 31, 2023. This change in reporting period should be considered when comparing the financial results between the two periods.

Note 2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Administrative expenses of the Plan are allocated to participant accounts on a pro-rata basis, according to each participant's account balance as a percentage of total Plan assets.

Note 3. Information Certified and Provided by Ameritas Life Insurance Corporation

Certain information related to investments disclosed in the accompanying financial statements, including investments held at July 24, 2024 and December 31, 2023, and net appreciation in fair value of investments and interest and dividends and other income for the periods then ended was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Custodian.

Note 4. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits, except for fully benefit-responsive investment contracts, which are reported at contract value. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1 measurements") and the lowest priority to unobservable inputs ("Level 3 measurements"). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means;
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Gains and losses included in changes in net assets available for benefits for the seven months ended July 24, 2024 and year ended December 31, 2023, are reported in net appreciation (depreciation) in the fair value of investments. The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the seven months ended July 24, 2024 and year ended December 31, 2023, there were no transfers between Levels 1 and 2 and no transfers into or out of Level 3.

Pooled Separate Accounts

The Pooled Separate Accounts are only available to the clients of the Custodian. The net asset value of a Pooled Separate Account is based on the market value of its underlying investments and is not a publicly-quoted price in an active market. These fair values are generally obtained from third-party pricing services or determined through the use of valuation models or methodologies, including matrix pricing, using substantially all observable inputs. As of December 31, 2023, all Pooled Separate Accounts are reflected in Level 2. As of July 24, 2024, there were no Pooled Separate Accounts in the Plan.

Note 5. Group Annuity Contract with Insurance Company

In 2014, the Plan entered into a group annuity contract issued by The Guardian Insurance and Annuity Company ("GIAC"). GIAC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the group annuity contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attributed for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by GIAC, represents contributions or transfers-in made under the contract, plus earnings, less participant withdrawals or transfers-out, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The group annuity contract was terminated as of July 24, 2024.

Note 5. Group Annuity Contract with Insurance Company – continued

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at July 24, 2024 and December 31, 2023, was \$0 and \$729,391, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. The interest rate is based on the return GIAC expects on new investments made and held, and it will always equal or exceed the contractually guaranteed rate. Such interest rates are established and declared for new contributions that will be received in a calendar quarter. The minimum contractually guaranteed rate for any interest rate period is two percent.

Certain events limit the Plan's ability to transact at contract value with GIAC. Such events include the following: (a) full or partial plan termination; (b) the insolvency of the Plan Sponsor; (c) the Plan Sponsor files for protection under federal bankruptcy law, is deemed insolvent, dissolves, closes, shuts down its business, or ceases operations; (d) the Plan continues to be operated or administered in a manner that would disqualify the Plan, is unlawful, violates ERISA or the Internal Revenue Code, or exposes GIAC to potential liability, after GIAC has provided the Plan with at least 30 days' notice of concern; and (e) after the first contract year has elapsed, the aggregate account value under contract totals less than \$50,000.

Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become one hundred percent vested in their employer contributions.

NOTES TO FINANCIAL STATEMENTS

Note 8. Income Tax Status

The Plan uses a non-standardized 401(k) plan document sponsored by Dyatech. Dyatech received an opinion letter from the Internal Revenue Service ("IRS") dated March 31, 2014, which states that the non-standardized 401(k) document satisfies the applicable provisions of the Internal Revenue Code of 1986, as amended (the "Code"). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified.

U.S. GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10. Related Party Transactions

Certain Plan investments are shares held in fixed rate options managed by Ameritas Life Insurance Corporation. The Company is the Custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions.

Note 11. Subsequent Events

Management has evaluated subsequent events through September 11, 2025, the date these financial statements were available to be issued, and determined there were no other events occurring after July 24, 2024, but prior to the issuance of these financial statements, that would have a material impact on its financial statements.



