INDEPENDENT AUDITOR'S REPORT

To the Trustee and Plan Administrator
McKay's Market 401(k) Plan
Coos Bay, Oregon

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of McKay's Market 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of McKay's Market 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of McKay's Market 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about McKay's Market 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

1. Plan Description

The following description of McKay's Market 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The Plan's most recent restatement was effective January 1, 2022.

General

The Plan is a defined contribution plan available to qualifying employees of K. E. McKay's Market of Coos Bay, Inc. (McKay's Market). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan's investment structure is a group annuity contract or funding agreement that includes variable investment offerings, through Pooled Separate Accounts or Common Collective Trusts with Principal Financial Group. These Pooled Separate Accounts or Common Collective Trusts are divided into investment divisions called "Sub-Accounts." Each Sub-Account invests in shares of any underlying mutual fund.

Eligibility

To be eligible to participate in the Plan, an employee must have attained the age of 18 and have completed at least one year of service. Union employees are excluded from participation in the Plan. Employees must also have worked at least 1,000 hours in the year of eligibility. Entry dates are the first of the month after meeting all eligibility requirements. Beginning on January 1, 2021, when the Setting Every Community Up for Retirement Enhancement Act (the SECURE Act) became effective, the annual hourly requirement for part-time employees to become eligible is at least 500 hours in a three-year period. The plan was amended effective January 1, 2024 to waive service requirements for acquired employees of JC Market.

Contributions

Each year, participants may contribute, on either a pre-tax or after-tax (Roth) basis, the lesser of 100 percent of the participant's eligible compensation or the annual maximum contributions as defined by IRS Code 415(c)(1)(A).

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants who have attained the age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers), excluding participants who are no longer employed by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate of 5 percent of eligible compensation.

McKay's Market makes a Safe Harbor matching contribution equal to 100 percent of the participant's contribution up to a maximum of 5 percent of a participant's eligible compensation, in accordance with Plan provisions. In addition to the required Safe Harbor matching contribution, McKay's Market may make discretionary matching contributions or discretionary nonelective contributions (profit-sharing). For the years ending December 31, 2024 and 2023, there were no discretionary matching or profit-sharing contributions.

Contributions are invested in a target date fund based on the participant's estimated retirement age unless changed by the participant.

1. Plan Description, continued

Participant Accounts

The account of each eligible participant is credited with the participant's and employer's contributions as defined above. Individual accounts may be credited or debited for allocations of plan earnings and administrative expense based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant (or designated beneficiary in the event of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in the participant's account, or installment payments over a period not to exceed the life expectancy of the participant. For termination of service for other reasons, a participant may receive the value of the vested interest in the participant's account as a lump-sum distribution. In-service distributions are permitted from vested accounts upon attainment of age 59½ or for hardship based on provisions specified in the Plan document.

Forfeited Accounts

If a participant leaves McKay's Market employment prior to three years of service, any non-vested portion of their account is forfeited and will be used to reduce future employer contributions. For the years ended December 31, 2024 and 2023, forfeitures were \$7,470 and \$-0-, respectively. The entirety of 2024 forfeitures were forfeited in error and subsequently corrected and refunded back to participant accounts after year end.

Vesting

Participants are vested immediately in their contributions and Safe Harbor matching contributions plus actual earnings thereon. Vesting in company discretionary matching contributions and non-elective (profit-sharing) contributions are based on years of service.

A participant is 100 percent vested after three years of service for the non-Safe Harbor match (pre-2013) amounts and non-elective (profit-sharing) contributions. Upon reaching normal retirement age or upon death, the participant is 100 percent vested.

Notes Receivable from Participants

Participant loans are not permitted by the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies, continued

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion on fair value measurements.

Interest and dividend income are recorded on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Administrative Expenses

Expenses of administering the Plan may be paid from Plan assets at the election of the Plan administrator. Certain expenses of maintaining the Plan may be paid by McKay's Market and are therefore excluded from these financial statements. Investment related expenses are included in net change in fair value of investments.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments – Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant contributions receivable.

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

3. Information Certified by the Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company, the custodian, has certified that the following information included in the accompanying financial statements and supplemental schedules is complete and accurate as of and for the years ended December 31:

4. Plan Termination

Although it has not expressed any intent to do so, McKay's Market has the right to terminate the Plan at any time, subject to Plan provisions. In the event of Plan termination, the accounts of all participants become fully vested and nonforfeitable, and all unallocated amounts will be allocated to the accounts of the participants in accordance with the Plan provisions.

5. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase plan. Pension Plan Specialists PC, the sponsor of the pre-approved plan, has received an opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended and restated since reviewing the letter, the Plan administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by the Internal Revenue Service; however, there are currently no audits for any tax periods in progress.

6. Party-in-Interest Transactions

Certain plan investments are shares of mutual funds managed by Principal Life Insurance Company. Principal Life Insurance Company is the asset custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Principal Life Insurance Company, the custodian, for contract administrator services amounted to \$65,588 and \$51,873 for the years ended December 31, 2024 and 2023, respectively. These transactions are exempt from the prohibited transaction rules of ERISA.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to its fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. Management determined common collective trust investments should be moved to level 2 as of December 31, 2024. There were no changes in the methodologies used at December 31, 2023.

Registered investment companies: The Plan's investments are units of mutual funds held within a group annuity contract. These funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and considered to have a readily determinable fair value.

8. Fair Value Measurements, continued

Common/collective trust and pooled separate accounts: These investments include various index funds for domestic equities. The investments are valued at the net asset value of units of a bank collective trust, and the net asset value is published to investors through accessing their online balances and more broadly available through publishing publicly.

9. Non-exempt Transactions

For the year ended December 31, 2024, participant contributions totaling \$24,889 were not remitted to the Plan within the appropriate time period by the Employer. These transactions constitute prohibited transactions as defined by ERISA. The Employer is taking the appropriate steps to correct the situation by reimbursing employees for lost earnings and interest, and have further implemented a procedure to ensure that all future remittances are made within the prescribed time period. There were no delinquent participant contributions for the year ended December 31, 2023.

10. Subsequent Events

Management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.

Effective March 1, 2025, the Plan made certain SECURE 2.0 provisions available to participants, including federally declared disaster loans, federally declared disaster withdrawals, super catch-up contributions and increasing the force-out threshold to \$7,000.
