## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Koury Engineering and Testing 401(k) Profit Sharing Plan and Trust (the "Plan") an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31 2024, and the related notes to the financial statements.

Management has obtained certification from a qualified institution as of and for the year ended December 31, 2024, and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

**NOTE A – DESCRIPTION OF THE PLAN AND SUMMARY OF THE SIGNIFICANT ACCOUNTING POLICIES**

The Koury Engineering and Testing 401(k) Profit Sharing Plan and Trust (the "Plan") is a defined contribution plan providing retirement income, disability, termination and death benefits to eligible employees. The original Plan was effective January 1, 1988. The Plan is sponsored and administered by Koury Engineering and Testing, Inc. including the affiliated employers; Koury Payroll Services, Inc., ND Testing, Inc., and Hilltop Geotechnical, Inc. (collectively, the "Company")

Effective January 19, 2022 the Plan was restated to adopt a Volume Submitter Profit Sharing and 401(k) adoption agreement transferring fund balances from Mid Atlantic Trust Company to Voya Retirement Insurance and Annuity Company (Voya), the Plan asset custodian. Voya is responsible for investing and managing the Plan's assets. This amendment and restatement also bring the Plan into compliance with the legislative and regulatory changes set forth in Internal Revenue Service (IRS) Notice 2017-37. The Plan consists of a tax deferred savings program under Internal Revenue Code (IRC) Section 401(k) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following description of the Plan provides only general information. Participants and other interested parties should refer to the plan document for a more complete description of the Plan's provisions.

The Plan excludes employees who are covered by a collective bargaining agreement, nonresident aliens, and employees hired as a result of a transaction described in Code section 410(b)(6)(C) such as an asset or stock acquisition, merger, or similar transaction involving a change in the employer of the employees of a trade or business. All other employees shall be eligible to participate in the Plan after completing 3 months of service and attainment of 21 years of age. Entry dates for the Plan are the first day of every month.

Contributions

Participants may contribute to the Plan; subject to IRS limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated target date fund based on their age until changed by the participant.

The Plan also provides for discretionary employer contributions. There was no employer contributions for the year ended December 31, 2024.

Participant Accounts

A participant's account is credited with the participant's contributions, allocation of (a) the Company's contributions and (b) plan earnings. A participant's account is debited with an allocation of plan losses and charged for administrative expenses; as applicable. Allocation of earnings or losses are based upon participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions at all times. Participants are vested in the employer matching and profit-sharing contributions based upon the following schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts the lesser of \$50,000 or 50 percent of their vested account balance. The notes are secured by the balance in the participant's account and bear a reasonable fixed rate of interest based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest are paid through payroll deductions.

Payments of Benefits

The Plan provides for the payment of benefits to the participant or beneficiary at retirement (age 65), death, disability or termination of employment. Participants terminating their employment with the Company or attaining age 59 1/2 are entitled to withdraw all or a portion of their vested account balance. Participants who qualify for retirement benefits and withdrawals will receive their benefits in the form of a lump sum cash distribution or in periodic installments. "Hardship" distributions, as outlined in the Plan, are permitted subject to the approval of the Company. Benefits under the Plan shall be distributed solely from the assets of the Trust. The benefit to which a participant is entitled is the benefit that can be provided directly from the participant's vested account balance.

Payments of Benefits – Continued

In addition, participants with balances less than \$5,000 will have their account balances automatically distributed to them. The individual has the right to direct payment to another qualified plan or individual retirement account.

Forfeitures

As of December 31, 2024, there was no balance in the forfeitures account. Forfeitures of non-vested Company matching or profit-sharing contributions are retained in the Plan and may be used to reduce future Company contributions and pay plan expenses.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reporting amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities.

Investment Valuation and Income Recognition

Investments, except for the investment in the insurance contract, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, see Note D.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan Document. No allowance for credit losses has been recorded as of December 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable and terminated participant accounts from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. For the year ended December 31, 2024, the Company paid \$11,000 for administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through September 22, 2025, the date the financial statements were available to be issued, and noted that concluded that there were no additional events that require recording or disclosure in the financial statements as of December 31, 2024.

**NOTE C - CERTIFIED INVESTMENT INFORMATION**

For the years ended December 31, 2024, and 2023 management has elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), the audits need not extend to any statements or information related to the certified investment information. **NOTE D - FAIR VALUE MEASUREMENTS**

FASB ASC 820, *Fair Value Measurements and Disclosures* established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE D - FAIR VALUE MEASUREMENTS – CONTINUED**

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- Common Collective Trusts (variable annuities): The initial pricing input is the quoted price obtained for the underlying stock and bond investments which is then adjusted to apply the expense factor disclosed in the annuity contract. The formula-calculated unit value is then compared to an accounting-driven unit value the following morning. The accounting unit value is determined in a manner similar to a mutual fund NAV calculation: dividing the net assets by the number of units outstanding.
- Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual Funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The investment is classified within Level 1 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - INVESTMENT CONTRACT**

At December 31, 2024, the Plan invested in a benefit-responsive fixed account investment option with Voya Retirement Insurance and Annuity Company (Voya). Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The fixed account investment option meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 is \$440,161. The crediting interest rate is based on a formula agreed with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a semi-annual basis for resetting. The investment earned an average yield of 1.5% during the year ended December 31, 2024.

**NOTE E - INVESTMENT CONTRACT – CONTINUED**

Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including partial or total plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestures or spin offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, and (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

**NOTE F - RELATED PARTY TRANSACTIONS**

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. Certain investments are managed by Voya in common collective trusts as defined by the Plan. The Plan issues loans to participants which are secured by the balances in participants' accounts. The Plan paid certain administrative fees in 2024. The Company paid certain administrative expenses of the Plan, including audit fees. These transactions qualify as party in interest transactions for which a statutory exception exemption exists.

**NOTE G - PLAN TERMINATION**

Although the Company has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants will become 100 percent vested in all Company contributions.

**NOTE H - TAX STATUS**

On January 19, 2022, the Company adopted the Voya Retirement Insurance and Annuity Company Non-standardized Defined Contribution Pre-Approved Plan, which obtained its latest Opinion Letter on December 18, 2018. In this letter, the Internal Revenue Service states that the Plan is acceptable under Section 401 of the Internal Revenue Code (Code) for use by the employers for the benefit of their employees. The Trustee and Plan administrator believe the Plan is designed and is currently being operated in compliance with applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE I - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
