## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of Mize CPAs Inc. 401(k) Plan  
Topeka, Kansas

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Mize CPAs Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedule Required by ERISA**

The supplemental Schedule of Assets is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF THE PLAN

**General** – The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) for employees of Mize CPAs Inc. (the “Company”). The Plan became effective October 1, 1984. The Plan was amended and restated effective January 1, 2021, to adopt the Third Cycle Restatement to bring the Plan into compliance with legislative and regulatory changes set forth in IRS Notice 2017-37.

The following description of the Mize CPAs Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

**Plan Restatement** – The Plan was amended and restated effective November 14, 2024. The following changes were made to the Plan:

- Fidelity Management Trust Company (“FMTC”) replaced Matrix Trust Company as the investment custodian for the Plan. FMTC also replaced the Company as the Plan’s trustee.
- Fidelity Retirement Plan Services replaced TPP Retirement Plan Specialists as the Plan’s TPA and participant recordkeeper.
- Participants must be at least 18 years of age to participate in the Plan.
- The Company match became a non-discretionary match of 100% up to 3% of compensation.
- The threshold for automatic distribution of terminated participant balances increased to \$7,000.

**Eligibility** – The Plan covers substantially all employees of the Company who have completed 1 hour of service and the age of 18, except for employees covered by a collective bargaining agreement, and leased employees. Employees may enter the Plan on the first day of each Plan quarter after meeting the eligibility requirements.

**Contributions** – Subject to certain Internal Revenue Code (“IRC”) limitations, participants may elect to contribute a portion of their salary on a pretax basis, or as a Roth contribution. Participants may elect to make contributions up to 90% of their annual compensation. Participants who have reached 50 years of age are eligible to make catch-up contributions to the Plan.

For 2024, the Company match was a non-discretionary match of 100% of the amount contributed by the participant, up to a participant’s contribution of 3% of compensation. Participants that are highly compensated do not participate in the Company match.

Additionally, the Company may make discretionary profit-sharing contributions. During 2024, the Company did not declare a profit-sharing contribution. To be eligible to share in the profit-sharing contribution, a participant must be employed at the end of the year and have completed 1,000 hours of service. In addition, certain shareholders are not eligible to receive an allocation of the profit-sharing contribution. The amount received by each eligible participant is the ratio that each participant’s compensation bears to the total compensation of eligible participants.

**Participant Accounts** – Each participant’s account is credited with the participant’s and Company’s contributions, investment earnings and losses, and is charged with the participant’s withdrawals and distributions and an allocation of Plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investment Options** – The Plan offers a variety of mutual funds, money market funds and a stable value fund (common collective trust) as investment options for participants. In addition, participants may direct their contributions to individually directed brokerage accounts.

**Vesting** – Participant contributions and rollover accounts are fully vested at all times. Participants hired prior to July 1, 2015, are fully vested in matching contributions, and profit-sharing contributions vest in 20% increments, with 20% vested after 2 years of service, and become 100% vested after 6 years of service. For participants hired after July 1, 2015, matching and profit-sharing contributions vest in 20% increments, with 20% vested after 2 years of service, and become 100% vested after 6 years of service. In the event of death, disability, reaching normal retirement age, or termination of the Plan, the Company contributions will become fully vested. An employee must work 1,000 hours in a year to earn a year of service.

**Forfeitures** – Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. Forfeitures can be used to pay the administrative expenses of the Plan or to reduce future Company contributions to the Plan. During 2024, \$23,967 was used to pay administrative expenses. As of December 31, 2024 and 2023, there was \$10,922 and \$2,608, respectively, in the forfeitures account.

**Payment of Benefits** – Upon termination of employment, the participant, or in the case of death, the participant's beneficiary receives the participant's account balance in a single lump-sum. In the event of termination by a participant, account balances under \$7,000 may be subject to automatic distribution. Rollover funds are not considered when determining if a participant's balance is subject to automatic distribution. Vested balances between \$1,000 and \$7,000 will be automatically rolled over to an IRA account in the participant's name, unless otherwise instructed by the participant.

**In-Service Withdrawals** – The Plan allows in-service withdrawals for participants who are at least 59½ years old. The Plan also allows for hardship withdrawals to Plan participants meeting specific conditions, as defined in the Plan Document. Hardship withdrawals are limited to the participant's elective deferral account.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their employee account balance. The maximum loan term is 5 years. The loans are secured by the balance in the participant's account and bear interest at the *Wall Street Journal* prime rate, plus 2%. Principal and interest is paid ratably through payroll deductions. A participant may only have two loans outstanding at a time.

**Administrative Expenses** – Administrative expenses incurred by the Plan may be paid by the Plan or by the Company. During 2024, expenses paid by the Plan totaled \$142,919, and consisted of professional, recordkeeping and investment fees. Participants electing to invest in individually directed brokerage accounts may incur additional expenses. Any such expenses are charged directly to the participant as a reduction in investment return.

**Termination of the Plan** – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, participants shall become fully vested, and all remaining Plan assets shall be allocated to the participants as described in the full text of the Plan.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions** – Employer and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

**Excess Refundable Contributions** – Amounts payable to participants for contributions in excess of amounts allowed by the IRC are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants subsequent to year-end.

**Investment Valuation and Income Recognition** – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments in the mutual funds, common collective trust, money market funds and the brokerage accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance is considered necessary.

**Payment of Benefits** – Benefit payments are reported in the year paid.

**Date of Management's Review** – Subsequent events have been evaluated through September 26, 2025, which is the date the financial statements were available to be issued, and there were no material events requiring recognition or disclosure.

### 3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds and Money Market Funds – Valued at the closing price reported on the active market on which the individual securities are traded.

Common Collective Trust – Valued at the net asset value (“NAV”) of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held in the fund less its liabilities.

Common and Preferred Stocks, and Exchange Traded Funds – Valued at the closing price reported on the national exchange on which the securities are traded. These are held in the individually directed brokerage accounts.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The Plan’s investments are reported at fair value as follows at December 31, 2024 and 2023:

(a) Certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits. The common collective trust investment is valued daily, may be redeemed daily without restrictions, and with no notice requirements.

#### 4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the financial statements.

**5. INFORMATION CERTIFIED BY THE TRUSTEE AND A CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the Trustee, and Matrix Trust Company, a custodian of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Interest and dividend income
- Net appreciation in fair value of investments
- Schedule of Assets (Held at End of Year), excluding notes receivable from participants

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**6. TAX STATUS**

The Company adopted a prototype Non-standardized Pre-Approved Profit-Sharing Plan with CODA which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has since been amended. However, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

The Plan pays certain fees to Fidelity and Matrix to administer the Plan. The Plan may also pay the audit fees from Plan assets. These transactions qualify as party-in-interest. Notes receivable from participants are party-in-interest transactions.

Certain Plan investments consisted of money market funds managed by Matrix. Matrix was a custodian of the Plan assets, including the individually directed brokerage accounts, and, therefore, these transactions qualify as party-in-interest.

Certain Plan investments consist of mutual funds and money market funds managed by Fidelity, and Fidelity is the Trustee and a custodian of the Plan and, therefore, these transactions qualify as party-in-interest.
