- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

The following description of the Edesia Inc. Retirement Savings Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established by Edesia, Inc. (the Plan Sponsor or Employer) on January 1, 2011. The purpose of the Plan is to accumulate retirement income for its employees which will supplement retirement benefits provided to them by Social Security. The Plan is a contributory defined contribution plan under Section 403(b) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan Sponsor is also the Plan Administrator. As Plan Administrator, the Plan Sponsor has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Ascensus Trust Company (Ascensus) is the appointed trustee of the Plan.

Eligibility

Employees are immediately eligible to participate in the Plan and are automatically enrolled upon hire at a deferral rate of 4% of compensation on a pre-tax basis, unless they opt out. The Plan adopted certain provisions for eligibility for long-term part-time employees under the Setting Every Community Up for Retirement Enhancement Act of 2022 (SECURE) Act 2.0, which will be effective January 1, 2025.

Contributions

Participants may elect to contribute on a pre-tax or post-tax basis any percentage of their annual compensation to the Plan, subject to certain limitations as allowable under the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may roll over amounts representing distributions from other qualified defined benefit or contribution plans (Rollovers).

Participants are immediately eligible to receive Employer safe harbor matching contributions equal to 100% of their elective deferral contribution up to a maximum of 4% of their compensation. The Employer may also make discretionary additional safe harbor matching and qualified non-elective contributions. Effective March 1, 2024, employees who normally work less than 20 hours per week are not eligible for employer safe harbor matching contributions and non-elective contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, any rollover contributions made by the participant, and allocations of (a) the Employer contributions, (b) Plan earnings (losses) and (c) administrative revenue (expenses). Plan earnings (losses) and administrative revenue (expenses) are allocated to participant accounts based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their contributions, including rollover contributions, plus earnings thereon, and in the Employer's safe harbor matching contributions.

Vesting in the Employer's discretionary additional safe harbor matching and non-elective contributions is based on years of service in accordance with the following schedule:

<u>Years of Vesting Service</u>	<u>Vested Percentage</u>
Fewer than 3	0%
3 or more	100%

A year of vesting service is equal to at least 1,000 hours of service in a Plan year.

Participant Notes Receivable

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 minus the highest outstanding balance of loans in the past twelve months or 50% of their vested account balance.

Loans are secured by the vested balance in a participant's account and bear interest at the prevailing rate comparable to the current interest rates charged by financial institutions for similar loans, as determined by the Plan Administrator. Principal and interest are paid ratably through bi-weekly payroll deductions and must be completed within five years, with the exception of loans whose proceeds are used for the purchase of a participant's primary residence, which must be repaid over a reasonable period of time, as determined by the Plan Administrator. Participants may only have one loan outstanding at any time.

Payment of Benefits

Upon retirement from service, total and permanent disability, termination of employment or death, participants will receive the value of their account balance in a lump-sum distribution, in accordance with the provisions of the Plan. If a participant reaches age 59½, the participant may elect to receive all or a portion of his or her pre-tax contributions account. The Plan also provides for mandatory distribution to participants upon reaching age 73.

In the event of death, benefits are payable to the participant's surviving spouse or designated beneficiary. At any time, a participant may also elect to receive all or a portion of his or her Rollover. Terminated participants with vested account balances greater than \$1,000 may receive a lump-sum payment or, if the vested balance is greater than \$7,000, which increased from \$5,000 effective January 1, 2024 through a SECURE Act 2.0 provision, participants may receive a lump-sum payment or qualified joint and survivor annuity. Vested balances equal to or less than \$1,000 will be immediately cashed out in a lump-sum distribution. Hardship withdrawals from the Plan are permitted from the participant's elective deferral contribution account subject to the limitations imposed by the IRC.

Forfeitures

Any balance in the Employer contribution account of a participant who has separated from service, to which he or she is not entitled, shall be administered by the trustee and subsequently used to pay administrative expenses or reduce Employer contributions. At December 31, 2024, the forfeited non-vested account balance was \$15. At December 31, 2023, there was no balance in the forfeited non-vested account. During 2024, no forfeitures were used to reduce Plan expenses or Employer contributions.

Plan Termination

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. If the Plan is terminated, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value, except for amounts allocated to the insurance company general account investment, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). Contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the trustee.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest and are secured by the balance in the respective participant's account. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within stated terms. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document.

Contributions

Participant elective deferral contributions and Employer safe harbor matching contributions are recorded bi-weekly when the Employer remits the payroll deductions for investment into the Plan. From time-to-time, an Employer safe harbor matching contribution true-up is required and generally remitted in January following the Plan year end.

Payment of Benefits

Benefits are recognized when paid to participants or their designated beneficiaries.

Administrative Revenue (Expenses)

Expenses incurred in the administration of the Plan are paid by the Employer unless the Employer directs that such expenses shall be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management fees for certain investments are included as a reduction of investment return (net appreciation or depreciation) and not reflected separately in the Statement of Changes in Net Assets Available for Plan Benefits.

Administrative revenue arises when investment managers return a portion of the investment fees to the recordkeeper to offset the administrative expenses. Any excess resulting from this revenue credit remains in an unallocated account from which future Plan expenses can be paid or allocated to participant accounts. The Plan received administrative revenues of \$2,705 during 2024, which is included in net appreciation in fair value of investments on the accompanying Statement of Changes in Net Assets Available for Plan Benefits. The Plan held \$538 of unallocated administrative revenues at December 31, 2024, and none at December 31, 2023.

Estimates

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest risk, market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan invested in four mutual funds that accounted for approximately 48% and 43% of total Plan investments as of December 31, 2024 and 2023, respectively.

Financial Instruments with a Concentration of Credit Risk

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the outside entity's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

Subsequent Events

Management has evaluated subsequent events through July 29, 2025, which is the date these financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

As of December 31, 2024 and 2023, the Plan's investments in mutual funds are reported at level 1 within the fair value hierarchy.

4. Investment Contract with Insurance Company

The Plan has entered into an investment contract, Standard Stable Asset Fund, with Standard Insurance Company (Standard). Amounts held in connection with this contract are held in Standard's general account. Contributions allocated to the contract are guaranteed by Standard. The value of this contract included in the financial statements, as reported to the Plan by Standard, is equal to the sum of contributions made, less withdrawals and administrative expenses, plus interest credited, which approximates fair value.

The insurance company is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The minimum crediting rate under this contract is 1.00%, and the crediting rate is reviewed on a quarterly basis.

5. Summary of Financial Data Certified by the Trustee

The following is a summary of financial information and data certified by the trustee, Ascensus:

6. Income Tax Status

The Plan is operating under a volume submitter plan designed and sponsored by The Angell Pension Group, Inc. (Angell) (the Volume Submitter). Angell received an advisory letter from the IRS dated March 31, 2017, in which the IRS stated that the Volume Submitter satisfies the applicable requirements of the IRC. The Plan has been amended since receiving the advisory letter in order to comply with the latest applicable tax laws and regulations. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Differences from Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

8. Related Party Transactions and Party-in-Interest Transactions

Plan investments are held and managed by Ascensus, the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to Ascensus for administrative services totaling \$19,779 for the year ended December 31, 2024. Ascensus also receives revenue from The Standard Stable Asset Fund's service provider for services Ascensus provides to the fund (Note 2). In addition, participant notes receivable qualify as party-in-interest transactions.


