Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Meriwest Credit Union 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the Meriwest Credit Union 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

A. General

The Plan is a defined contribution plan that was established on January 1, 1996 by Meriwest Credit Union (the “Credit Union”) to provide benefits to eligible employees of the Credit Union and its subsidiary, Meriwest Mortgage Company, LLC. The Plan was last amended and restated effective March 1, 2019 to incorporate all prior amendments. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

B. Administration and Expenses

The 401(k) Plan Review Committee (the “Committee”) manages the operation and administration of the Plan. John Hancock Retirement Plan Services, LLC serves as trustee and third party administrator.

Investment fund management fees and operating expenses are charged directly to the investment fund and are thereby factored into each investment fund as a reduction of investment return. Administrative, recordkeeping and investment advisory fees were paid by the Plan in 2024 and 2023. Certain fees including withdrawal and participant loan administration fees are charged directly to participants. The Credit Union pays substantially all other costs of administering the Plan.

C. Eligibility

All employees of the Credit Union and its participating affiliates, other than leased employees, and employees employed in a temporary job classification who are not employed by the Credit Union, are eligible to participate in the Plan upon their date of hire.

D. Contributions

Participants may elect to contribute their eligible pre-tax compensation to the Plan and/or elect to make Roth after-tax contributions. Pre-tax deferrals and Roth contributions are subject to applicable Code limits. Participants age 50 or older may make additional catch-up contributions subject to applicable Code limits. Participants who make pre-tax contributions to the Plan receive an equivalent reduction in taxable compensation.

All eligible employees hired who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, are auto-enrolled at a pre-tax contribution rate of 6% of compensation. Unless the Participant otherwise elects, the Participant’s elective deferral rate shall be automatically increased by 1% annually to a maximum of 90%.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant’s investment directions.

D. Contributions (Continued)

The Credit Union may make discretionary profit sharing contributions as provided by the Plan and approved by the Board of Directors. No profit sharing contributions were made for the 2024 or 2023 Plan years.

E. Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions, earnings or losses, expenses and an allocation of Credit Union contributions, if any. Participant accounts are invested based solely on participant directions. The accounts of participants who do not make an affirmative investment election are invested in one of the Target Date Funds ("T. Rowe Price") based on the approximate retirement year of the participant.

F. Vesting and Forfeitures

Participants are immediately 100% vested in their entire account balance.

G. Payment of Benefits

Normal retirement age under the Plan is age 65. Upon termination of service, death, retirement, attainment of age 59½ or the tenth anniversary of the year in which the participant commenced participation in the Plan, a participant or beneficiary may choose to maintain his or her account in the Plan or to receive vested benefits. The Plan provides for benefits to be paid in a lump sum, installments or in the form of a nontransferable annuity purchased from an insurance company. Hardship distributions are permitted under limited circumstances as provided in the Plan and approved by the Committee.

All amounts under \$5,000 that are automatically distributed will be rolled over into an IRA.

H. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. Such loans bear interest at available market financing rates and are secured by the participant's account balance. A loan must be repaid to the Plan within a five-year period, unless the loan is used for the purchase of a principal residence in which case the maximum repayment period may be extended. A participant may have a maximum of two loans outstanding. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants carry an interest rate ranging from 4.25% to 9.50% at December 31, 2024 with maturities through March 2033. Notes are measured at their unpaid principal balance plus accrued interest. Delinquent notes receivable are recorded as a distribution based on the terms of the Plan document.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Investment Valuation and Income Recognition

Investments are stated at fair value except the fully benefit-responsive investment contract which is valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents contributions made to the fund, plus earnings, less participant withdrawals and administrative expenses. Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

C. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

D. Risks and Uncertainties

Investments are exposed to various investment risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

NOTE 3 - INCOME TAX STATUS

The Credit Union adopted a prototype plan that has received a favorable opinion letter from the Internal Revenue Service. The Credit Union believes the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes, and trust which forms part of the Plan is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Credit Union has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

In accordance with CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, certain information related to investments disclosed in the

accompanying financial statements and supplemental schedule of assets (held at end of year), including investments held at December 31, 2024 and 2023 and net appreciation of investments, interest and dividends for the years then ended, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by John Hancock Trust Company, LLC, the trustee of the Plan.

NOTE 6 - FAIR VALUE MEASUREMENTS

Accounting guidance establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices of identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability. The following table summarizes Plan investments at December 31 based on inputs used to value them:

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net assets value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Although the plan administrator believes this valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value could result in a different fair value measurement at the reporting date.

NOTE 7 - NEW YORK LIFE GUARANTEED INTEREST ACCOUNT

The New York Life Guaranteed Interest Account is maintained in a general account by New York Life. New York Life is contractually obligated to repay principal and a specified interest rate to the Plan. Because the fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to this fund. Participants may direct the withdrawal or transfer of all or a portion of their investment in the fund at contract value.

The crediting interest rate of the fund is based on a formula. The actual yield earned by the Plan was 3.00% and 2.95%, respectively for the years ended December 31, 2024 and 2023.

Certain events might limit the ability of the Plan to transact at contract value including premature termination of the Plan’s investment in the New York Life Guaranteed Interest Account. The plan administrator does not believe that any events limiting the Plan’s ability to transact at contract value are probable of occurring.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS

The payment by the Plan of direct and indirect expenses related to Plan operations and investment activity to Plan service providers are party-in-interest transactions under ERISA regulations. Such transactions are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 17, 2025, the date on which the financial statements were available to be issued. There are no material subsequent events that require adjustment or additional disclosure in these financial statements.
