Note 1 – Description of Plan

The following description of the BSK Associates Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

General – The Plan is a defined contribution plan that was established on January 1, 1988, by BSK Associates (the Company) to provide benefits to eligible employees, as defined in the plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (the Code) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility – With the exception of eligibility related to the prevailing wage contribution, employees of the Company are eligible to participate in the Plan upon reaching age 18 and after completing one year of service in which at least 1,000 hours are worked. Participants are eligible to receive employer contributions if they are employed as of the last day of the Plan year and meet the age and service requirements.

Prevailing wages are contractual and are part of a fringe benefit. The Company remits prevailing wages on federal and state projects that are determined by the Department of Industrial Relation Prevailing Wage Determinations. Only employees working on particular jobs receive this extra portion of fringe benefit. The Company has the option to pay funds directly to the participant or deposit these funds on the participant's behalf into the participant's account in the Plan. Prevailing wage contributions are not subject to age, service, or hours requirements otherwise required under the Plan for other benefit sources.

Employer contributions – The Company may make contributions to the Plan as follows:

Discretionary contributions – The Company may elect to make discretionary contributions in such amounts as may be determined by the Company's Board of Directors. For the year ended December 31, 2024, the Company made discretionary contributions to the Plan amounting to \$1,091,181.

Prevailing wage contributions – Eligible employees who work on federally funded projects subject to prevailing wage rules receive prevailing wage fringe benefits. Employers have the option to fund these fringe benefits by contributing on an individual's behalf to a qualified retirement plan. These prevailing wage contributions are determined pursuant to the requirements of the Davis-Bacon Act and are subject to contracts for individual jobs. Each contract provides the specifics on what qualifies as prevailing wages, and the employer makes a contribution subject to that contract. The fringe portion of the wage determination is calculated per hour and deposited on a periodic basis. For the year ended December 31, 2024, the Company made prevailing wage contributions to the Plan amounting to \$109,420. Contributions are subject to regulatory limitations.

Participant accounts – The Plan is a defined contribution plan under which a separate individual account is established for each participant. The account maintained for each participant will be credited annually with his/her allocable share of Company stock (including fractional shares) purchased and paid for by the Plan, or contributed in-kind to the Plan as an employer contribution, with his/her allocable shares of any forfeitures from Company stock accounts, and with any allocable stock dividends on Company stock. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

Vesting – With the exception of vesting related to prevailing wage contributions, if a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company. After two years of service, participants vest 20% per year, and are 100% vested after completing six years of service.

Participants are vested immediately in the Company's prevailing wage contributions.

Payment of benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over up to a five-year period (plus one additional year if participant's vested account exceeds certain limits). For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Put option – Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradeable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of stock distributed to participants for which there is no market. The put price is representative of the current appraised value of stock. The Company can pay for the purchase in a lump sum or in equal annual installments with interest over a period of five years.

Diversification – Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who are at least age 55 with at least ten years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage increases to 50%. Participants who elect to diversify receive a cash distribution. The election to diversify is made subsequent to year end based upon the shares of employer stock in the participant's account at year end.

Forfeitures – Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the plan year. During the year ended December 31, 2024, forfeitures of cash and shares amounting to approximately \$10,876 and 557, respectively, were allocated to participants.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and appreciation of those investments.

Payment of benefits – Benefits are recorded when paid.

Expenses – As provided in the plan document, administrative expenses may be paid either by the Plan or by the Company. The Company has historically paid the operating expenses for the Plan.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits, but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through September 25, 2025, which is the date the financial statements were available to be issued.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Money market funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Mutual funds – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Employer securities (company common stock) – The BSK Associates common stock held by the Plan is reported at fair value based upon an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior years as illustrated in the following table.

Note 5 – Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated November 9, 2017, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Trustees believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, Trustees have evaluated the Plan's tax position and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Risks and Uncertainties

The Plan's investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 7 – Related Party and Party-in-Interest Transactions

The Plan invests in the common stock of BSK Associates. This is a related party and a party-in-interest transaction. As described in Note 1, the Company has historically paid the operating expenses for the Plan. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA.

Note 8 – Reclassification

The form 5500 has certain items that differ from amounts shown on the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefit for either period.

Note 9 – Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Employee Benefits Administration Committee directs the Trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust established under the Plan will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan's terms and the IRC.
