### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Carolinas Center for Surgery 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. ### 1. Description of the Plan

The following description of the Carolinas Center for Surgery 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General* – The Plan is a defined contribution plan established effective July 1, 1976, as restated June 9, 2021. The Plan covers all employees, excluding non-resident alien employees of Carteret Surgical Associates, P.A. dba Carolinas Center for Surgery (the "Company" or "Sponsor") who have completed one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Board of Directors is responsible for oversight of the Plan. The Plan's investment committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Board of Directors.

*Contributions* – Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan document, up to the maximum limits of \$23,000 of the Internal Revenue Code ("IRC"). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company is permitted to make nonelective discretionary contributions to the Plan allocated to participants based on their classification. The three classifications include: (1) Participants who are owner-physicians, (2) Participants who are licensed professionals eligible to bill Medicare under their own provider number (other than owner-physicians), and (3) all other participants. The Company will make a safe harbor matching contribution equal to 100% of elective deferrals that do not exceed 4% of compensation. Additional discretionary amounts may be contributed by the Company at the option of the Board of Directors. For the year ended December 31, 2024, the Company approved a \$165,366 discretionary contribution to the Plan. The Plan requires a participant to be employed as of year end to be eligible to receive employer contributions. The Company contributed \$84,297 in safe harbor matching for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

*Participant Accounts* – Each participant's account is credited with the participant's contributions, including any rollover amounts from qualified plans and allocations of: (a) the Company's safe harbor contributions, (b) the Company's nonelective discretionary contributions, and (c) Plan earnings (losses) and charged with benefit payments and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined.

*Vesting* – Participants are immediately vested in employee contributions or rollover contributions plus actual earnings thereon. Participants are also immediately vested in the safe harbor contribution. Due to the partial plan termination, participants are now 100% vested in Company discretionary elective contributions. See Note 6 for more information.

*Notes Receivable from Participants* – Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Terms range up to five years or greater for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate of 4.25% to 9.50% and maturing through January 2029.

*Benefits and Payments* – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the Plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump-sum cash payment. If the vested benefit does not exceed \$1,000, the benefit will be paid in a lump-sum amount. In addition, the Plan allows for hardship distributions if certain criteria are met.

*Plan Administration* – Carolinas Center for Surgery is the Plan administrator. Empower Trust Company, LLC serves as "Trustee" of the Plan.

*Forfeitures* – At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$37,732 and \$22,659, respectively. These accounts will be used to reduce future employer contributions or to pay administrative expenses. During 2024, the Plan administrative expenses were reduced by \$18,900, from forfeited nonvested accounts, in accordance with the Plan provisions.

### 2. Summary of Significant Accounting Policies

*Basis of Accounting* – The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates* – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Loans are considered to be in default and uncollectible by the Plan if any scheduled loan repayments are not made by the end of the calendar quarter following the calendar quarter in which the missed payment was due.

*Payment of Benefits* – Benefits are recorded when paid.

*Expenses* – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

*Subsequent Events* – Subsequent events were evaluated through September 23, 2025, the date the financial statements were available to be issued.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

*Level 1* – Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation technique include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – These investments are public investment vehicles valued using the net asset value ("NAV") provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market. For mutual funds where NAV is the quoted price in an active market, investments are classified within Level 1 of the valuation hierarchy.

*Common Collective Trusts* – These investments are a public investment vehicle valued using NAV provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the funds, minus its liabilities, and then divided by the number of shares outstanding. As the investments are valued at NAV as a practical expedient, the common collective trusts are not classified within the fair value hierarchy.

Accordingly, Empower Trust Company, LLC, the qualified institution, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

### **5. Party-in-interest Transactions**

The Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

Effective January 29, 2024, the Plan experienced a partial plan termination due to staff reductions. As a result, affected participants were made 100% vested in employer contributions.

### **7. Tax Status**

The Plan adopted a pre-approved plan offered by Great-West Trust Company, LLC. The pre-approved plan received an IRS Opinion Letter dated November 14, 2022, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **8. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
