### Opinion

## NOTES TO FINANCIAL STATEMENTS

### **1. Plan Description:**

The following description of The Chazen Companies Employee Stock Ownership Plan (the "Plan") is provided for general information only. Participants should refer to the Plan agreement for a more complete description.

#### **General**

Chazen Engineering, Land Surveying, Landscape Architecture & Geology Co., D.P.C. (the "Company") established the Plan effective as of January 1, 2007. The Plan was amended and operates, in relevant part, as a nonleveraged employee stock ownership plan ("ESOP") and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 as amended (the "IRC"), and is subject to the applicable provisions of the Employment Retirement Income Security Act of 1974 ("ERISA").

The Plan purchased Company common stock using employer contributions and held the stock in a trust established under the Plan.

On December 31, 2020, an amendment was adopted to terminate the Plan. As a result of the decision to terminate the Plan, all participants who had not incurred a forfeiture as of January 1, 2020, became 100% vested. Partial distribution occurred during 2021 through 2022. The remaining account balances are expected to be distributed in 2025.

#### **Eligibility**

Prior to plan termination, employees of the Company and its participating subsidiaries became eligible to participate in the Plan upon completion of twelve months of service as of the beginning of the next Plan year. Participants must work a minimum of 1,000 hours and be employed on the last working day of the year to be eligible for an allocation of Company contributions for that year.

#### **Contributions**

Contributions may be paid in cash or shares of Company stock as the Company's Board of Directors may from time to time determine in their discretion. Shares of Company stock will be valued at their then fair market value. Employee contributions are not permitted.

#### **Vesting**

As a result of the decision to terminate the Plan, all participants who had not incurred a forfeiture as of January 1, 2020 became 100% vested.

#### **Payment of Benefits**

Upon retirement, termination, death, or permanent disability, a participant receives a lump-sum or annuity amount equal to the value of his or her vested account balance. The non-vested portion of their account is forfeited.

Distributions pursuant to the Plan termination will be paid at the participants' election by a combination of cash distribution paid directly to participants, rollover to an IRA, or rollover distribution to the LaBella Associates Profit Sharing/401(k) Plan. Effective December 31, 2021, Chazen Companies 401(k) Plan merged into LaBella Associates Profit Sharing/401(k) Plan. Distributions of the participant's account balances made during 2024 and 2023 totaled \$0 and \$0, respectively. Remaining account balances are expected to be distributed in 2025.

#### **Participant Accounts**

Each participant's account is credited with the allocation of the Company's contributions and Plan earnings or losses and charged with an allocation of administrative expenses that are paid by the Plan. Allocations may be charged based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Participant Accounts and Forfeitures**

Company contributions and Plan forfeitures are allocated to each participant's account based upon the ratio of the participant's eligible compensation to total eligible compensation for the Plan year. There were no accumulated forfeitures at December 31, 2024 or 2023 or forfeitures reallocated to eligible participants during the years ended December 31, 2024 or 2023.

#### **Administration**

All administrative expenses of maintaining the Plan are paid by the Company unless paid by the Plan.

### 2. Summary of Significant Accounting Policies:

#### **Basis of Accounting**

Due to the decision to terminate the Plan as of December 31, 2020 and the subsequent liquidation plan, management determined that liquidation of the Plan is imminent and the financial statements for 2024 and 2023 have been prepared using the liquidation basis of accounting.

#### **Pervasiveness of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for pension benefits at the date of the financial statements and the actuarial present value of accumulated plan benefits as of the valuation date, and the changes in net assets available for benefits during the reporting period. Actual results may differ from those estimates.

#### **Employer Contributions**

Pursuant to the Plan agreement, the Company may elect to make contributions to the Plan on a yearly basis. There were no contributions made to the Plan for 2024 and 2023.

#### **Benefits**

Benefits are recorded when paid.

#### **Income Taxes**

The Internal Revenue Service has determined and informed the Company, by a letter dated June 15, 2015, that the Plan is qualified, and the trust established under the Plan is tax exempt, under the appropriate sections of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan and concluded that, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **Priorities Upon Termination**

The Company reserves the right to terminate the Plan at any time subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant, or his or her beneficiary, at the time prescribed by the Plan terms and the IRC. Upon termination of the Plan, the Board of Directors shall direct the trustees to make distributions to participants in accordance with the provisions of the Plan.

Effective December 31, 2020, there was an amendment adopted to terminate the Plan. Remaining account balances are expected to be distributed in 2025.

#### **Subsequent Events**

The date to which events occurring after December 31, 2024, the date of the most recent statement of net assets available for benefits, have been evaluated for possible adjustment to the financial statements or disclosure is September 10, 2025, which is the date on which the financial statements were available to be issued.

#### **Administration of Plan Assets and Related Party Transactions**

The Plan's assets are held by the trustees of the Plan. Company contributions are held and managed by the trustees, who invest cash received and make distributions to terminated participants. Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officer or employee receives compensation from the Plan.
