NOTE 1 - Description of the Plan

The following description of the Sodexo Management, Inc. Health and Welfare Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a complete description of the Plan's provisions.

The Plan and Trust were established January 1, 2003 to provide health and other benefits to eligible participants. The sponsoring employer, Sodexo Management, Inc., has agreed in writing to be bound by the terms and conditions of the Trust Agreement establishing the Plan. The Plan is an employee benefit plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan provides medical, dental, vision, prescription drug coverage, short-term disability benefits, life and accidental death and dismemberment, sick leave, health reimbursement arrangement (HRA), and severance benefits for eligible participants and their dependents. The Plan provides many of these benefits on a self-funded basis and contracts with third party insurance companies. The Plan also carries a stop-loss insurance policy, which covers both specific and aggregate claims in excess of the deductibles as specified in the contract.

Employees are eligible to participate in the Plan on the first month following one month of continuous employment. Participants will receive coverage for any month in which they remain eligible for the Plan and for which the Plan management makes contributions to the Plan on their behalf. The participants' coverage will end at midnight on the last day of the month in which eligibility ceases.

The Plan shall remain in existence from year-to-year unless written termination notice is given by the Plan Sponsor or Plan Administrator to the other at least 60 days, but not more than 90 days, prior to the anniversary date of effective coverage under this Plan.

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to employees, to discontinue its contributions at any time, and terminate the Plan subject to the provisions set forth in ERISA.

NOTE 2 - Summary of Significant Accounting Policies

Accounting Method

The accounts of the Plan are maintained on an accrual basis of accounting for financial reporting purposes.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, claims incurred but not reported, eligibility credits, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash and equivalents

Cash equivalents include money market funds used in general operations.

Concentration of credit risk for cash:

For business purposes, the Plan maintains cash balances at Partners Bank of California, which, from time to time, may exceed the \$250,000 insurance provided by the Federal Deposit Insurance Corporation. Amount in excess of the \$250,000 insurance limit as of December 31, 2024 and 2023 was \$9,056,472 and \$6,179,531 respectively. The Plan has not experienced any losses in such accounts. The Plan management does not believe the Plan is exposed to any significant credit risk on cash.

Employer Contributions Receivable

Employer contributions due but not paid at year-end are recorded as contributions receivable. An allowance for uncollectible accounts is considered unnecessary and is not provided.

Benefit Claims Payable

The obligation for benefit claims payable is an estimate for self-funded benefits incurred on or prior to December 31, but paid after December 31. The estimate was calculated based on a review of actual claims paid subsequent to year-end, with incurred and received dates of December 31, and prior.

Benefit Claims Incurred, But Not Reported

The obligation for benefit claims incurred, but not reported is an estimate for self-funded benefits incurred on or prior to December 31, but reported to and paid by the Plan after December 31. The estimate was calculated using available claims experience data and projected future claims.

Employer contributions are recognized as income in the month the employees worked. The Plan is financed by employer contributions and from participants electing Consolidated Omnibus Budget Reconciliation Act (COBRA) coverage.

Benefits

Benefits expense is recorded when paid. Hours worked through December provide participants with benefits eligibility through December. If an employee's eligibility ceases, the employee's coverage will end at midnight on the last day of the month in which eligibility ceases.

Health Reimbursement Arrangement (HRA)

The Plan provides limited vision HRA benefits to eligible participants to cover frames and prescription corrective lenses up to an annual maximum of \$150 per participant. At termination of employment any remaining balance will be forfeited. Included in the accompanying statement of net assets are amounts available to provided HRA benefits as of December 31, 2024 and 2023, totaling \$18,430 and \$23,664, respectively.

Dismissal Wage/Unemployment Benefits (DUB) & Severance Benefits

The Plan provides severance benefits to eligible participants upon an employee's involuntary severance of employment. Included in the accompanying statement of net assets is \$57,354 and \$127,854 available to provide severance benefits as of December 31, 2024 and 2023.

NOTE 3 - Excess Loss Indemnity Policy

Certain benefits may be provided under the terms of two separate Excess Loss Indemnity Policies written by Stonewater Underwriters, Inc. on behalf of Fidelity Security Life Insurance Company for policy period ending December 31, 2024 and 2023 respectively. The policies contain two excess loss provisions. The first of which applies to individual participant claims, whereby when the claims paid on behalf of an eligible participant or dependent exceeds \$150,000 in year 2024 and 2023, the insurance carrier will reimburse the plan for 100% of the excess. The second provision involves aggregate plan claims, whereby when the total aggregate claims paid on behalf of all eligible participants or dependents exceed a specified amount based on monthly aggregate rate factors, the insurance carrier will reimburse the Plan 100% of the excess up to a maximum aggregate amount of \$1,000,000, less the amount reimbursed for individuals under the specific individual policy noted above.

NOTE 4 - Income Taxes

The Trust established under the Plan to hold the Plan's assets has not applied for exemption from California or federal income taxes, and is currently subject to income tax on its net investment income. The Trustee believes that the Trust does not have any net taxable income for the tax years ended December 31, 2024 or 2023 and, therefore, no tax liability is reflected in these financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the Internal Revenue Service and California Franchise Tax Board. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - Party-In-Interest Transactions

FCE Benefit Administrators, Inc. received commissions and reimbursement of administrative fees from the Plan's insurance carriers of approximately \$107,416 and \$157,026 for December 31, 2024 and 2023, respectively. The insurance commissions and fees are paid by the insurance company and are not an expense of the Plan.
