## INDEPENDENT AUDITORS' REPORT

To the Plan Trustees of  
Jaros, Baum & Bolles Employees 401(k) Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Jaros, Baum & Bolles Employees 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

## NOTES TO FINANCIAL STATEMENTS

### Note 1 - Description of the Plan:

The following description of the Jaros, Baum & Bolles Employees 401(k) Savings Plan (the “Plan”) provides only general information and is presented to assist in understanding the Plan’s financial statements. The financial statements and notes are representations of the Plan’s management, which is responsible for their integrity and objectivity. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** - The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), covering all eligible employees of Jaros, Baum & Bolles Consulting Engineers LLP (the “Company” and “Plan Sponsor”) who have attained the age of twenty-one and have completed three months of service. Employees are eligible to participate on the first day of the month which coincides with or follows the date they satisfy the eligibility requirements. All employees the Company are eligible to participate except (1) union employees, (2) any employee who is nonresident alien with no U.S. source income, (3) any employee who is a leased employee, (4) any employee who is part-time/temporary/seasonal such as one who worked less than 1,000 hours of service in the relevant eligibility period, and (5) any employee who became an employee as a result of a “Code Section 410(b)(6)(C) transaction”.

The Plan was amended August 1, 2017 to allow MJT - ESC, LLC (“MJT”) to become a participating employer in the Plan. Any prior service time to the Company for applicable MJT employees is included as service time for Plan eligibility purposes. The employees of MJT follow the same plan document guidelines as employees of the Company.

**Plan Administration** - The Plan is administered by the Plan Sponsor. The Plan’s assets are held by State Street Bank and Trust Company (the “Trustee”), who is responsible for the custody and management of the Plan’s assets.

**Automatic Enrollment** - All eligible employees are automatically enrolled in the Plan upon meeting the eligibility requirements unless they elect to opt out of participation. Automatic enrollment sets pre-tax deferral contribution rate at 5% of an employee’s compensation in the absence of other employee elections. All eligible employees who are automatically enrolled in the Plan will receive an automatic increase in their deferral contribution rate of 1% of Plan Compensation, to a maximum of 10%, every year on the anniversary date of auto enrollment, unless the participant selects otherwise.

**Contributions** - Eligible participants may elect to contribute up to 99% of annual eligible compensation (pre-tax or Roth) within limits prescribed by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions during that year. Each plan year, the Company may make a discretionary employer matching contribution based on employee deferrals and/or a non-elective contribution based on compensation. Subsequent to year-end, the Company made a discretionary 12% matching contribution for the year ended December 31, 2024, in the amount of \$472,562, less forfeitures of \$50,000. There were no non-elective contributions for the year ended December 31, 2024.

**Vesting** - Participants are vested immediately in their own contributions and actual earnings thereon. Participants shall vest in any discretionary employer matching and non-elective contributions in accordance with the following vesting schedule:

**Participant Accounts** - Individual accounts are established for each plan participant. Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) Plan earnings/losses, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Payment of Benefits** - On termination of service due to death, disability or retirement, a participant or in the case of death the designated beneficiary, may elect to receive an amount equal to the value of the participant's vested interest in their account in either a lump-sum, or in annual installments over a period of not more than their assumed life expectancy or the assumed life expectancy of their beneficiary. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If death occurs prior to retirement, the participant's account is paid to the designated beneficiary.

**Forfeitures** - Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures can be used to reduce employer contributions or they can be used to offset the Plan's administration expenses. Forfeitures can also be allocated to participants' accounts. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$55,289 and \$12,837, respectively. Forfeitures used to reduce employer contributions totaled \$50,000 for the year ended December 31, 2024.

### **Note 2 - Summary of Significant Accounting Policies:**

**Basis of Accounting** - The accompanying financial statements are prepared on the accrual basis of accounting.

Investment contracts held by defined-contribution plans are required to be reported at fair value except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transaction under the terms of the Plan.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Company to make estimates and assumptions that affect certain reported amounts of assets, and liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions in the Statement of Changes in Net Assets Available for Benefits during the reporting period. Accordingly, actual results as determined at a later date, may differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value (except for fully benefit-responsive group annuity contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Cash and Equivalents** - Cash and equivalents include a money market account with a maturity of three months or less.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, withdrawals, recordkeeping fees, and investment advisory fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Payment of Benefits** - Benefits are recorded when paid.

**Hardship Withdrawals** - The Plan provides for hardship withdrawals from participants' vested balances, not to exceed an amount required to meet an immediate need created by hardship, and then only to the extent that such immediate need cannot be satisfied by other sources reasonably available to the participant. Permissible circumstances for hardship withdrawals include medical expenses, purchase of a home, tuition payments, amounts necessary to prevent eviction from the participants' personal residence, and such other circumstances as the Plan Administrator may determine in accordance with Internal Revenue Service ("IRS") rules and regulations.

**Subsequent Events** - The Plan Administrator has reviewed and evaluated all events and transactions from December 31, 2024, through September 24, 2025, the date the financial statements were available to be issued. The effect of those events and transactions that provide additional pertinent information about conditions that existed at the Statements of Net Assets Available for Benefits date have been recognized in the accompanying financial statements.

#### **Note 3 - Certified Investment Information:**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, the Trustee, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- a) Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.

- b) Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- c) Investment information included in the Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule of assets (held at end of year).

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of year).

### Note 4 - Fair Value Measurements:

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued at the closing price in the active market in which the fund is traded.
- *Cash and equivalents*: Valued at the closing price in a similar market in which the fund is traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Transfers Between Levels**

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in the economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2, and 3.

**Note 5 - Group Annuity Contract:**

The Plan holds a traditional investment contract with New York Life ("NYL"). The contract, referred to as a group annuity contract, meets the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated by the insurance company before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the Trust to be tax-exempt under Section 501(a) of the IRC.
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events that allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer.

#### **Note 6 - Risks and Uncertainties and Concentration of Investment Risk:**

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the financial statements.

The Plan may invest in a trust that holds securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage backed securities, including securities backed by sub-prime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

The Plan's investment in two funds comprises approximately 30% and 31% of total investments at December 31, 2024 and 2023, respectively.

#### **Note 7 - Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan's provisions to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants' contributions remain fully vested and Company contributions become fully vested. Under no circumstances may the Company take ownership of any of the Plan's assets as a result of such termination.

#### **Note 8 - Notes Receivable from Participants:**

Participants may obtain loans from the Plan from a minimum of \$500 up to 50% of their vested account balance or a maximum of \$50,000, whichever is less. Loans bear an interest rate based on the prime rate plus 1% and are collateralized by a participant's account balance. Loans are generally payable through payroll deductions within five years, from the date granted unless it is for the purchase of a principal residence.

#### **Note 9 - Tax Status:**

The Plan was written on an IRS non-standardized pre-approved document, which obtained its latest opinion letter on June 30, 2020 in which the IRS stated that the Plan as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

#### **Note 10 - Party-in-Interest:**

The Trustee of the Plan's assets holds the Plan's investments, which include various mutual funds. No fees were paid to the Trustee by the Plan for the year ended December 31, 2024. Transamerica Retirement Solutions ("TRS") is the recordkeeper and provides administrative services to the Plan and, therefore, these transactions qualify as a party-in-interest. The fees paid by the Plan to TRS were \$84,066 for the year ended December 31, 2024. Investment advisory service fees paid by the Plan to Morgan Stanley Smith Barney LLC totaled \$80,000 for the year ended December 31, 2024.
