## INDEPENDENT AUDITORS' REPORT

To the Participants and Retirement Investment Committee  
Lifelong Learner Holdings 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Lifelong Learner Holdings 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the financial statements section of our report. ## 1. DESCRIPTION OF PLAN:

The following description of the Lifelong Learner Holdings 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan covering all employees, with certain exclusions, as defined, of Lifelong Learner Holdings, LLC and any related companies that have adopted the Plan (collectively, the Employer) who have been employed 30 days (or have completed 1,000 hours of credited service if part-time, temporary, or seasonal) and are age 18 or older. Employees may enter the Plan monthly after meeting eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective March 11, 2024, the Plan was amended, and certain participating employers were removed as participating employers. Participant account balances totaling approximately \$30,334,862 were transferred out of this Plan to the PSI 401(k) Plan in July 2024 for participants related to these employers.

### Contributions

Participants may contribute up to 90% of their annual eligible compensation, as defined by the Plan. Participants are permitted to make elective Roth contributions to the Plan and participants may also make rollover contributions representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 are eligible to make catch-up contributions. Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code (IRC), as defined by the Plan agreement.

The Employer elected to apply the safe harbor provisions and made Employer safe harbor matching contributions equal to 100% of the first 3%, and 50% of the next 2% of eligible compensation deferred by the participant. The Plan also provides for an annual discretionary Employer profit sharing contribution to eligible employees, as defined by the Plan document. The Employer did not make an additional discretionary profit sharing contribution for 2024 or 2023. A participant is eligible for discretionary Employer profit sharing contributions upon completing 12 months of service, as defined, and will receive an allocation if employed on the last day of the plan year.

### Participant accounts

Each participant's account is credited with the participant's contributions, Employer contributions, and earnings and losses thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan's investments are participant-directed.

### Vesting

Participants are immediately vested in their elective contributions and Employer safe harbor matching contributions plus actual earnings thereon. Vesting in other Employer contributions is based on years of service, where a year is defined as one in which an employee works 1,000 or more hours. Participants are 20% vested after 1 year of service, 40% vested after 2 years of service, 60% vested after 3 years of service, 80% vested after 4 years of service, and are fully vested after 5 years of service in any discretionary Employer profit sharing contribution.

**Participant notes receivable**

Participant notes receivable are permitted under certain circumstances and are subject to limitations. Participants may borrow from their funds up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Notes are repaid over a period not to exceed 5 years with exceptions for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest rates as determined reasonable by the plan administrator. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits**

On termination of service, disability or retirement, a participant or his or her beneficiary will receive a lump-sum distribution equal to the value of his or her account, partial payments, or installment payments over a certain period. Normal retirement age is age 65; however, the Plan also provides for early payment of benefit after reaching age 59 ½. The nonvested portion of the account is treated as a forfeiture. Hardship withdrawals are permitted in accordance with the Internal Revenue Service (IRS) guidelines.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

**Basis of accounting**

The Plan's transactions are reported on the accrual basis of accounting.

**Use of estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

**Investment valuation and income recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest and dividend income are recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Participant notes receivable**

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Upon default (as defined), the plan administrator treats the default as a distribution and offsets the outstanding balance of the note against the participant's vested account balance. No allowance for credit losses has been recorded at December 31, 2024 or 2023.

**Payment of benefits**

Benefits are recorded when paid.

### **Administrative expenses**

Certain expenses incurred in the administration of the Plan are paid by the Employer and are excluded from these financial statements. Investment related fees are included in net appreciation in fair value of investments. Fees related to participant directed transactions are charged directly to the participant's account and are included in administrative expenses. Certain expenses are paid through revenue sharing rather than direct payment. During the years ended December 31, 2024 and 2023, administrative expenses were paid through revenue sharing rather than direct payment in the amount of \$45,417 and \$53,334, respectively.

### **Subsequent events**

The Plan evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The Plan has evaluated subsequent events through September 4, 2025, the date that the financial statements were available to be issued.

### **3. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE:**

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company (Fidelity), the trustee, has certified to the completeness and accuracy of all investments and participant notes receivable reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the supplemental schedule of assets (held at end of year) as of December 31, 2024 and the related investment activity and interest income on participant notes receivable reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

### **4. FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in the active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurements level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methods used for assets measured at fair value. There have been no change in methodologies used at December 31, 2024 or 2023.

- Mutual funds: The fair value of these securities is based on the net asset value (NAV) of shares held by the plan at year end which is based on observable market quotations for identical assets and are priced on a daily basis at the close of business.
- Interest-bearing cash: The carrying value approximates fair value.
- Common collective trust: Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level or any input that is significant to the fair value measurement.

**5. FORFEITED ACCOUNTS:**

Forfeited nonvested accounts totaled \$10,657 and \$11,936 as of December 31, 2024 and 2023, respectively. Forfeited nonvested accounts shall be used to reduce future Employer contributions or pay Plan expenses. No forfeitures were used to reduce Employer contributions or pay Plan expenses during the years ended December 31, 2024 or 2023.

**6. PARTY-IN-INTEREST TRANSACTIONS:**

Certain Plan investments are managed by Fidelity, the trustee, as defined by the Plan, and, therefore, these transactions and related fees paid to the trustee qualify as party-in-interest transactions to the Plan.

**7. PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in Employer contributions.

**8. RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts and the amounts reported in the statement of net assets available for benefits.

**9. TAX STATUS:**

The Employer adopted a non-standardized pre-approved profit-sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the IRS dated June 30, 2020. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has since been amended. While the Employer has not obtained its own determination letter on the Plan, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.
