## Independent Auditors' Report

To the Trustees

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the financial statements of Comtrix Solutions Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**Note 1 - Description of Plan**

The following description of Comtrix Solutions Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. Copies of this booklet are available from the Company.

General – The Plan is a defined contribution plan sponsored by the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees, other than certain excluded employees (union employees, nonresident aliens, and leased employees), are eligible to become participants in the Plan on the first day of the month in concurrent with or following three months of employment.

Investments – The investments of the Plan are held by Reliance Trust Company. (the Custodian), who maintains the investments in various mutual funds and common collective trusts. Participants direct the investments in their accounts into the various investment options offered by the Plan. The maximum loss, if any, that would be incurred by the Plan if the counterparties to the Plan’s investments failed to perform is the recorded amount of such investments.

Plan Contributions - Participants may elect to contribute a percentage of their annual compensation or a fixed amount per pay period, on a pre-tax or after-tax basis, as a salary deferral. These deferrals are subject to the annual limitations defined in the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified retirement plans or individual retirement accounts.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4 percent of eligible compensation, and their contributions invested in a designated fund selected by the plan administrator until changed by the participant.

The Company will make a safe harbor matching contribution to all participants based on the following tiers of salary deferrals: 100% of salary deferrals up to the first 4% of Plan compensation, as defined.

Cash contributions receivable, if any, are unsecured.

Participant Accounts – Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options – Participants direct the investment of their contributions into various investment options, the majority of which are mutual funds seeking long-term capital growth and capital appreciation, along with both international and domestic stocks and securities. Generally, the Plan’s investments are collateralized by the proportionate share of the respective fund’s underlying net assets. The maximum loss, if any, which would be incurred by the Plan if the counterparties to the Plan’s investments failed to perform and any collateral was insufficient is the recorded amount of such investments.

Vesting - Vesting is the portion of the participant’s account that cannot be forfeited. Participants are immediately vested in employer safe harbor matching and participant contributions, including earnings thereon. Vesting in the Plan Sponsor’s discretionary profit-sharing contribution portion of each participant’s account is immediate, and all participants become fully vested in the Plan Sponsor’s contributions as follows:

Notes Receivable from Participants – Subject to approval by the Plan administrator, participants may borrow part of the value of their before-tax contributions the Plan. The amount must be at least \$1,000 and not more than the lesser of one-half of the borrower’s invested individual account balance of \$50,000. The loan is fully secured by the participants’ account. The loans are required to bear interest and be repaid over periods not exceeding five years.

Participant notes receivable are measured at unpaid principal balance plus any accrued unpaid interest.

Upon default of participant notes receivable, the entire outstanding principal and interest shall be immediately due and payable. If a distributable event, as defined by the IRC, has occurred, the note receivable will be foreclosed on and be offset against the participant’s account balance. If a participant’s note receivable is in default, the participant shall be treated as having a taxable deemed distribution whether or not a distribution event has occurred.

Payment of Benefits - On termination of service due to death, disability or retirement, a participant (or a participant’s beneficiary in the event of the death of a participant) may elect to receive either a lump sum amount equal to the value of the participant’s vested interest in his or her account, or installment payments. For termination of service due to other reasons, a participant may receive the value of vested interest in his or her account as a lump sum distribution, or installment payments. In-service distributions from a participant’s vested account balance may be made provided the participant has reached the age of 59½, has incurred a plan-defined hardship, or has become disabled.

Forfeited Accounts - Forfeitures of terminated participants’ non-vested accounts can be used to reduce future Plan Sponsor contributions or pay certain Plan administrative expenses. If a terminated employee is rehired by the Plan Sponsor, then the participant may be entitled to a restoration of certain amounts forfeited, based on provisions in the Plan document. There were no forfeitures available as of December 31, 2024.

Administrative Expenses – Certain fees for legal, accounting and other administrative fees are paid by the Plan sponsor.

**Note 2 – Summary of Significant Accounting Policies**

Basis of Accounting – The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United State of America (U.S. GAAP). Annual returns filed under applicable provisions of ERISA and the IRC are filed on the modified cash basis of accounting.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation or depreciation in the fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

Benefit Payments – Participant contributions are recorded in the period the Company makes payroll deductions from the Plan participants’ earnings. Receivables for these contributions are unsecured. Benefit payments are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses paid by the Plan Sponsor are excluded from these financial statements. Certain investment related expenses are included in net realized and unrealized appreciation in the fair value of investments.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Note 3 – Investments Held by Custodian (Unaudited)**

The plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by The Trust Company of Tennessee, Inc. and was not subjected to any auditing procedures performed by the independent public accountants:

- a. Total investments as shown in the accompanying statements of net assets available for benefits of \$1,100,846 and 212,382 as of December 31, 2024 and 2023, respectfully.
- b. Net investment earnings as shown in the accompanying statement of changes in net assets available for benefits of \$65,900 and \$14,332 for the year ended December 31, 2024 and 2023, respectfully.
- c. All investment-related information in the accompanying supplemental Schedule H, Line 4i — Schedule of Assets (Held at End of Year) as of December 31, 2024.

**Note 4 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 — Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Mutual funds.* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective investment trust:* All common/collective trusts, including the Federated Hermes Capital Preservation Fund, which primarily holds investments in fully benefit-responsive contracts, are valued at the net asset value of units of the common/collective trusts as determined by the issuer of the trust based on the fair values of the underlying net assets divided by the number of units outstanding.

The net asset value per unit is a quoted price in a market that is not active; therefore, these investments are classified within Level 2 of the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The following table sets forth by level, within the fair value hierarchy, the Plan’s investments at fair value as of December 31, 2024:

**Note 5 – Income Tax Status**

The Plan Sponsor adopted a prototype plan sponsored by The Trust Company of Tennessee, Inc., which received a favorable opinion letter from the Internal Revenue Service (“IRS”), which states the prototype plan is designed in accordance with applicable requirements of the IRC, and is, therefore, not subject to tax under present income tax law.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax years in progress.

**Note 6 – Termination of the Plan**

The Company has reserved the right to terminate the Plan or reduce or cease contributions at the discretion of the board of directors or to amend the Plan at any time and in any respect. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

**Note 7 – Risks and Uncertainties**

The Plan investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with its investment, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

**Note 8 – Other Related Party Transactions and Party-In-interest Transactions**

Certain Plan investments are held and managed by the Custodian; therefore, these transactions qualify as party-in-interest transactions. Also, certain fees paid by the Plan qualify as party-in-interest transactions. Related party transactions include contributions from the Plan Sponsor.

**Note 9 – Reconciliation of Financial Statements to Form 5500**

There are no reconciling items between the financial statements and Form 5500 filed with the Department of Labor.

**Note 10 – Subsequent Events**

Subsequent events were evaluated through September 29, 2025, which is the date the financial statements were available to be issued.
