Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Dataminr, Inc. 401 (k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Dataminr, Inc. 401 (k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Dataminr, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a 401(k) Profit Sharing Plan which was established on January 1, 2014. The Plan has been amended and restated throughout the years, and was most recently amended and restated on November 7, 2024, to change the Plan’s address.

On January 1, 2024, the Plan was amended and restated to reduce the employer’s match formula from 50% to 40% of the first 6% of eligible compensation of deferring participants.

On December 5, 2023, the Plan changed its trustee from Reliance Trust Company to ADP Retirement Trust Services. In conjunction with the change in its trustee, approximately \$49,307,000 of the Plan’s assets were transferred into a new trust account.

On December 29, 2022, President Biden signed the Consolidated Appropriations Act of 2023 into law, which includes the package of retirement provisions referred to as “SECURE 2.0”. These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system, finding ways for them to accumulate more assets and ensuring they get connected with those assets when retirement occurs. Most of the provisions of SECURE 2.0 will continue to become effective going forward, and will require significant changes to the Plan’s administration and recordkeeping, however, there has been no significant impact to the Plan, to-date.

The Plan provides retirement benefits for employees of Dataminr, Inc. (the “Company”) who have reached the age of 21 and meet the two (2) months of service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute between 1% and 90% of eligible earnings, as defined in the Plan. Roth elective deferrals are permitted under the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers).

The Plan includes an auto enrollment provision for all newly eligible employees to automatically enroll in the Plan, unless they elect not to participate, with a default rate set at 6% of eligible compensation each payroll period. The Plan allows for employer matching contributions equal to 40% of the first 6% of eligible compensation of deferring participants and a one (1) year service requirement to be 100% vested in the employer matching contributions. The Company may make nonelective contributions to the Plan, although the Company is not required to do so. During 2024, the Company did not make nonelective contributions to the Plan. All contributions are subject to certain limitations imposed by the Plan and the Internal Revenue Code (the “Code”).

Participant Accounts

Each participant's account is credited with the participant's contributions, Company's contributions and allocations of the Plan's earnings and charged with an allocation of administrative expenses. Allocations of administrative expenses are based on the participant's compensation or account balance, as defined in the Plan document. The benefit to which a participant is entitled to is equal to the benefit that can be provided from the participant's vested account.

Investment Options

Participants may direct their contributions into any of the funds offered by the Plan which were held at ADP Retirement Trust Services from January 1, 2024 to December 31, 2024. These funds include a variety of investment options with various objectives and degrees of financial risk.

Vesting

Participants are immediately vested in their elective deferral and rollover contributions, including the earnings on these amounts. Vesting in the Company's contributions portion of their accounts is based on years of continuous service. Effective January 1, 2019, participants are fully vested in matching contributions upon the completion of one (1) year of service. Participants are fully vested in nonelective Company's contributions upon the completion of six (6) or more years of service based upon a graded vesting schedule. Participants are also fully vested upon reaching their normal retirement date, death, or total disability.

Forfeited Accounts

If participants terminated their employment before they became fully vested in Plan benefits, they would have been entitled to receive a distribution of their vested benefits. The non-vested benefits would be forfeited. The forfeited amounts are used to defray reasonable administrative expenses or to offset employer contributions under the Plan for the Plan Year in which the forfeiture occurs. As of December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$36,229 and \$35,321, respectively, including stale checks of \$36,216 and \$34,124, respectively.

Notes Receivable from Participants

Participants may borrow a minimum of \$500 up to 50% of their vested account balance up to a maximum of \$50,000 from their accounts. The participants may only have one (1) loan outstanding at any given time. Loan terms range from one to five years, except for loans to purchase a primary residence, which may be offered over a term of up to thirty years. The participant's notes receivable are secured by the balance in the participant's account and bear interest in effect in the month the loan is effective. The interest rate is the Prime Rate plus 1%. Principal and interest are paid ratably through payroll deductions. Participant notes receivables are measured at the unpaid principal plus accrued interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. At December 31, 2024 and 2023, Notes Receivable from Participants amounted to \$308,807 and \$371,946, respectively, and bore an interest rate ranging from 5.25% to 10.50%.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, annual installments, or partial withdrawals of at least \$500. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

The Plan also provides for in-service distributions by participants who have attained the age of 59½. Upon financial hardship, a participant is entitled to the value of his or her deferral as well as any vested matching contributions or nonelective contributions.

Rollover Contributions

Contributions from a qualified retirement plan established by a new participant's previous employer may be "rolled over" into the Plan. Rollover contributions amounted to \$1,270,260 for the year ended December 31, 2024.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles ("GAAP") in the United States of America requires management of the Plan to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received in exchange for the sale of an asset or to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Payment of Benefits

Benefits to participants are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are therefore, excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses.

NOTE 3 – CERTIFICATION BY THE INVESTMENT TRUSTEES

The information related to investments and notes receivable from participants disclosed in the accompanying financial statements and schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied by the Plan Administrator and certified as complete and accurate by ADP Retirement Trust Services, the trustee of the Plan, as permitted by the election made by the Plan Administrator under 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 – FAIR VALUE MEASUREMENTS

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none">• Quoted prices for similar assets or liabilities in active markets;• Quoted prices for identical or similar assets or liabilities in inactive markets;• Inputs other than quoted prices that are observable for the asset or liability; and• Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used, need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a

Mutual Funds

Mutual Funds are valued at fair value based on quoted net asset values of the shares, as reported by the fund. Mutual funds held by the Plan are mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ADP Retirement Trust Services is the recordkeeper of the Plan. Recordkeeping fees paid during the year for administrative services were based on reasonable rates for such services. The recordkeeping fees amounted to \$19,143 and are included in Administrative Expenses in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Certain employees of the Company who participate in the Plan perform administrative services to the Plan at no cost to the Plan.

NOTE 6 – TAX STATUS

The IRS has determined and informed the Plan sponsor by a letter dated July 8, 2014, that the Plan and related Trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. These investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits. The current economic environment has increased the degree of uncertainty.

The Plan’s investment options which accounted for more than 10% of the Plan’s total net assets available for benefits as of December 31, are, as follows:

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
