Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of Neighborhood Assistance 401(k) Profit Sharing Plan & Trust (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered Neighborhood Assistance 401(k) Profit Sharing Plan & Trust’s internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing our opinion on the effectiveness of the Plan’s internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan’s internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Reliance Trust Company that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraph and was not designed to identify all deficiencies in internal control that might be significant deficiencies or material weaknesses and therefore there can be no assurance that all such deficiencies have been identified. However, as discussed below, we identified certain deficiencies in internal control that we consider to be significant deficiencies

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct misstatements on a timely basis. A material weakness is a deficiency, or combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the plan’s financial statements will not be prevented, or detected and corrected on a timely basis. We did not identify any deficiencies in internal control that we consider to be a material weakness.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiency in Neighborhood Assistance 401(k) Profit Sharing Plan & Trust’s internal control to be a significant deficiency:

Current plan personnel do not have the necessary specialized industry expertise to prepare employee benefit plan financial statements in accordance with generally accepted accounting principles. As the plan auditor, we obtained the relevant information from the third-party recordkeeper, proposed all necessary adjusting journal entries, and prepared the financial statements, footnotes and supplemental schedules required to enable the disclosures to be in accordance with generally accepted accounting principles. This lack of specialized industry expertise could result in a misstatement of the financial statements that would not be detected by management.

We have attached a management letter containing comments, observations, and recommendations on internal controls, procedures and other matters which came to our attention during the audit of the Neighborhood Assistance 401(k) Profit Sharing Plan & Trust. These comments, observations, and recommendations are not considered to be material weaknesses or significant deficiencies but are areas in which the Plan can improve its operations and procedures in a cost-effective manner. Before deciding on a course of action based on our comments, you may wish to assess the expected benefits and related costs of our suggestions. We would be glad to clarify any of our comments noted on this attachment and noted above or discuss with you how we can provide further assistance.

We make these comments to encourage management's continuing efforts to develop and strengthen the internal control systems and procedures, and to ensure compliance with all ERISA and DOL regulatory requirements. These are not material weaknesses or significant deficiencies, but recommendations we felt were important enough to bring to your attention.

UNCLAIMED PROPERTY:

Issue:

The Plan has an "Unclaimed Property" account that had \$2,823 in it as of December 31, 2024. We have been told that this balance represents distribution checks from prior years that were never cashed.

Recommendation:

We recommend that an effort be made to contact the owners of these funds and if those efforts continue to be unsuccessful that these funds be turned over to the Massachusetts Unclaimed Property Division where they can be held for their rightful owners.
