## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Worldwide Oilfield Machine, Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Worldwide Oilfield Machine, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### Opinion

**NOTE 1 — DESCRIPTION OF PLAN**

The following description of the Worldwide Oilfield Machine, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of Worldwide Oilfield Machine, Inc. and Total Frac Solutions, Inc. (together referred to as the Company). All employees of the Company, excluding union and leased employees and nonresident aliens, are eligible to participate in the Plan provided they have two months of service and have attained age 21. Employees may enter the Plan on the first day of each month after meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Newport Group, Inc. was the recordkeeper and Ascensus, LLC was the custodian and served as trustee through February 23, 2024. Effective February 23, 2024, Automatic Data Processing ("ADP") Retirement Services began providing recordkeeping services to the Plan and ADP Retirement Trust Services, LLC ("ADPRTS") became the custodian of the Plan's investments and serves as trustee. The Company is the plan administrator and has overall responsibility for the operation and administration of the Plan. The plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Throughout the year, employees may be transferred to various positions within the Company, which may result in a transfer between various retirement plans sponsored by the Company. Transfers between various Company retirement plans may also occur as Plan amendments are adopted to permit additional or restrict existing groups of Company employees participating in the Plan.

Effective February 1, 2024, the plan document was restated in its entirety due to the change in service providers described above. There were no significant changes to the provisions of the Plan.

**Contributions**

Participants may contribute up to 90% of annual eligible compensation, as defined in the Plan, and designate those contributions as either pre-tax or Roth. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). In addition, participants are permitted to transfer the vested portion of their accounts to an in-plan Roth transfer account subject to the Plan's provisions.

The Plan provides a discretionary matching contribution which is determined as a percentage of participant elected deferrals. For the year ended December 31, 2024, the Company made a matching contribution equal to 50% of employee deferrals up to 6% of eligible compensation.

The Plan provides a discretionary profit sharing contribution in an amount determined annually by the Company. Profit sharing contributions are allocated to each participant based upon the ratio of the participant's compensation to the total compensation for the Company. There were no profit sharing contributions for the year ended December 31, 2024.

**Contributions (Continued)**

Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants elect investment accounts in which their contributions, as well as Company contributions, are invested. The investment account options comprise various degrees of risk and return.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and Company matching contributions, an allocation of the Company's profit sharing contribution, and investment earnings based on their selected investments. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to \$50,000 or 50% of the participant's vested account balance, whichever is less. The loans are secured by the balance in the participant's account. A participant may have up to two loans outstanding at one time. The loan interest rate is set at 1% above the prime rate that was effective at the time the loan was issued, as defined. Principal and interest is paid ratably through monthly payroll deductions.

**Vesting**

Participants are vested immediately in their contributions plus earnings thereon. Vesting in the Company's matching and profit sharing contribution portions of their accounts is based on years of service. After two years of service, a participant becomes 33% vested in Company contributions in the Plan. After three years of service, a participant becomes 66% vested in Company contributions in the Plan. A participant is 100% vested after four years of credited service, upon death, becoming disabled, or reaching normal retirement age of 65.

**Payment of Benefits**

On termination of service, death, disability or retirement, participants may elect to receive an amount equal to the value of the vested interest in their accounts in either a lump sum amount or in installments, depending on the size of the participant's account balance at the time of termination. The account of a participant with a vested account balance of less than \$7,000 who does not request a distribution will be rolled to an individual retirement account in the participant's name.

The Company may authorize certain withdrawals from a participant's account in the event of proven financial hardship. Hardship withdrawals must be a minimum of \$500, are allowed from all vested accounts and are subject to specific statutory and regulatory requirements.

In-service distributions must be a minimum of \$500 and are permitted from all vested accounts when a participant has attained age 59½.

**Forfeitures**

Forfeited nonvested accounts may be used to pay plan expenses or reduce Company contributions. For the year ended December 31, 2024, \$89,145 of forfeitures were used to reduce Company contributions. Unallocated forfeitures were \$137,355 and \$114,767 at December 31, 2024 and 2023, respectively.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is valued at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred.

**Excess Contributions Payable and Corrective Contribution Receivable**

The Company identified certain operational errors related to the definition of compensation and deferral rate authorization changes. As a result, the Company recorded an employer corrective contribution receivable on the statement of net assets available for benefits at December 31, 2024, which includes a qualified nonelective contribution and the associated matching contribution in the amount of \$53,011 and \$33,509, respectively. The Company self-corrected the errors in 2025 by making corrective contributions to the affected participants' accounts for the missed deferrals and associated missed matching contributions plus lost earnings.

**Excess Contributions Payable and Corrective Contribution Receivable (Continued)**

Excess contributions payable are recorded for amounts refundable by the Plan to participants for contributions made in excess of amounts allowed by the IRS. The excess contributions related to 2022 were not refunded to participants within the time frame required by the IRS. As a result, the employer recorded an employer corrective contribution receivable on the statement of net assets available for benefits at December 31, 2023, in the amount of \$103,667. The excess contributions plus earnings were refunded to participants or forfeited, as applicable, in August 2024, and the corrective contribution was remitted to the Plan in September 2024.

**Contributions and Contributions Receivable**

Contributions from participants and the associated Company contributions are recorded in the year in which the employee contributions are withheld from compensation. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Plan expenses primarily consist of plan administration fees. Fees related to the administration of notes receivable from participants and benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

**Subsequent Events**

Subsequent events were evaluated through September 17, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 — INFORMATION CERTIFIED BY THE TRUSTEES**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, as authorized representative of Ascensus Trust Company and Newport Trust Company, LLC, through February 23, 2024 and by ADPRTS from February 23, 2024 through December 31, 2024.

**NOTE 4 — FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price reported by the fund, which is the quoted net asset value (NAV) of shares.

*Common/collective trust:* The stable value common/collective trust invests in a fund in which the underlying assets consist primarily of fully benefit-responsive investment contracts. The fund is valued at NAV, the practical expedient to estimate fair value. Participant transactions may occur daily.

**NOTE 5 — INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan had a traditional fully benefit-responsive guaranteed investment contract issued by Standard Insurance Company (Standard). Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$427,522 and \$478,558, respectively.

Effective February 24, 2024, the Company elected to terminate the contract with Standard. The funds in the general account are being liquidated in six book value installment payments over a five-year period. The fund guaranteed interest rate is 1% for the life of the installment payout, and the fund is closed to contributions.

**NOTE 6 — PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in Company contributions.

**NOTE 7 — PARTY-IN-INTEREST TRANSACTIONS**

The Newport Group, Inc. and ADP Retirement Services provide recordkeeping services to the Plan. Avidian Wealth Solutions LLC is the investment advisor of the Plan. Total fees paid from the Plan to these entities for the year ended December 31, 2024 were \$68,116. These transactions qualify as party-in-interest transactions.

**NOTE 8 — DEPARTMENT OF LABOR INVESTIGATION**

On September 25, 2023, the Company received a letter from the Department of Labor requesting information to review the Plan's activity for years beginning January 1, 2020 to the date of the letter for compliance with Title I of ERISA, which establishes standards governing the operation of employee benefit plans. The Company does not expect this investigation to have a negative impact on the Plan.

**NOTE 9 — TAX STATUS**

As this Plan is a pre-approved defined contribution plan, the IRS issued an opinion letter dated October 6, 2020, stating that while they do not issue a determination as to whether a specific employer's plan is qualified, any employer who adopts this plan document will be considered to have a plan qualified under code Section 401(a) of the Internal Revenue Code (IRC) provided all the terms are not more favorable for officers, owners, or highly compensated employees than for other employees. Management believes that the Plan is operating in compliance with all the terms provided in the nonstandardized plan agreement. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan is subject to examination by the IRS for the statutory period.

**NOTE 10 — RISKS AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 11 — DELINQUENT CONTRIBUTIONS**

During the year ended December 31, 2024, the Company failed to remit to the Plan’s custodian certain employee contributions and loan repayments totaling \$8,499. In addition, although remitted in 2024, the Company failed to remit to the Plan’s custodian certain employee contributions and loan repayments totaling \$58,074 within the period prescribed by the Department of Labor’s regulations.

During the year ended December 31, 2023, the Company failed to remit to the Plan’s custodian certain employee contributions and loan repayments totaling \$8,801. In addition, although remitted in 2023, the Company failed to remit to the Plan’s custodian certain employee contributions and loan repayments totaling \$203,113 within the period prescribed by the Department of Labor’s regulations.

During the year ended December 31, 2022, the Company failed to remit to the Plan’s custodian certain employee contributions and loan repayments totaling \$11,196. In addition, although remitted in 2022, the Company failed to remit to the Plan’s custodian certain employee contributions and loan repayments totaling \$346,753 within the period prescribed by the Department of Labor’s regulations.

During the year ended December 31, 2021, the Company failed to remit to the Plan’s custodian certain employee contributions and loan repayments totaling \$1,181. In addition, although remitted in 2021, the Company failed to remit to the Plan’s custodian certain employee contributions and loan repayments totaling \$27,273 within the period prescribed by the Department of Labor’s regulations.

The Company self-corrected all prohibited transactions described above between March 2025 and August 2025 by making contributions to the affected participants’ accounts, or refunding loan repayments if applicable, for the missed employee contributions and loan repayments and restoring the affected participants for potential lost income in the amount of \$7,189.
