Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Carpenter Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Carpenter Group 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Carpenter Group 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Carpenter Group 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an Auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. NOTE 1. DESCRIPTION OF PLAN

The following description of The Carpenter Group 401(k) Plan (the "Plan"), formerly know as The Carpenter Group Profit Sharing Plan, provides only general information. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions. As noted below, the Plan was amended and restated, effective September 1, 2024, to adopt a proto-type plan with provisions to convert from a non-contributory profit sharing plan to a contributory 401(k) Plan. Also, as part of the amendment, the Plan's name changed from The Carpenter Group Profit Sharing Plan to The Carpenter Group 401(k) Plan.

General

The Plan is a defined contribution plan which covers all full-time employees of The Carpenter Group (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Union employees and non-legal U.S. residents are excluded from participation in the Plan unless such agreement expressly provides for participation in the Plan.

Effective September 1, 2024, the Plan was amended and restated. This amendment and restatement was adopted to provide employees the opportunity to save for retirement on a tax-advantaged basis through a contributory 401(k) plan arrangement. A key feature of the new plan provisions is the opportunity for participants to make elective deferral contributions. Under the former plan, participants were not allowed to make elective deferral contributions.

Under the new plan agreement, participants may also benefit from discretionary employer matching contributions as well as rollover contributions

Eligibility

Prior to September 1, 2024, employees became eligible at age twenty-one (21) and after completing 1,000 hours of service or more within a 12-month period. For the purpose of receiving a profit-sharing contribution, the entry date was semi-annually starting on the January 1st or the same day of the month occurring in each successive 6-month period, coinciding with or next following the date the eligibility requirements were satisfied.

Effective September 1, 2024, employees become eligible to participate at age 18 and after completing 3 months of employment. The entry date is the first day of the month coinciding with or next following the date when eligibility requirements are met. The entry date will be the same for all contributions.

Contributions

Prior to September 1, 2024, the Company made discretionary contributions to the profit-sharing plan. The employer profit-sharing contribution was allocated to each participant based on a two-tiered allocation formula based on compensation and a fixed compensation level (the Plan's integration level). The first tier was an allocation pro-rata of compensation up to 4.7%. Any remaining profit-sharing contributions after the first-tier allocation was allocated pro-rata based on compensation above the integration level up to the same percentage. Rollover contributions were not permitted by the former profit-sharing plan.

Notes to Financial Statements

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Contributions

Effective September 1, 2024, eligible employees (“participants”) may contribute from 1% up to 90% of their annual compensation subject to certain limitations as defined by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Automatic enrollment is implemented with an initial 3% of compensation per payroll for new participants. The automatic deferral increases by 1%, up to a maximum of 10%, on the first day of each calendar year. The Company may make a discretionary matching contribution, each payroll period, equal to a uniform percentage or dollar amount of elective deferrals. For the year ended December 31, 2024, an employer matching contribution of \$15,122 was made.

Participant accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The allocation of the participant’s account balance to various investments offered by the Plan is entirely participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Vesting in the Company’s discretionary matching contributions portion of a participants account balance is based on years of continuous service. A year of service is obtained upon completion of a twelve-month period from the date of hire. A participant vests in the Company’s contributions at the rate of 20% per year beginning in year two and is 100% vested after six years of credited service.

Payment of benefits

Benefits are payable to participants or designated beneficiaries upon retirement, termination, death, disability, or in-service if the participant has attained age 59 ½. Distributions may be paid in a lump sum amount equal to the value of the participant’s vested interest in his or her account.

The Plan allows for automatic distribution of participant accounts that have a vested balance of \$5,000 or less on the date of separation.

Break in service

A participant will incur a break in service using the elapsed time method. Under this method, a break in service is generally defined as a period during which an employee is not employed by the employer, regardless of hours worked.

Administrative expenses

The Plan’s recordkeeper fees and all other administration costs are paid directly by the Plan.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Forfeitures

Forfeitures are created when participants terminate employment before becoming 100% vested in their account balance with respect to employer contributions. Forfeitures are held in a stable value fund until they are used to pay plan expenses or to offset employer contributions. For the year ended December 31, 2024, forfeitures in the amount of \$2,469 were used to fund the employer matching contribution.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting which is in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefit payments are recorded when paid.

Under the Plan, a participant reaches normal retirement at the later of age 65 or the fifth anniversary of participation in the Plan.

Subsequent events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of events that affect the financial statements. Management believes there are no subsequent events for recording or disclosure in the financial statements for the year ended December 31, 2024. Subsequent events were evaluated through September 4, 2025, which is the date the financial statements were available to be issued.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEES AND CUSTODIANS

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, City National Bank as of and for the years ended December 31, 2024 and 2023 and ADP Retirement Trust Services, LLC, from September 1, 2024 through December 31, 2024, the trustees and custodians of the Plan, have certified to the completeness and accuracy of:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and dividend income reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets held at December 31, 2024.

NOTE 4. FAIR VALUE MEASUREMENTS

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4. FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price, as reported by the fund. Funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common stock: Valued at the closing price reported on the active market on which the individual securities are traded.

Limited partnership interest: Valued at the NAV of interest in limited partnership. The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the investment would be sold for an amount different from the reported NAV. If the Plan initiates a full redemption of the limited partnership, the issuer reserves the right to temporarily delay withdrawal from the limited partnership in order to ensure that securities liquidations will be carried out in an orderly business manner.

Stable value fund: Valued at the NAV of the units of the stable value fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV. Participant transactions (purchase and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments for which the fair value is measured using the NAV at December 31, 2024 and 2023 includes an interest of \$1,432,992 and \$3,645,398 in a limited partnership and a stable value fund with a balance of \$21 and \$0, respectively.

The limited partnership is comprised of securities holdings with the objective to generate attractive rates of return. Investment income reported, for these holdings, in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 includes a gain of \$582,005.

The Plan may redeem up to 1/4 of its "Liquid Sub Capital Account" as of the last business day of each fiscal quarter, upon forty-five days' written notice to the general partner. If the Plan submits a redemption request in respect of its entire Liquid Sub Capital Account balance, such redemption request will be fulfilled as follows: (i) on the first permitted withdrawal date following receipt of such redemption request, 1/4 of the Plan's Liquid Sub Capital Account balance; (ii) on the second permitted withdrawal date following receipt of such redemption request, 1/3 of the Plan's Liquid Sub Capital Account balance; (iii) on the third Permitted Withdrawal Date following receipt of such redemption request, 1/2 of the Plan's Liquid Sub Capital Account balance; and (iv) on the fourth Permitted Withdrawal Date following receipt of such redemption request, 100% of the Plan's Liquid Sub Capital Account balance.

NOTE 5. PLAN TERMINATION

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contribution accounts.

NOTE 6. RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments are shares of mutual funds, common stock, a partnership interest, interest-bearing cash, and a stable value fund under the custody of City National Bank and ADP Retirement Trust Services, LLC, respectively, the trustee and custodians as defined by the Plan. Fees paid by the Plan for the custodial, investment management and recordkeeping services amounted to \$70,013. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

NOTE 8. INCOME TAX STATUS

The Plan document is an Automatic Data Processing (ADP) Prototype Non-standardized Pre-Approved Profit-Sharing Plan with an Internal Revenue Service (IRS) opinion letter dated October 6, 2020, in which the IRS stated that the Plan, as then designed, followed the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax exempt. The Plan's annual return/ report of employee benefit plan filings for the past three years are subject to examination by tax authorities and may change upon examination.
