## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants  
Fortress Biotech, Inc. 401(k) Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

**Note 1 - Description of the Plan:**

The following description of the Fortress Biotech, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- a. **General** - The Plan is a defined contribution plan covering all employees of Fortress Biotech, Inc. and the following related employers: Aevitas Therapeutics, Inc., Avenue Therapeutics, Inc., Cellvation, Inc., Cyprium Therapeutics, Inc., Helocyte, Inc., Journey Medical Corporation, Mustang Bio, Inc., Oncogenuity, Inc., and Urica Therapeutics, Inc., (collectively the "Employer" or "Company"), who are age eighteen or older and who are not covered by certain collective bargaining agreements, or who are co-op or temporary employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). All investments are participant-directed.
- b. **Contributions** - Participants may make contributions to the Plan based on a percentage of compensation up to the maximum percentage of compensation permitted by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and common/collective trust funds as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 4 percent of eligible compensation. Contributions are automatically invested in a designated balanced fund until changed by the participant. Employer contributions to the Plan are based on the Plan document and vary according to the group that the individual employee belongs to.
- c. **Participants' Accounts** - Participants' accounts are credited with their voluntary salary deferral contributions, the corresponding Company matching and safe harbor contributions, and an allocation of (a) the Company's discretionary profit sharing contribution, if any, and, (b) Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant compensation and on account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- d. **Vesting** - Participants of the Plan are immediately vested in their contributions plus actual earnings thereon.
- e. **Benefit Payments** - On termination of service due to death, disability, or retirement, participants may elect to receive either a lump-sum distribution or annual installments if the participant's account is greater than \$1,000.
- f. **Notes Receivable from Participants** - Under the terms of a loan provision, participants may borrow up to 50 percent of their vested account balance up to a maximum of \$50,000. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. Loan terms range up to five years, unless it is for the purchase of a primary residence, in which case it can be up to thirty years. The loans are secured by the balance in the participant's account and bear interest at rates varying from 5.25 to 10.50 percent. Principal and interest are paid ratably through payroll deductions.
- g. **Forfeited Accounts** - At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$-0-, respectively. At the option of the Company, forfeitures may be used to reduce future Company contributions to the Plan or for the payment of Plan administrative expenses. During the years ended December 31, 2024 and 2023, \$-0- of forfeitures were used to reduce employer contributions, respectively.
- h. **Plan Termination** - Although it has not expressed any intent to do so, the Company has the right under the plan agreement to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants shall become fully vested in their accounts at that date and the assets would be distributed to participants in accordance with the terms set forth in the Plan.

**Note 1 - Description of the Plan - Continued:**

- i. **Administrative Expenses** - Certain professional fees and other expenses relating to the operation and administration of the Plan are paid by the Company and are not included in the accompanying financial statements. Investment management fees and plan administration fees charged to the Plan for all investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees, distribution and plan administration fees are reflected as a reduction of net appreciation in the fair value of investments. Loan origination, recordkeeping and certain other administrative fees are paid by the Plan's participants. During the years ended December 31, 2024 and 2023, administrative expenses amounted to \$4,721 and \$2,950, respectively.

**Note 2 - Summary of Significant Accounting Policies:**

- a. **Basis of Accounting** - The accompanying financial statements have been prepared on the accrual basis of accounting, as required by Accounting Standards Codification ("ASC") 962, Plan Accounting - Defined Contribution Pension Plans, including investment valuation and income recognition. The Plan year is January 1 through December 31.
- b. **Investment Valuation and Income Recognition** - The Plan's Investments are reported at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. The change in the difference between market value and cost of investment is reflected as net appreciation (depreciation) in fair value of investments in the periods in which such changes occur. Gains or losses from the sale of investments are determined on the average cost basis.
- c. **Use of Estimates** - The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.
- d. **Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.
- e. **Payment of Benefits** - Benefit payments to participants are recorded when paid. There were no participants or beneficiaries, who have elected to withdraw from the Plan, but have not been paid as of December 31, 2024 and 2023.
- f. **Operating Expenses** - All expenses of maintaining the Plan are paid by the Corporation. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Note 4 - Fair Value Measurements:**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Mutual Funds (Registered Investment Companies "RICs") - The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Common Collective Trust Funds - Common collective trusts are valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of the common collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**Note 5 - Tax Status:**

The Plan is a non-standardized prototype plan. The IRS has determined and informed the Company by a letter dated July 8, 2014, that the Plan satisfies the requirements of Section 401(a) of the Internal Revenue Code of 1986, as amended ("IRC") and therefore, is tax-exempt. The Plan has been amended since the latest determination letter. However, the Company and Plan Sponsor believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.
