#### NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### ***Basis of Accounting***

The accompanying financial statements of Leadec Corp. 401(k) Plan (the "Plan") have been prepared on the accrual basis using accounting principles generally accepted in the United States of America.

##### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and those such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### ***Notes Receivable from Participants***

For reporting purposes, participant loans are classified as notes receivable from participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

##### ***Payment of Benefits***

Benefits are recorded when paid.

##### ***Use of Estimates***

The preparation of financial statements in conformity with principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### ***Related Party Transactions***

Certain employees of the Plan sponsor provide administrative and executive oversight services to the Plan. The Plan is not charged by the Plan sponsor for the services.

##### ***Subsequent Events***

In preparing the financial statements, the Company has evaluated events subsequent to the statements of net assets date through September 23, 2025, which is the date the financial statements were available to be issued.

#### NOTE 2 DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

##### **General**

Effective September 2, 2003, Leaded Corp. (the Company) adopted the Plan for the benefit of eligible employees of the Company. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is also subject to various Collective Bargaining Agreements. Union employees, and such other employees who are expected to become part of a bargaining unit within 12 months of hire as designated by the employer, must have attained the age of 18 and completed two months of service in order to enter the Plan, and must complete twelve months of service in order to be eligible for employer contributions. Non-union employees of the Company must have attained the age of 18 and completed two months of service in order to enter the Plan, and must complete three months of service in order to be eligible for employer contributions. Eligible employees can enter the Plan on the first day of each quarter.

##### **Contributions**

Each year, participants may contribute, before tax, contributions to the Plan up to 60% of their eligible annual compensation, as defined. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 at December 31, 2024). Section 414(v) of the Internal Revenue Code of 1986 as amended allows a maximum catch-up contribution of \$7,500. Participants may also contribute amounts representing distributions from other qualified plans.

Participants designate the percentage of their total contribution to be invested in any of the Plan's investment funds. A participant may change the amount of his elective deferred contributions at any time during the Plan year by issuing a change request form to the Plan administrator. Participants may change the percentage of contributions invested in each account and may make transfers between accounts anytime during the year.

The Plan has adopted provisions to allow for automatic enrollment into the Plan. When new participants become eligible to participate in the Plan, deferrals will be made on their behalf at 1%, unless the participant elects a different deferral percentage or not to participate in the Plan.

The Company makes a matching contribution to the Plan on behalf of each participant who makes before-tax contributions. For the December 31, 2024 and 2023 plan years, eligible non-union employees received a Company match equal to 55% of the participant's contribution up to 5% of their total compensation. Eligible employees of UAW, International Union, received a Company match equal to 60% of their contribution up to 4% of their total compensation. They also received a fixed profit-sharing contribution in the amount of \$416. Eligible employees of UAW, Local No. 900, received a Company match equal to 60% of their contribution up to 4% of their total compensation. They also received a fixed profit sharing contribution in the amount of \$416. Eligible employees of UAW, International Union and Local No. 1853, received a Company match equal to 55% of their contribution up to 4% of their total compensation. Effective August 27, 2024, the match was changed to 55% of their contribution up to 5%.

The Company may also make additional discretionary contributions to the Plan to those participants employed on the last day of the contribution period. There were no additional discretionary contributions for December 31, 2024 and 2023.

#### NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

##### ***Rollover Contributions***

Participants may roll over their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

##### ***Participant Accounts***

Each participant's account shall be credited with the applicable contributions, earnings, losses, expenses and distributions. As defined in the Plan, allocations of earnings and losses are based on the ratio that the participant account bears to the total of all participant accounts.

##### ***Vesting***

Participants are immediately vested in all of their accounts.

##### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$500 up to the lesser of \$50,000 (as defined in the Plan) or 50% of their vested account balance. (If a participant had a note receivable balance in the most recent prior period, the maximum note amount is \$50,000 or 50% of their vested balance less the highest note balance in the prior period.) Participants may have only one note outstanding at any given time. Note repayment terms are not to exceed 5 years unless utilized for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at rates determined by the Plan Administrator taking into consideration rates being charged on similar commercial loans. Principal and interest are paid ratably through weekly or bi-weekly payroll deductions; however, lump sum payoffs are permitted.

##### ***Payment of Benefits***

On termination of service due to retirement, death, disability, other termination of employment with Leaded Corp., or termination of the Plan, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants with a vested account balance of \$5,000 or less will automatically be distributed as a lump-sum if a direct rollover is not requested in writing within 30 days.

Upon termination of the Plan, the assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

In-service distributions are permissible from the Plan for participants that have obtained the age of 59 1/2. Participants electing in-service distributions may elect to receive all or a portion of their vested benefits in a lump sum payment or annual installments.

In conditions of "financial hardship", as defined, a participant may apply to the Plan administrator for approval to withdraw a portion of their elective deferrals necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

##### ***Forfeitures***

The non-vested portion of terminated participant account balances can be used by the Plan sponsor to pay administrative expenses under the Plan, and then to reduce future employer contributions. For the years ended December 31, 2024 and 2023, the balance of unallocated forfeitures was \$36,074 and \$11,693, respectively. During 2024, no forfeiture funds were used to offset employer contributions or pay administrative expenses.

#### NOTE 3 TAX STATUS

The Internal Revenue Service has determined, and informed the Company by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

#### NOTE 4 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan is terminated, participants will become fully vested in their account balances.

#### NOTE 5 ADMINISTRATIVE EXPENSES

Administrative expenses represent the cost of accounting and administrative services provided to the Plan by ADP Retirement Services. Certain other administrative expenses of the Plan are paid by the Company.

#### NOTE 8 FAIR VALUE MEASUREMENTS

Applicable generally accepted accounting principles, GAAP, accounting for Fair Value Measurement and Disclosures establishes a framework for measuring fair value. That framework provides a fair value hierarchy that priorities the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the applicable GAAP accounting for Fair Value Measurement and Disclosures are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. (Mutual funds, common stocks, corporate bonds, US government securities, etc.)

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed actively traded.

#### NOTE 8 FAIR VALUE MEASUREMENTS (CONTINUED)

*Collective investment trust:* Valued at the net asset value calculated by the fund manager based on underlying investments. The existence of certain conditions can limit the trust's ability of the Plan to transact with participants at fair value of the collective trust. Specifically, any event outside the normal operation of the trust which causes a withdrawal from the investment contract may result in a negative market value adjustment with respect to such withdrawal. Examples of such events include plant closings, layoffs, plan termination, bankruptcy or reorganization, merger, early retirement incentive programs, tax disqualification of a trust or other events. As of December 31, 2024, the occurrence of an event outside the normal operation of the trust which would cause a withdrawal from the investment contract is not considered probable.

The Plan invests in the Invesco Stable Asset Fund which is a collective investment trust. Collective investment trusts are investment funds formed by pooling of investments by institutional investors, such as a group of not necessarily affiliated pension or retirement plans, typically with the intention of achieving cost savings over similar investment options such as mutual funds. Collective investment trusts are similar to mutual funds, with a named investment manager and documented investment objective. These investments, however, are not registered with the SEC (unlike mutual funds, which are registered) and participation is not open to the public. The NAV is measured by the custodian or investment manager as of the close of regular daily trading. These investments are classified within Level 2 of the fair value hierarch. In certain instances, NAVs may require adjustments to more appropriately reflect the fair value. No adjustments to NAVs were required.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
