### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

#### 1. Plan Description

The following description of the CenterPoint Properties Trust 401(k) Plan (the "Plan") is intended to provide only general information. CenterPoint Properties Trust (the "Employer" and "Plan Sponsor") has established procedures to advise all eligible employees of the provisions of the Plan through a Summary Plan Description. Participants should refer to the Plan agreement and the Summary Plan Description for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan and is administered by the Employer. The assets of the Plan are managed and administered under the terms of an agreement between the Employer and the trustee, Reliance Trust Company (the "Trustee"). The Trustee is responsible for the investment of such assets and the accounting for all related receipts and disbursements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### **Contributions**

All employees who have reached age 18 are eligible to participate in the Plan. Each year, participants may contribute up to 90% of pretax annual compensation, as defined in the Plan agreement, subject to Internal Revenue Service ("IRS") limits. Participant contributions may also include rollovers, which represent transfers of participant account balances previously held in the former employer's qualified plans. Participants are permitted to designate a portion or all of their deferral contributions as Roth Deferral Contributions. Roth Deferral Contributions are subject to the same IRS limits as pretax contributions.

Each year, the Employer will determine the amount, if any, of matching contributions that will be contributed to the Plan. One year of service with the Employer is required for a participant to be eligible to receive a matching contribution. For the year ended December 31, 2024, the Employer continued to elect to make a matching contribution equal to 50% of the participants' contributions, up to 8% of each participant's pretax annual compensation. The Employer may also make additional discretionary contributions, as determined by management. No additional discretionary contributions were made in 2024.

In no event shall the contributions credited to a participant's account for any Plan year, either separately or when combined with the Employer contributions, exceed the allowable deduction for federal income tax purposes.

#### **Automatic Enrollment Contributions**

Unless an employee elects otherwise after receiving notice, the employee will be automatically enrolled in the Plan to contribute 6% of eligible compensation, as soon as administratively feasible on or after the Participant's Entry Date, as defined in the Plan agreement. If the participant fails to affirmatively elect a different percentage, the participant's contribution percentage increases 1% annually not to exceed 8% of eligible compensation.

#### **Participant Accounts**

Each participant's account is credited with that participant's contributions and allocations of a) the Employer matching contribution and b) Plan investment earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The net investment gain or loss for each of the investment assets is allocated daily to each participant's elective accounts in the proportion to which each such account bears to the total of all such asset accounts.

#### **Vesting**

All participant and Employer contributions and earnings thereon are fully and immediately vested.

#### **Notes Receivable from Participants**

Within the limits of IRS regulations, which change from time-to-time, a loan may be requested for any reason by a participant. The minimum loan is \$1,000. The maximum loan is generally limited to the lesser of:

- (1) 50% of the participant's vested account balance, or
- (2) \$50,000, minus the highest outstanding loan balance in the prior 12 months.

The loan repayment period is set at a maximum of 5 years except in the case of a loan for the purpose of acquiring a principal residence, in which case the loan may be repaid over the maximum period per the Plan agreement. Participants may only have one loan outstanding at any time. The Plan Sponsor sets the rate of interest, which, in general, is intended to approximate the prevailing interest rates that may be charged by lending institutions for loans made under similar circumstances. The interest rate remains fixed throughout the duration of the loan. The loan is collateralized by the remaining balance in the respective participant's account. Upon termination with the Employer, the loan is due immediately. Outstanding loan balances may be paid off in full at any time while employed by the Employer; partial pre-payments are not permitted.

#### **Payment of Benefits**

Upon termination of service due to death, disability, and retirement or due to other reasons, a participant may elect to receive a lump sum amount or installments equal to the value of the participant's vested interest in his/her account. In-service distributions are permitted when a participant reaches age 59 1/2. Minimum distributions are required by law no later than April 1 following the calendar year the participant reaches 73 years old. In addition, hardship distributions are permitted if certain criteria are met.

#### **Administrative Expenses**

Administrative expenses are made up of record keeping fees, investment advisory and investment management fees, and loan processing fees. Certain professional fees and other administrative expenses incurred in connection with the Plan are paid by the Employer and are not reflected in the Statement of Changes in Net Assets Available for Benefits.

## **2. Summary of Significant Accounting Policies**

#### **Basis of Presentation**

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### **Valuation of Investments and Income Recognition**

Refer to Note 4 for disclosures provided for fair value measurements of Plan investments.

The Plan presents in the Statement of Changes in Net Assets Available for Benefits the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments. Purchases and sales of investments are reflected on a trade date basis. Dividends are recorded on the ex-dividend date.

**Notes Receivable from Participants**

Participant loans are stated at unpaid principal plus unpaid accrued interest. At December 31, 2024 and 2023 there were no loans in default that exceeded the participant's vested account balances. Interest income is recorded on an accrual basis.

**Payment of Benefits**

Benefits are recorded when paid.

**Use of Estimates**

The preparation of the financial statements in conformity with GAAP requires the Plan Sponsor to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan provides for various investment options in any combination of registered investment funds and a common/collective trust fund. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

**3. Information Certified by the Trustee**

**Investments**

The investment assets of the Plan at December 31, 2024 and 2023 were held, and all transactions for the year ended December 31, 2024, were executed by the Trustee under the terms of the trust agreement.

In accordance with the provisions of 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Trustee has certified as complete and accurate all investment and notes receivable from participants information included in the accompanying financial statements and the supplemental schedule. Information included in the accompanying financial statements relating to investments and notes receivable from participants and the corresponding income (loss) was prepared by or derived from information prepared by the Trustee of the Plan and furnished to the Plan Sponsor. The Plan Sponsor has obtained a certification from the Trustee as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that such information is complete and accurate. Such information includes investments at fair value, notes receivable from participants, interest income on notes receivable from participants, dividend income, and net appreciation in fair value of investments as shown in the accompanying Statements

#### 4. Fair Value of Investments

The FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB 820 are described as follows:

- Level 1 – Quoted market prices in active markets that the Plan has the ability to access for identical assets
- Level 2 – Quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuations in which all significant inputs are observable in the market; and
- Level 3 – Valuations using significant inputs that are unobservable in the market and include the use of judgment by the Plan about the assumptions market participants would use in pricing the assets.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any inputs that are significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the investments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### Registered Investment Funds

The shares of registered investment funds are valued at quoted market prices on an exchange in active markets or net asset values as computed by the applicable fund company, which represent the net asset values of shares held by the Plan at year end, and are classified as Level 1 investments.

#### Common/Collective Trust Fund

The fund is valued using the net asset value, referred to as NAV, provided by the administrator of the fund. Units of the fund are valued each day on which the New York Stock Exchange (NYSE) is open for trading in accordance with the valuation procedures established by the Trustee. The NAV per unit is calculated as of the close of trading on the NYSE (generally, 4:00 p.m. U.S. Eastern time). The NAV per unit is computed by dividing the total assets of the fund, less its liabilities, by the total number of units outstanding at the time of such computation. Participant transactions (purchases and sales) may occur daily. There are no significant redemption restrictions or unfunded commitments on this investment. In accordance with GAAP, since the common/collective trust fund is measured using the NAV per share practical expedient, the investment is not classified in the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Plan Termination**

Although the Employer has reserved the right to amend or terminate the Plan, it was established with the intention that the Plan and the payment of contributions will be indefinite. Each participant or beneficiary, as the case may be, is entitled to receive any amounts credited to his or her accounts in the Plan, provided, however, that the Employer is not required to effect such distribution until written evidence of approval of such termination and distribution has been received from the Commissioner of the IRS. Presently, there is no intention on part of the Employer to terminate the Plan.

**6. Tax Status**

The Plan is based on a Prototype Non-standardized Profit Sharing Plan with a qualified cash or deferred arrangement (“CODA”) from Automatic Data Processing Inc., which received an IRS opinion letter, dated October 6, 2020. As such, the Plan Sponsor does not intend to file for a determination letter with the IRS. Although the Plan has been amended since the date covered by

the opinion letter, the Plan Sponsor believes that the Plan is designed and is currently being operated in accordance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been recorded by the Plan.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**7. Party-in-Interest Transactions**

Certain participants have loans outstanding to the Plan. Transactions involving these investments qualify as party-in-interest transactions. At December 31, 2024 and 2023, the Plan held an investment of \$1,461,804 and \$1,353,582, respectively in a common/collective trust managed by the Trustee of the Plan, as such the investment and investment transactions associated qualify as party-in-interest transactions.
