NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN

The following description of the FIT Electronics, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan that was established in 1998 by FIT Electronics, Inc. (the “Company” or “Employer”) to provide benefits to eligible employees, as defined in the Plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (the “Code”), as amended, and the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Eligibility

Employees of the Company who are over 21 years old and complete three months of service are eligible to participate in the Plan.

Administration

The Company has appointed an Investment Committee to manage the operation and administration of the Plan. The Company has contracted with Reliance Trust Company to act as the custodian, and ADP Retirement Services, a third-party administrator to process and maintain the records of participant data.

Participant Contributions

Participants may elect to have the Company contribute up to 70% of their eligible pre-tax or Roth after-tax compensation to the Plan up to the amount allowable under the Plan document and current income tax regulations. Participants who have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan allows for After-tax voluntary employee contributions to the Plan and In-Plan Roth rollover contributions.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant’s direction and the Plan’s provisions.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Employer Contributions

The Plan is considered a “safe harbor 401(k) plan” where the Company has committed to making safe harbor contributions to ensure that the nondiscrimination regulations are met. The safe harbor match was equal to 100% of eligible participants’ contributions not to exceed 6% of eligible compensation in 2024. The safe harbor matching contributions are calculated on a per payroll period basis. However, at the end of the Plan year, the Company will adjust the safe harbor matching contributions based on each participant’s contributions and compensation for the entire Plan year and record a true-up contribution. For the year ended December 31, 2024, the Company recorded a true-up contribution for the safe harbor match of \$35,017, which was included in the Employer contribution receivable at December 31, 2024. Employer match contributions are invested in the same manner as employee elective deferrals.

Vesting

Participants are immediately vested in their entire account, including safe harbor matching contributions.

Participant Accounts

Individual accounts are maintained for each of the Plan’s participants to reflect the participant’s contributions, Company contributions, rollovers from qualified plans of the participant’s previous employers, and allocations of the Plan’s earnings and administrative expenses. The benefit to which a participant is entitled is that which can be provided by the participant’s vested account.

Investment Options

Participants must direct their salary deferral contributions to selected investments as made available and determined by the Investment Committee. Participants may change their investment options any time throughout the year via the Internet website or by using the automated telephone system offered by the third-party administrator. Employer contributions are invested in the same manner as employee deferrals.

Payment of Benefits

Upon a participant’s early retirement (age 59.5), normal retirement, termination of employment, death, or disability, the participant (or the participant’s beneficiary in the event of death) may elect to receive a lump sum distribution equal to the value of his or her account, equal installment payments over the period of the life expectancy of the participant or the life expectancy of the designated beneficiary, or direct trustee to trustee rollovers. The Plan allows for the automatic distributions of participant account balances under \$1,000, and also allows for an automatic rollover into an Individual Retirement Account if the amount is between \$1,000 and \$5,000.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Financial Hardship Distributions

The Plan allows hardship withdrawals in accordance with IRS regulations. Among other things, the withdrawal must be necessary in light of immediate and heavy financial needs of the participant and is limited to certain purposes. The participant may only take withdrawal hardship distributions from elective deferrals.

Notes Receivable from Participants

The Plan allows participants to borrow a minimum of \$500 up to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the participant's account balance. Such notes bear interest at the U.S prime rate plus 1% and must be repaid to the Plan within a five-year period unless the note is used for the purchase of a principal residence in which case the maximum repayment period is fifteen years. A participant can have two loans currently outstanding from the Plan at any time. Outstanding notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50%, and mature through 2029. Outstanding notes receivable from participants at December 31, 2023 carry interest rates ranging from 4.25% to 9.25%, and mature through 2028.

Plan Expenses

The Company currently pays for most of the Plan's expenses. Expenses paid by the Company are excluded from the financial statements. Plan expenses not paid by the Company will be charged on a pro-rata basis to the value of the participants' account balances.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

Investment Valuation and Income Recognition (Continued)

Management fees charged to the Plan for investments in registered investment companies are based on assets invested and are deducted on a daily basis. Management fees are reflected as a reduction of investment returns for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document. There were no delinquent notes receivable from participants as of December 31, 2024 and 2023. No allowance for credit losses have been recorded as of December 31, 2024 and 2023.

Benefit Payments

Benefit payments are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

Income Taxes

The Plan has adopted a non-standardized pre-approved plan form of a pre-approved plan document. The pre-approved plan has received an opinion letter from the Internal Revenue Service ("IRS") as to non-standardized pre-approved plan's qualified status. The non-standardized pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

NOTE 3 – CERTIFIED INFORMATION

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the United States Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the custodian of the Plan, has certified the completeness and accuracy of:

- Investments and notes receivable from participants reflected in the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, dividend and interest income, other income, and interest income on notes receivable from participants reflected in the accompanying statement of changes in net assets available for plan benefits for the year ended December 31, 2024;
- Assets reflected in the supplemental Schedule H, 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

NOTE 4 – FAIR VALUE MEASUREMENT

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 4 – FAIR VALUE MEASUREMENT (Continued)

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Registered investment companies (mutual funds)

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts

Valued at the daily closing price as reported on the active market on which the individual securities are traded.

Collective investment trust

Units held in collective investment trust (“CIT”) are valued using the net asset value practical expedient (NAV practical expedient) of the CIT as reported by the CIT managers. The NAV practical expedient is based on fair value of the underlying assets owned by the CIT, minus its liabilities, and then divided by the number of units outstanding. The NAV of a CIT is calculated based on a compilation of primarily observable market information. The following table provides additional information for investments in the CIT that calculates net assets value per share (or its equivalent):

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Notes receivable from participants are managed by an affiliate of Reliance Trust Company, the custodian of the Plan. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 6 – ACCOUNTING FOR UNCERTAINTY IN INCOME TAXES

U.S. GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS or the DOL. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – PLAN TERMINATION OR MODIFICATION

The Company intends to continue the Plan indefinitely for the benefit of its participants; however, it reserves the right to terminate or modify the Plan at any time by resolution of its Board of Directors and is subject to the provisions of ERISA. Upon termination of the Plan, further contributions to the Plan shall cease and all participants who are affected by such termination shall become 100% vested. Net assets available for plan benefits would be distributed to the participants based on each participant's interest in the Plan.

NOTE 8 – SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to allow taking hardship distributions from all sources and add In-Plan Roth rollover transfers to the Plan with a minimum amount \$500 from all sources.

The Plan has evaluated subsequent events through September 11, 2025, which is the date the financial statements were available to be issued.
