Note 1 - Description of plan:

The following description of the UCB, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Primary Sponsor of the Plan is UCB Holdings, Inc. The Plan is a defined contribution plan covering substantially all employees of UCB Holdings, Inc., UCB, Inc., UCB Biosciences, Inc., UCB Pharco, Inc., UCB Pharma, Inc., UCB Manufacturing, Inc., UCB Technologies, Inc., and RA Pharmaceuticals, Inc. (collectively known as the Company, Plan Sponsor, UCB, or Plan Administrator).

The Plan's eligibility requirements are as follows: for eligible employees classified as full-time and scheduled to work at least 24 hours per week, employees are required to complete one hour of service to be eligible to participate. For all other eligible employees, plan participation is allowed upon the earlier of the completion of 1,000 hours of service in a 12 month period beginning on the date of hire, or completion of more than 500 hours of service per Plan year in three consecutive Plan years. The 1,000 hours of service requirement reverts to a calendar year after the first 12 months of service. These provisions have been modified. See the amendments below.

Employees must be at least 18 years of age to participate in the Plan. Plan entry is immediate upon completion of the preceding eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Amendments

Effective January 1, 2024, the Plan was amended to modify the eligibility service, as described in the above paragraph, for non-full-time employees from 1,000 hours of service in a 12 month period or completion of more than 500 hours of service per Plan year in three consecutive years, to one hour of service. Additionally, prior service with Beryllium, Medichem, Emerald, deCode, RA Pharma, Element Genomics, and Zogenix were recognized.

Effective January 1, 2024, the Plan was amended to modify the allowed use of the Plan's forfeiture balance. Previously, forfeitures were allowed to reduce employer Plan contributions or to pay allowable Plan expenses. This amendment modifies those provisions to only allow forfeitures to be used to reduce employer contributions to the Plan.

Notes to Financial Statements - Continued

Note 1 - Description of plan - continued:

Contributions

Participants classified as non-highly compensated employees may elect to contribute from 1% to 75% of eligible compensation on a pre-tax or Roth basis, and up to 5% on an after-tax basis, through payroll deductions. Participants classified as highly compensated employees may elect to contribute from 1% to 13% of eligible compensation on a pre-tax or Roth basis and up to 5% on an after-tax basis, through payroll deductions. Participants who have attained age 50 before the end of the Plan year are permitted to make catch-up contributions. The Company provides non-discretionary employer matching contributions equal to 100% of each participant's pre-tax and Roth contributions up to a maximum of 5% of eligible compensation, as defined.

The Company provides a year-end employer match true-up contribution for all participants. The Company made employer matching and match true-up contributions of \$18,804,854 for the 2024 Plan year. Contributions are subject to certain limitations under the Internal Revenue Code (IRC).

The Plan also has a retirement savings contribution benefit in an amount equal to a percentage of the participant's compensation based upon the participant's age on the last day of the Plan year, and is allocated in accordance with the following schedule:

To receive a retirement savings contribution, a participant must be employed on the last day of the Plan year, or must have retired, died, become permanently disabled, terminated due to a reduction of workforce, or attained age 60 prior to termination of employment during the Plan year. The Company made retirement savings contributions of \$26,155,235 for the 2024 Plan year, of which \$2,993,734 was funded from forfeited accounts. This contribution was made in the subsequent Plan year. Contributions are subject to certain limitations under the IRC.

Participants may direct both employee and employer contributions in 1% increments to any of the Plan's fund options. Participants may change their investment options daily.

Participant accounts

Each participant's account is credited with the participant's contributions, the Company's matching contribution, an allocation of the Company's retirement savings contribution, Plan expenses, and Plan earnings.

Allocations are based on a combination of the participant's compensation, age and service, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Forfeited accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,198,756 and \$1,608,306, respectively, and are included in the common/collective trust fund on the statements of net assets available for benefits. During 2024, forfeitures totaling \$1,698,013 were used to reduce employer contributions to the Plan.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants vest in the Company's matching contributions in accordance with the following schedule:

Participants are immediately vested upon termination of the Plan, upon reaching the normal retirement age of 65, or upon disability or death while an employee of the Plan Sponsor. Forfeitures of terminated participants' non-vested accounts may be used by the Plan for the payment of Plan expenses or to reduce employer contributions.

Payment of benefits

A participant is entitled to a distribution of the vested value of his or her account upon termination of service, disability, death, or retirement. Distributions are made in lump-sum payments. Upon attainment of age 59 1/2, a participant may elect to withdraw all or part of their pre-tax, Roth, and vested employer matching contributions balances.

In-service withdrawals of a participant's pre-tax, Roth, and vested employer matching contributions balances are permitted in cases of proven financial hardship. Participants may request distribution of their after-tax and rollover account balances at any time. If a participant's account balance is between \$1,000 and \$5,000 upon termination of service, the Plan Sponsor has the option to "force-out" the participants account balance by rolling over the

participant's account to an individual retirement account. If a participant's account balance is less than \$1,000 upon termination of service, a distribution of the participant's account will be made automatically in a single lump-sum cash distribution.

Notes receivable from participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, excluding their retirement savings account balance. Note receivable terms range from one to five years, or up to ten years for the purchase of a primary residence. Participants may have two notes outstanding at any time. Notes receivable are secured by the participant's account and bear interest at the prime rate published in *The Wall Street Journal* plus 1%. Principal and interest are paid ratably through payroll deductions. Participants may prepay their notes at any time.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Administrative expenses

Administrative expenses of the Plan are paid by either the Company or the Plan, as determined by the Plan Sponsor. The Company absorbs a portion of the administrative expenses of the Plan. A flat fee per participant is charged quarterly to participant accounts. Additional fees charged for processing notes receivable from participants, as well as other account transaction fees, are charged directly to the accounts of applicable participants. The remaining expenses of the Plan are paid by the Plan Sponsor. Plan expenses primarily consist of fees charged for loans, distributions, recordkeeping, investment consulting, auditing, and legal fees.

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Stable value fund

The Plan has an investment in the Vanguard Retirement Savings Trust which is a stable value investment. This type of investment is reported at contract value as contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents the cost plus contributions made under the contract plus interest at the contract rates less withdrawals and administrative expenses.

This investment stipulates that if the Plan Sponsor initiates an event such as a merger, mass layoffs, plan termination, implementation of early retirement incentive programs, or other events within the control of the Plan Sponsor resulting in a material and adverse financial impact on the fund, all withdrawals attributable to these events that exceed a specified level are payable at fair value rather than at contract value. It is at least reasonably possible that one of these events could occur.

However, this investment is fully benefit-responsive at contract value. Participant-directed withdrawals in accordance with the Plan document are payable at contract value even if the withdrawal is precipitated by a Plan Sponsor initiated event, so long as the employee experiences a bona fide job loss. In the event of a spin-off or sale of a division where the employee does not experience a bona fide job loss, the issuer may make a clone contract available to the successor employer's plan.

In the event that the Plan is terminated, there is a material adverse change to the provisions of the Plan, or the employer elects to withdraw from a contract in order to switch to a different investment provider, the amount withdrawn from the investment would be payable at fair value rather than at contract value. The Plan's investment in the Vanguard Retirement Savings Trust is considered to be fully benefit-responsive.

Investment valuation and income recognition

The Plan's registered investment company funds and collective investment trusts investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. These investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;
Quoted prices for identical or similar assets or liabilities in inactive markets;
Inputs other than quoted prices that are observable for the asset or liability;
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investment valuation and income recognition - continued

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Shares of registered investment companies are valued at the net asset value of shares held by the Plan at year end by obtaining quoted prices on nationally recognized securities exchanges. These investments are considered to be actively traded.

Collective investment trusts are valued at the net asset value (NAV) of units in the individual collective trust investments. The NAV is used as a practical expedient to estimate fair value, where the NAV is based on the underlying assets owned by each trust, less liabilities, divided by the number of units outstanding.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Payment of benefits

Benefits are recorded when paid.

Note 4 - Party-in-interest transactions:

The trustee and its affiliates perform services for the Plan, sell products to the Plan, and manage and maintain certain investments of the Plan for which fees are charged to the Plan. The Plan pays a portion of the administrative expenses. Such transactions, while considered party-in-interest transactions under ERISA, are specifically exempt from the prohibited transaction rules.

Note 5 - Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants' accounts will become fully vested.

Note 6 - Tax status:

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated July 11, 2022 that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for Plan years prior to 2021.

Note 7 - Subsequent events:

The Plan was amended with an effective date of January 1, 2025 as follows:

The allowed maximum after-tax contributions for both non-highly compensated employees and highly compensated employees was increased from 5% to 10% of eligible compensation;

The newly allowed increased limits for catch-up contributions for participants attaining age 60 to 63 during a plan year were adopted. The new limits allow for the greater of \$10,000 or 50% more than the regular catch-up contributions amount, which is indexed for inflation annually;

The "force-out" provisions of the Plan were modified to raise the threshold from \$5,000 to \$7,000.
