## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of **Stephenson Equipment, Inc. Group Medical Plan**, (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - modified cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of **Stephenson Equipment, Inc. Group Medical Plan** and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

***Basis of Accounting***

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedules are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

## NOTES to FINANCIAL STATEMENTS

### NOTE 1 - DESCRIPTION of the PLAN

The following description of the **Stephenson Equipment, Inc. Group Medical Plan** (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan provides health benefits covering substantially all employees of Stephenson Equipment, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Benefits**

The Plan provides health benefits covering all full-time employees of the Company scheduled to work at least 30 hours per week and their spouse and dependents. Spouses are only eligible for coverage if they are unemployed or the spouse is employed, but the benefits offered by the employer of the spouse are deemed to be significantly less than that of the Plan. Employees are eligible upon date of hire. Employees must enroll within 30 days of eligibility or enrollment is not permitted until an annual enrollment period that is held each year.

#### **Self-Insured Benefits**

The health benefits are self-insured by the Company. The claims for these self-insured benefits are processed by the Plan's third-party administrators under administrative services only (ASO) arrangements. The third-party administrators pay claims directly to or on behalf of participants. The payments for these claims are paid by the Plan's trust which is funded by the general assets of the Company and employee payroll deductions. Despite the Plan's utilization of third-party administrators for claims processing, the ultimate responsibility for payments to providers and participants is retained by the Plan.

#### **Health Savings Account**

Participants in the Plan can contribute to a health savings account (HSA). The associated activity of the HSA accounts for Plan participants is excluded from these financial statements because the Plan is not obligated to pay benefits.

#### **Stop-Loss Coverage**

The Company has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount) as well as its aggregate exposure for all health claims.

#### **Contributions**

The Company shall periodically deliver to the Plan such amounts of money as shall be necessary for timely payment of all claims and reasonable administrative expenses of the Plan. The Company provides for stop-loss insurance over a specified amount as per agreement with the excess loss insurance carrier, with the premiums being paid by funds deposited in the Plan. Participant contributions represent a percentage of participant and dependent costs. The Plan is contributory.

#### **COBRA - Consolidated Omnibus Budget Reconciliation Act**

Generally effective for Plan years beginning on or after July 1, 1986, the Plan is required to offer continuation of benefits for a specified period of time to qualified participants and their dependents who would not otherwise be eligible for continued coverage because of a particular qualifying event as required by law. Each qualifying individual pays his/her premium directly to the third-party administrator, which is shown as COBRA deposits. COBRA claims and other COBRA expenses are paid by the third-party administrators.

### NOTE 1 - DESCRIPTION of the PLAN (Continued)

#### Pharmacy Rebate Credit

The Plan receives a fixed pharmacy rebate credit per member per month under its contract with a third-party administrator. Amounts received through the years ended December 31, 2024 and 2023 were netted against administrative expenses in the accompanying statements of changes in net assets available for benefits - modified cash basis. Amounts received for the years ended December 31, 2024 and 2023 were \$167,088 and \$77,061, respectively.

#### Termination of the Plan

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to and contributions required of participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the Company must pay the claims incurred and expenses of the Plan due up to the date of termination plus extended benefits, if any, provided under the Plan. Also, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than that for the exclusive benefit to the Plan's participants.

### NOTE 2 - SUMMARY of SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The Plan follows the practice of presenting its financial statements in accordance with the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (US GAAP). Under the modified cash basis of accounting, only revenues collected, costs and expenses paid, and assets and liabilities arising as a result of cash transactions or from the recognition of income due from insurance companies for claims paid or deferred employer contributions are recognized. Investments are recorded at fair value. Fixed pharmacy rebates are netted against administrative fees. Therefore, accrued income and expenses, payables, and deferred expenses, which may be material in amount, are not reflected on the accompanying financial statements.

#### Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Dividend income is recorded when received by the Plan. Net appreciation (depreciation), if any, includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### Payment of Benefits

Claims payments are recorded when paid by the third-party administrators. Out of network fees associated with claims are recorded in benefit payments.

Excess loss premiums paid by the Company are recorded as payments in the accompanying statements of changes in net assets available for benefits - modified cash basis.

## NOTE 2 - SUMMARY of SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Stop-Loss Coverage

Premiums for stop-loss insurance are recorded as deductions in the accompanying statements of changes in net assets available for benefits - modified cash basis. Stop-loss refunds totaling \$62,989 and \$227,337 for the years ended December 31, 2024 and 2023, respectively, have been netted with claims paid in the accompanying statements of changes in net assets available for benefits - modified cash basis. Stop-loss refund recoverables totaling \$54,059 and \$90 for the years ended December 31, 2024 and 2023, respectively, have been netted against employer contributions in the accompanying statements of changes in net assets available for benefits - modified cash basis.

### Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those amounts.

### Benefit Obligations

Plan obligations at December 31, 2024 and 2023, for health claims incurred by participants are estimated by analyzing actual subsequently paid claims that have dates of service during the reporting period and additional reserve for unreported claims which is determined by the third-party administrators.

### Income Taxes

Plan Management evaluates tax positions taken by the Plan and discloses a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Administrative Expenses

Administrative fees paid by the Company are recorded in the accompanying statements of changes in net assets available for benefits - modified cash basis.

Certain administrative expenses associated with the Plan are paid by the Company.

## NOTE 3 - ERISA DISCLOSURES

The trust established under the Plan to hold the Plan's assets is a taxable trust account. Income taxes of \$9,639 and \$-0- were paid by the Plan for the years ended December 31, 2024 and 2023, respectively.

### Related Party Transactions and Party-in-Interest Transactions

The Plan's trust account is with Wilmington Trust. The Plan's money market investments of \$1,216,695 and \$686,039 at December 31, 2024 and 2023, respectively, were with Wilmington Trust. Fees of \$900 were paid to Wilmington Trust for the years ended December 31, 2024 and 2023.

As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

There were no prohibited transactions involving a known party-in-interest for the years ended December 31, 2024 and 2023.

### NOTE 4 - INVESTMENTS CERTIFIED by TRUSTEE

### NOTE 5 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset and liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of and for the years ended December 31, 2024 and 2023:

*Money Market Fund:* Valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily net asset value (NAV) and to transact at that price. The money market fund is deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
