Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Jersey Shore Steel Rolling Division Hourly 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

(1) Description of Plan

The following description of the Jersey Shore Steel Rolling Division Hourly 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan qualified under Section 401(k) of the Internal Revenue Code (IRC) covering substantially all union employees of the Company. The Plan was established by Jersey Shore Steel Company (the Company) effective October 1, 1997 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Eligibility

All employees of the Company, except nonresident aliens, who have completed three months of service and become a member of the Local 4907-03 United Steelworkers of America Union, are eligible to enroll in the Plan. New participants may enroll on the first day of each month of the plan year.

Contributions

Effective September 1, 2005, employees who have elected to cease future benefit accruals under the Pension Plan for Employees of Jersey Shore Steel Company, Inc. (the Pension Plan) are eligible to receive employer matching and profit sharing contributions.

The Company will match an amount equal to 50% of a participant's deferral contribution up to 4% of compensation. In addition, a profit sharing contribution amounting to 3% of eligible participants' compensation will be made on an annual basis.

Participants may elect to contribute an unlimited percentage of their compensation, not to exceed the maximum of \$23,000 in 2024. Participants who are age 50 or older by the end of the calendar year may also make a catch-up contribution of up to \$7,500 for the year ended December 31, 2024. Participants may elect their contributions be either pre-tax or Roth. Participants may also make contribution amounts representing distributions from other qualified defined benefit or defined contribution plans.

(1) Description of Plan, Continued

Participant Accounts

Each participant's account is credited with the participant's contributions as well as allocations of the Company's matching and profit-sharing contributions, plan earnings, and forfeitures of terminated participants' nonvested accounts. Participant accounts may also be charged with an allocation of certain administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Forfeitures are allocated by reducing the employer contributions and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon.

Vesting in the employer matching and profit sharing contributions plus actual earnings thereon is based on years of continuous service in accordance with the following schedule:

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. These options include a money market fund, growth funds, blend funds, target date funds and other funds. Participants may change their investment options daily.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, excluding the balance of Roth contributions. Loan terms may vary as determined by the plan administrator, to a maximum of five years (unless such loan is used to acquire a principal residence). The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%, determined at the date of loan issuance. Principal and interest are paid ratably through regular payroll deductions.

Payment of Benefits

Any benefit payable under the Plan to a participant (or spouse or beneficiary, if applicable) may be made in the form of a lump-sum distribution or partial withdrawals and installments under certain conditions. Distributions may be caused by one of the following events:

- attainment of normal retirement age (the later of the date which a participant reaches 64 years of age or the 3rd anniversary of the first year in which participation on the Plan commenced);
- death during employment;
- termination of employment; and
- attainment of age 70½ regardless of employment status.

Withdrawals

Participants under age 59½ may withdraw all or part of their pre-tax, Roth, and rollover contributions in cases of hardship. The hardship withdrawal is subject to the consent of the plan administrator. Participants may not withdraw other portions of their individual account balance until termination of their employment.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,212 and \$94, respectively. These accounts may be used to reduce future employer contributions and administrative expenses. During 2024, employer contributions were reduced by \$16,300 from forfeited non-vested accounts.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent loans are treated as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses incurred to maintain the Plan are paid directly by the Company and are excluded from these financial statements. Loan servicing and distribution fees are charged to the account balances of those participants initiating such transactions and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued.

(3) Financial Information Certified by the Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments at fair value and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (John Hancock), a qualified institution.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

(4) Fair Value Measurements, Continued

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value (NAV) of units held by the Plan at year end based on the market value of its underlying investments. Although the pooled separate accounts are not available in an active market, the NAV of the units are approximated based on the quoted prices of the underlying investments that are traded in an active market.

Certain investments measured at NAV per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy.

There were no significant transfers among investment levels during the years ended December 31, 2024 and 2023.

(5) Related Party Transactions and Party-In-Interest Transactions

Plan administration services are performed by Paragon Alliance Group, LLC (Paragon). Paragon is the recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules. Plan fees and expenses may be paid by the Plan or by the Company.

Certain plan investments are shares of pooled separate accounts managed by John Hancock. John Hancock is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments. Fees paid by the Plan to John Hancock and Paragon for plan administration services, transaction fees, loan fees and benefit payment fees amounted to \$20,353 for the year ended December 31, 2024.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their employer contributions.

(7) Tax Status

The Plan uses a prototype plan document sponsored by Paragon. The Internal Revenue Service (IRS) has informed Paragon by a letter dated June 30, 2020, that the non-standard prototype plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Prohibited Transactions

During 2022, the Company failed to remit to the Plan's custodian certain employee contributions within the period prescribed by the Department of Labor regulations. The contributions were remitted to the Plan during 2022, and the lost earnings on the delinquent contributions were remitted to the Plan during 2024.

(9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
