Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Global Industrial Company 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedules Required by ERISA

The supplemental schedule of assets held at end of year as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

NOTE A - Description of Plan

The following description of Global Industrial Company 401(k) Plan, (the "Plan"), and related programs of Global Industrial Company and its domestic subsidiaries (collectively the "Company") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was originally established on January 1, 1987 and is a defined contribution 401(k) plan for the exclusive benefit of all full-time employees who meet minimum age and service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants must have more than one month of service with the Company and be at least 21 years old in order to contribute a percentage of their annual compensation through either deferral or Roth not to exceed 60% of compensation, subject to the maximum contributions allowable under the Internal Revenue Code. In accordance with the amended plan, the Company makes matching contributions equal to 37.5% of the amount of a participant's salary reduction contribution up to 6% of compensation. The Company made matching contributions of \$1,961,371 for the year ended December 31, 2024. The Company can also make a discretionary profit sharing contribution, the amount of which is determined by management. No discretionary profit sharing contribution was authorized for the year ended December 31, 2024. A participant must complete 1,000 hours of service and be employed by the Company as at the last day of the plan year to be eligible for the discretionary profit sharing contribution. Employer's matching contributions are allocated to each participant based on the amount of his salary reduction contribution to the Plan and discretionary profit sharing contributions are allocated as a percentage of each eligible active participant's compensation plus a percentage of each eligible active participant's compensation in excess of the Social Security taxable wage base for the plan year ("integration level"). Excess deferral contributions made by participants in 2024 amounted to \$16,119. This amount was refunded on March 7, 2025 in order to satisfy the relevant nondiscrimination provisions of the Plan. Due to its trivial nature, this amount was not included in the statement of changes in net assets available for benefit for the year ended December 31, 2024, and instead will be recognized in 2025.

The Plan includes a qualified automatic contribution arrangement, pursuant to which all eligible employees are enrolled automatically with a 6% tax-deferred contribution rate unless the employee elects otherwise. These contributions are invested in the Plan's default investment option unless the employee makes a different investment election. The default investment option is the Fidelity Freedom Fund closest to the participants projected retirement date at age 65. Employees may opt out of the automatic enrollment, stop contributions, modify their contribution rate or type, or change their investment allocation at any time.

Participant Accounts

Each participant's account is credited with the participant's contribution and earnings and allocations of the Company's contribution. Forfeited balances of terminated participants' nonvested accounts are used to reduce Company contributions, which are allocated as discussed above.

Vesting

Participants are immediately vested in their contributions and the earnings thereon. The Company's discretionary and matching contributions, plus the earnings thereon, vest according to the schedule below. For purposes of computing years of vesting service, an employee must have completed at least 1,000 hours of service in any plan year. However, upon the participant's death, disability or attainment of age 65, all amounts are immediately vested.

Notes Receivable from Participants

The Plan allows participants to borrow from their account a minimum of \$1,000 and a maximum of up to 50% of the vested value of their account balance. However, outstanding loans under the Plan may not exceed \$50,000 per participant. Loans, which are evidenced by a promissory note, bear interest at the prime rate plus 1% which is fixed at the date of the loan. Repayment is required in level payments over a period not to exceed five years, unless the loan qualifies as a home loan in which case the repayment period is not to exceed ten years. Participant loans are carried at their unpaid principal balance plus any accrued but unpaid interest.

Withdrawals

Withdrawals of all vested amounts may be made after a participant attains 59 ½ years of age or if the withdrawal is for reason of hardship (as defined).

Payment of Benefits

On termination of service due to death, disability or retirement, a participant, or the participant's beneficiary, if due to death, is to receive the vested value of their account in either a lump sum, if the account balance is less than \$5,000 or, at the participant's discretion, an annuity contract or lump sum, if the account balance is greater than \$5,000.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$655,575 and \$375,548, respectively. These accounts will be used to reduce future employer contributions.

NOTE B - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles may require the plan administrator to make certain estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. The shares of registered investment companies are valued at quoted market prices, which represent the net asset values ("NAVs") of shares held by the Plan at year-end. The Plan invests in the Fidelity Managed Income Portfolio ("MIP") stable value common collective trust fund. The Plan's interest in the MIP is valued at the NAV practical expedient of the underlying investments reported by the issuer of the common collective trust at year-end. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from reported net asset value. The underlying assets owned by the MIP consist primarily of readily marketable fixed income securities. Securities traded on a national securities exchange are valued at the last reported sales price on the last business day of the Plan year.

Purchases and sales of securities are recorded as of their trade-date. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. See Note C for discussion of fair value measurements.

Notes Receivable from Participants

Notes receivable from participant's loans are carried at their unpaid principal balance plus any accrued but unpaid interest. The interest rate is 4.25% to 9.50% on all outstanding loans during 2024. As of December 31, 2024, the due dates on the outstanding loans range from one month to one-hundred-twenty months. Delinquent participant loans are reclassified as distributions upon the terms of the Plan document.

NOTE B - Summary of Significant Accounting Policies (Continued)

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding charge to corrective distributions in the statement of changes in net assets available for benefits if the refund takes place prior to March 15 of the subsequent calendar year. If the refund occurs subsequent to March 15 of the subsequent calendar year, the corrective distributions are recognized in the year the distribution takes place in the statement of changes in net assets available for benefits. No excess contribution payable was recorded at December 31, 2024 or 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has considered subsequent events occurring through September 16, 2025, the date the financial statements were available for issuance, in evaluating its estimates and in the preparation of its financial statements.

NOTE C - Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits.

The Financial Accounting Standards Board standard on "*Fair Value Measurements*" establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 is observable information for similar items in active or inactive markets, and Level 3 inputs are unobservable inputs to be used in situations where markets don't exist or are illiquid. Level 3 has the lowest priority.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE C - Fair Value Measurements (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and considered as Level 1 investments.

Stable Value Common Collective Trust: MIP is the only stable value collective trust fund available to the Plan. The Plan uses the NAV per share of the MIP provided by the trustee as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the MIP, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner. The MIP's units are issued and redeemed daily at the constant NAV of \$1 per unit. The Fund's investment objective is stability of principal and high current income.

NOTE F - Related Party and Party-In-Interest Transactions

Certain plan investments are managed by an affiliate of Fidelity Management Trust Company, the Plan's trustee. Therefore, these transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA. The fair value of such investments aggregated \$100,900,404 and \$85,224,256 as of December 31, 2024 and 2023, respectively. Fees paid by the Plan for investment management services are netted against net appreciation in fair value of investments.

NOTE G - Termination of Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the termination of the Plan, after payment of administrative expenses, if any, the trust fund shall be used for the exclusive benefit of members and their beneficiaries and for no other purpose. In the event of plan termination, participants will become 100 percent vested in their accounts.

NOTE H - Tax Status

The Internal Revenue Service has issued a determination letter stating that the prototype Plan from which the current Plan was derived meets the requirements of Section 401(a) of the Internal Revenue Service Code ("IRC") qualifying for tax-exempt status. Therefore, a specific determination letter for the Plan has not been applied for or obtained. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
