Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the CLEAResult 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan

The following description of the CLEAResult 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of CLEAResult Consulting, Inc. and the participating employers of CustomerLink, LLC and CLEAResult Consulting Great Lakes LLC (collectively the "Company" or "Employer"). An employee becomes eligible to participate in the Plan upon attainment of age 21 and completion of one month of service. Employees who are covered under collective bargaining agreements, leased employees, non-resident aliens and employees who are residents of Puerto Rico are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants may elect to have a percentage deducted from their eligible compensation as defined by the Plan document. Participant contributions may be deducted on a pre-tax or Roth basis. The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 6% of their eligible compensation. Participants will also be auto-escalated by 1% annually, up to a maximum of 15% of annual eligible Plan compensation effective the first day of the succeeding Plan year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. A participant may elect to increase, decrease or suspend deductions according to procedures established by the Company. There is an annual limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code ("IRC").

The Company makes safe harbor matching contributions to the Plan each year in the amount required to satisfy Qualified Automatic Contribution Arrangement ("QACA") requirements under the IRC, up to the maximum amounts permitted by the IRC. The QACA Employer contribution is equal to 100% of a participant's elective deferrals not in excess 1% of the participant's eligible compensation plus 50% of each participant's elective deferrals in excess of 1% but not in excess of 6% of the participant's eligible compensation. Discretionary qualified non-elective Employer contributions were permitted prior to September 15, 2016 but are no longer permitted.

Subsequent to December 31, 2024 and 2023, the Plan remitted a true-up Employer contribution to affected participant accounts that is applicable for the 2024 and 2023 Plan years. The amount of \$173,541 and \$184,656 was funded from the Plan's forfeiture account in 2025 and 2024 and as such, is not reflected as a receivable on the statements of net assets available for benefits at December 31, 2024 and 2023.

1. Description of Plan (*continued*)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution, (b) Plan earnings (losses) thereon and (c) certain administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

Vesting

A participant is 100% vested in his or her deferral and rollover accounts including allocated earnings thereon at all times.

For any discretionary qualified non-elective contributions, the following vesting schedule applies:

Plan mergers in prior periods resulted in multiple vesting schedules related to various Employer contributions of the participating affiliate employers. Details of the various vesting schedules may be obtained in the Plan document and vesting schedule addendums. The vesting schedules apply to frozen Employer contribution sources and are tracked separately from the contributions made by the Employer.

Forfeitures

If a participant terminates their employment with the Company, the non-vested contributions plus allocated earnings thereon may be used to reduce aggregate future Employer contributions or Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$220,474 and \$175,143. During 2024, \$213,470 was used to reduce Employer contributions and \$57,950 was used to pay Plan expenses.

Notes Receivable from Participants

The Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum amount of 50% of their vested account balance or \$50,000 (whichever is less). Loans are collateralized by the balance in the participant's account and bear interest at prime rate plus 1%. The loan must be repaid within a five-year period, unless the loan is used to acquire the principal residence of the borrower, in which case repayment terms may be extended. A participant may not have more than one loan outstanding at any one time. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, age 59 1/2 or retirement, participants may elect for payment to be made in a lump sum or in an amount the participant designates from time to time. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the group annuity contract, which is stated at contract value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The common/collective trusts are valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The group annuity contract is valued at contract value, which represents contributions plus credited interest less participant withdrawals and fees.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded upon a distributable event.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in value of investments.

Reclassifications

Certain 2023 amounts have been reclassified to conform with the 2024 presentation.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 15, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively “Empower”), qualified institutions.

Group Annuity Contract, at Contract Value

The Plan invests in the Key Guaranteed Portfolio Fund (the “Portfolio Fund”) as an investment option for Plan participants. The Portfolio Fund is a general account product offered through a group annuity contract and is fully benefit-responsive. Participant principal and interest are fully guaranteed by the entire general account assets of Empower Annuity Insurance Company of America, the issuer of the Portfolio Fund. Each quarter an interest rate is established for all money, regardless of when it was deposited. The credited interest rate may stay the same or change each quarter. Participants may transfer their account balance to any other investment option offered under the Plan at any time with no restrictions or penalties.

4. Investments (continued)

Group Annuity Contract, at Contract Value (continued)

An event that limits the ability of the Plan to transact at contract value with the issuer (for example, premature termination of the contracts by the Plan, plant closings, layoffs, plan termination, bankruptcy, mergers, and early retirement incentives) and that also limits the ability of the Plan to transact at contract value with the participants in the Plan must be probable of not occurring. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

Common/Collective Trusts

The Plan offers various common/collective trusts through Great Gray Trust Company. The unit values are determined on a daily basis and amounts can be redeemed daily. The Plan has no unfunded commitments related to the common/collective trusts at December 31, 2024. The Plan did not hold investments in common/collective trusts at December 31, 2023.

5. Tax Status

The Plan's prototype plan document preparer has obtained an opinion letter dated November 14, 2022 from the Internal Revenue Service ("IRS") stating that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

6. Party-in-Interest Transactions

Certain Plan investments are managed by Empower. Empower are the trustee and custodian as defined by the Plan document and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Certain administrative functions are performed by officers or employees of the Employer at no cost to the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

7. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their Employer contributions.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
