We have performed audits of the financial statements of the Gould Paper Corporation Employees' Profit Sharing and Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). ### 1. Plan Description

The following description of the Gould Paper Corporation Employees' Profit Sharing and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan that became effective on May 29, 1957, that covers substantially all employees of Gould Paper Corporation and its participating employers (collectively, the Employer or the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is administered by the Gould Paper Corporation Employees' Profit Sharing and Retirement Plan Committee of Gould Paper Corporation. Empower Trust Company, LLC is the trustee of the Plan, having custodial responsibility for the Plan's assets. Empower Retirement, LLC is the recordkeeper of the Plan. Collectively, these entities will be referred to as Empower.

#### *Eligibility*

An employee who is 18 years or older may become a participant in the Plan on the first Plan entry date after completion of 30 days of service, having worked at least 83.3 hours of service in such 30 days, or upon completion of 1,000 hours of service within 12 consecutive months.

#### *Contributions*

Participants are permitted to contribute up to 90% of their eligible compensation on a pre-tax and after-tax basis, subject to certain limitations. Effective January 1, 2023, the Plan also allows for Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company may provide matching contributions at its discretion. For the years ended December 31, 2024 and 2023, the Employer matched 150% of each participant's pre-tax deferral contributions, up to 2% of the participant's eligible compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

#### *Vesting*

Participants are vested immediately in their contributions, plus actual earnings thereon. Participants vest in Employer contributions at the rate of 20% for each completed enrolled year in the Plan after two years of service, with 100% vesting after six years.

Additionally, each participant shall be 100% vested in Employer contributions in the case of:

- Attainment of age 65
- Total and permanent disability
- Death

### *Participant Accounts*

Each participant's account is credited with the participant's and Employer contributions, as well as allocations of investment earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific-participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Notes Receivable from Participants*

Subject to the approval of the Company, participants may obtain loans from the Plan. The minimum loan is \$1,000. The maximum that may be borrowed from the participant's account is the lesser of \$50,000 or 50% of the vested account balance. The interest rate of the loan is calculated at 1% above the prime rate determined at loan origination. Loan repayments are made through payroll deductions in equal installments over a period that may not exceed five years.

### *Payment of Benefits*

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a series of payments. Additionally, the participant may withdraw his or her elective deferrals on account of financial hardship or the attainment of age 59½.

### *Forfeitures*

Forfeitures that occur during a Plan year will be used to pay administrative expenses of the Plan, and any remaining forfeitures will be used to offset future Employer contributions.

During 2024 and 2023, forfeited amounts totaling \$118,301 and \$74,130, respectively, were used to pay administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$12, respectively.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments in the statements of changes in net assets available for benefits. Administrative expenses for the Plan totaled \$136,514 and \$105,990 for the years ended December 31, 2024 and 2023, respectively.

### *Revenue Credits*

The Plan's trust agreement with Empower provides for a participant revenue credit arrangement, whereby the trustee allocates quarterly deposits into the accounts of eligible participants who are invested in certain funds. Unallocated revenue credits at December 31, 2024 and 2023 are \$0 and \$10, respectively. During 2024 and 2023, the Plan received credits of approximately \$101,389 and \$96,844, respectively. Revenue credits are presented in other income in the statements of changes in net assets available for benefits.

### 2. Summary of Accounting Policies

#### *Basis of Accounting*

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP) and are presented on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisor and Empower. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Fees charged by the trustee relating to notes receivable from participants are paid from the participants' accounts. Delinquent notes receivable are deemed distributed and included in benefits paid to participants in the statements of changes in net assets available for benefits.

#### *Contributions*

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

#### *Payment of Benefits*

Benefits are recorded when paid.

### 3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and

dividend income, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, a qualified institution.

### 4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds* - Investments in mutual funds are valued at net asset value (NAV) of shares held by the Plan at year-end. The mutual funds are traded at quoted prices through the National Securities Clearing Corporation. These investments are priced by the Plan's custodian using nationally recognized pricing services based on observable market data.

*Self-Directed Brokerage Accounts* - These accounts consist of cash and cash equivalents, certificates of deposit, U.S. Treasury bills, money market funds, mutual funds, common stock, exchange traded funds (ETFs), and American depositary receipts (ADRs). Cash and cash equivalents and certificates of deposit are valued at amortized cost, which approximates market value. U.S. Treasury bills, money market funds, mutual funds, common stock, ETFs, and ADRs are valued at the daily closing price reported on the active market.

*Common Collective Trust (CCT)* - The CCT is valued at NAV, which is based on the fair value of the underlying investments less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions

may occur daily with no advance notice, and there are no unfunded commitments. The CCT is a direct-filing entity.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Excess Contributions

The Plan did not pass the Actual Deferral Percentage test for the years ended December 31, 2024 and 2023. Excess contributions amounted to \$121,802 and \$107,134 as of December 31, 2024 and 2023, respectively, and were accounted for as a liability with a corresponding reduction to participant contributions during 2024 and 2023. Excess contributions were reimbursed to Plan participants in February 2025 for 2024 amounts and in March 2024 for 2023 amounts.

## 6. Related Party and Party-in-Interest Transactions

As described in Note 1, the Plan paid certain expenses related to plan operations and investment activity to Empower. These transactions qualify as party-in-interest transactions, which are exempt

from the prohibited transaction rules of ERISA. Notes receivable from participants also qualify as party-in-interest transactions.

### **7. Tax Status**

The Plan uses a pre-approved plan document sponsored by Meredith J. Sesser, A Professional Corporation. Meredith J. Sesser, A Professional Corporation received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is currently designed and being operated in accordance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **8. Plan Termination**

Although it has not expressed any intent to do so, the Company may, at its discretion, discontinue contributions or terminate the Plan completely or partially at any time by delivering to the trustee a notice of complete or partial termination, specifying the date of termination of the Plan, and, in the case of a partial termination, specifying the participants affected by such partial termination. In the event of Plan termination, each participant will become 100% vested in their accounts.

### **9. Risks and Uncertainties**

The Plan's investment options are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. As of December 31, 2024 and 2023, one investment accounted for approximately 26% of total investments.

### **10. Subsequent Events**

Subsequent events have been evaluated through September 25, 2025, the date the financial statements were available to be issued. There were no subsequent events requiring adjustments to or additional disclosure in the financial statements as stated herein.
