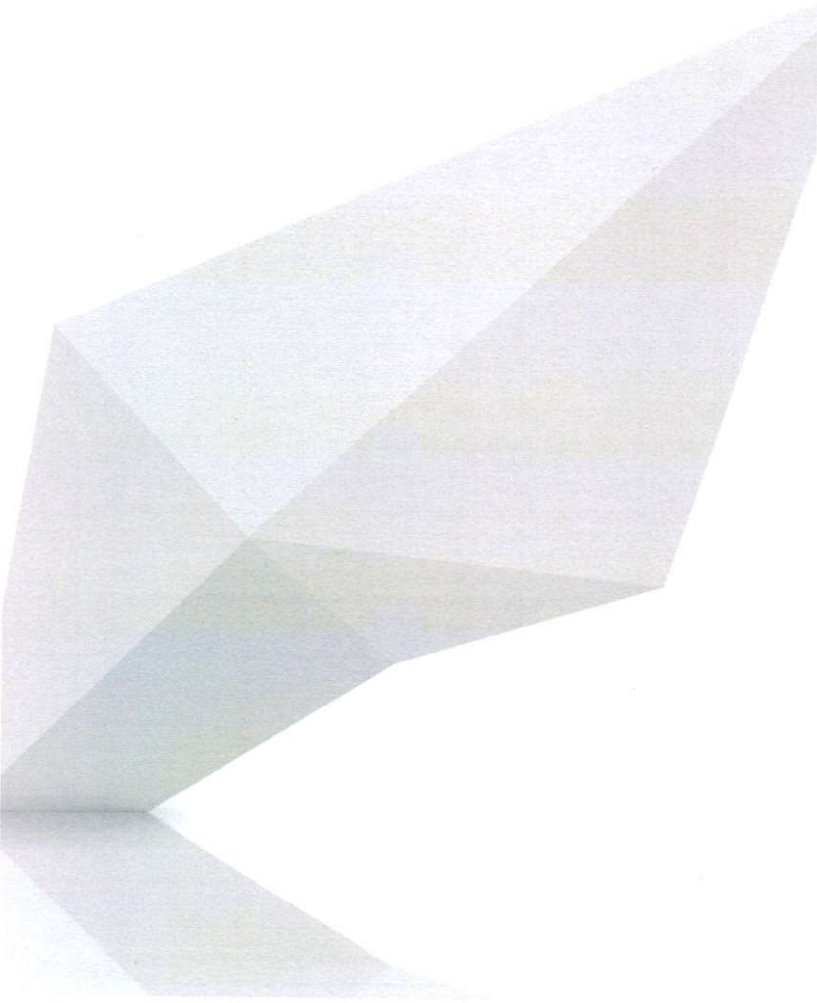

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Corza Medical 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan for eligible employees of Corza Medical Inc., and its affiliated companies who adopt the Plan (collectively referred to as "the Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

Eligibility

Employees of the Company, except union employees, non-resident aliens, leased employees and employees of the affiliate located in Puerto Rico, are eligible to participate in the Plan on the first day of their employment.

Contributions

Each year, participants may contribute, on a pre-tax or Roth after-tax basis, up to 80% of their annual compensation, as defined by the Plan, up to dollar amounts permissible under the Internal Revenue Code (IRC). The Plan also allows catch-up contributions, on a pre-tax or Roth after-tax basis, by participants age 50 or older, subject to certain IRC limitations, and allows for rollover contributions from other qualified sources, as defined by the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for the Company to make safe harbor matching contributions to eligible participants in an amount equal to 100% of the participant's deferrals up to 3% of eligible compensation, plus 50% of the participant's deferrals on their next 2% of eligible compensation. The Company made safe harbor contributions of \$1,435,431 for the year ended December 31, 2024. The Plan also provides for Company discretionary contributions allocated on a pro-rata basis of compensation to participants who have completed in the Plan year a minimum of 1,000 hours of service, as defined by the Plan, and who are employed on the last day of the Plan year. No discretionary Company contribution was made for the year ended December 31, 2024.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, Company safe harbor matching contributions, and allocations of (a) the Company's discretionary contributions, if any, and (b) Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately vested in their pre-tax contributions, after-tax Roth contributions, rollover contributions and Company safe harbor matching contributions, plus actual earnings (losses) thereon. Vesting in Company discretionary contributions, if any, plus actual earnings (losses) thereon, is based on a participant's years of service, vesting at a rate of 20% per year, with a participant being fully vested after five years of service. In the event of death, total disability, or reaching normal retirement age (age 65), participants' accounts become 100% vested.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,125 and \$9,117, respectively. Forfeitures are portions of participants' accounts that participants surrender by terminating employment prior to becoming fully vested. These accounts will be used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the Plan document. Forfeitures amounting to \$4,827 were used to pay Plan expenses during 2024.

Notes Receivable from Participants

Plan participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the vested portion of the participant's account balance or \$50,000. The notes are secured by the vested balance in the participant's account, bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Administrator, and are repaid ratably through payroll deductions. Interest rates on notes outstanding at December 31, 2024 ranged from 4.25% to 9.50%. A participant may have only one loan outstanding at any given time.

Payment of Benefits

On termination of service due to disability, retirement, or for other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in their account in the form of a lump sum payment or, upon a participant's death, by payment options as defined in the Plan. In addition, while still employed by the Company, the Plan allows for in-service withdrawals by participants who have attained the age of 59 ½ from the vested portion of their account balance. The Plan also allows for hardship withdrawals for specific situations as defined by the Plan. At December 31, 2024, there were no amounts owed to former participants whose employment had been terminated and who requested payout of their account balances.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 (SECURE 2.0), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Plan management has evaluated those provisions and determined there is no material impact on the Plan for the years ended December 31, 2024 and 2023. Plan management will evaluate and determine which optional provisions, if any to elect in the future.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2: Summary of Significant Accounting Policies (Continued)

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in investment income.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through September 26, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan adopted an automatic enrollment provision whereby newly eligible and rehired employees who do not elect an initial deferral rate or do not opt out of Plan participation will be automatically enrolled in the Plan at a 3% pretax deferral rate and their contribution will be invested into the Plan's qualified default investment alternative, until changed by the participant.

Note 3: Information Prepared and Certified by the Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Charles Schwab Trust Bank, the Trustee of the Plan.

Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted market prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Note 4: Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Primarily consist of mutual funds and common stock, which are valued at the daily closing price as reported by the fund or active market on which the individual securities are traded. The mutual funds held in the self-directed brokerage accounts are deemed to be actively traded.

Money market deposit account: Valued at cost, which approximates fair value, and is a capital preservation vehicle that bears interest at a reasonable rate as determined monthly by Charles Schwab Trust Bank. The crediting interest rate for the period from January 1, 2024, to December 31, 2024, ranged from 1.69% to 1.98%.

Common collective trust funds: A stable value fund that is valued at the NAV of units of the collective trust as provided to the Plan administrator by the trustee of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawals from the trust in order to ensure that securities' liquidations will be carried out in an orderly business matter.

Note 5: Tax Status

The Company adopted a restated and amended Prototype Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan ("Prototype Plan") sponsored by Schwab Retirement Plan Services, Inc. The Prototype Plan obtained its latest determination letter on September 21, 2020, in which the Internal Revenue Service (IRS) stated that the Prototype Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not requested its own IRS determination letter. The Plan has been amended since receiving the determination letter; however, the Plan Administrator believes the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 6: Related-Party and Party-In-Interest Transactions

Certain Plan investments and other Plan assets are managed by Charles Schwab Trust Bank, the Trustee, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. Additionally, Schwab Retirement Plan Service, Inc. provides administrative and Plan recordkeeping services. These transactions are not considered prohibited transactions under the ERISA regulations. Fees paid by the Plan to the Trustee for investment advisory and other administrative and recordkeeping expenses amounted to \$79,845 for the year ended December 31, 2024. Fees of \$19,400 incurred and paid by the Plan to its independent accountant for attest services also qualify as party-in-interest transactions. In addition, certain administrative functions are performed by employees of the Company, for which no compensation is received from the Plan for their services.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 7: Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company discretionary contributions.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
