Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Q-Lab Corporation Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Q-Lab Corporation Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Q-Lab Corporation Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Q-Lab Corporation Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE 1 - PURPOSE AND DESCRIPTION OF PLAN

The Q-Lab Corporation Retirement Plan (the Plan), adopted in 1974, is a defined contribution plan covering all eligible personnel in the employ of Q-Lab Corporation and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All eligible employees become participants on the first day of the month following their employment date.

The Plan includes a cash-or-deferred-arrangement provision pursuant to Section 401k of the Internal Revenue Code. Under this provision, each deferring participant may contribute up to seventy-five percent (75%) of compensation, subject to annual deferral limits with catch-up contributions for eligible participants allowed. In 2023, the plan eliminated discretionary matching contributions to non-management employees in the sponsor's Florida and Arizona locations. The plan does allow for a discretionary non-elective employer contribution. Eligibility to receive an allocation of the employer's discretionary non-elective contribution requires at least one thousand (1,000) hours of service during a plan year as well as being employed as of the last day of the plan year.

Participants should refer to the plan document for a more complete description of the Plan's provisions.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Adoption of New Accounting Standard - Effective January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13, Financial Instruments - Credit Losses (Topic 326). This standard replaced the incurred loss methodology with an expected methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of credit losses using historical experience, current conditions, and reasonable and supportable forecasts and generally applies to financial assets measured at amortized cost. Financial assets measured at amortized cost will be presented at the net amount expected to be collected by using an allowance for credit losses.

The Plan adopted Accounting Standards Codification (ASC) 326 and all related subsequent amendments thereto effective January 1, 2023, using the modified retrospective approach for all financial assets measured at amortized cost which did not have a material impact on the financial statements.

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting.

Contributions – The Plan provides for discretionary contributions determined by the plan sponsor annually. Allocation of the plan sponsor's contribution to eligible employees is based on participant wages. For the plan years ended December 31, 2024 and 2023, discretionary contributions to the plan were \$1,008,825 and \$752,848, respectively. Annual average deferral percentage compliance testing may result in required distributions to certain highly compensated participants subsequent to the end of a plan year. For the plan years ended December 31, 2024 and 2023, excess deferrals totaling \$42,902 and \$1,838, respectively, were reported as a liability and a reduction against employee deferrals for the plan years then ended.

Investment Options – Upon enrollment in the Plan, a participant may direct employer contributions to any of the investment fund options offered by the Plan. Participants may change their investment options and transfer funds between investment options daily.

Valuation of Investments – The Plan's investments are reported at fair value based on the quoted market price of the funds held by the Plan at year end, except as otherwise disclosed.

Participant Accounts - Each participant's account is maintained separately within the plan and is credited with their elective deferrals, employer contributions and earnings. Allocations of employer contributions, investment income and administrative expenses are based on a participant's compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting – Participants are immediately vested in contributions made pursuant to the cash-or-deferred arrangement plus earnings thereon. The Company's discretionary contribution and related earnings is subject to vesting based on the elapsed time method. The elapsed time method uses a period of service, rather than hours of service, to compute years of service for vesting purposes. A service year is based on the duration of employment by an employee with the employer and uses only whole years of service. A participant is 100% vested after six years of service or their normal retirement date. Forfeited balances of terminated participants' non-vested accounts are allocated to participants receiving an allocation of the discretionary contribution. The amount of such forfeited balances not yet allocated as of December 31, 2024 and 2023 totaled \$38,373 and \$36,804, respectively.

Administrative Fees – The Plan sponsor pays certain administrative fees on behalf of the Plan.

Payments of Benefits – On termination of service, death, disability, or retirement, a participant may receive a lump-sum amount equal to the vested value of their account or receive installment payments not to exceed the life expectancy of the participant or their beneficiary. Hardship distributions are not permitted

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

NOTE 3 – INVESTMENTS

All investment information disclosed in the accompanying financial statements and schedule, including investments held at December 31, 2024 and 2023, and net appreciation of common collective trust, dividends, and interest for the year ended December 31, 2024, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company.

The Plan's investment in the Fidelity Managed Income Portfolio, a common collective trust, is a fully benefit-responsive investment contract intended to provide preservation of principal while earning a level of interest income consistent with capital preservation while providing liquidity at contract value for participant withdrawals and transfers. Contract value, however, is the relevant measurement attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate transactions under the terms of the plan.

NOTE 4 – FAIR VALUE

Financial Accounting Standards Board ASC 820-10-05, *Fair Value Measurements* (ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Observable inputs (other than level 1) including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 5 – INCOME TAX STATUS

With the adoption of the Fidelity Volume Submitter Profit Sharing Plan with CODA (a defined contribution plan) the plan sponsor determined that it is eligible to and has chosen to rely on the volume submitter plan opinion letter. This plan received an opinion letter from the IRS stating that the form of the plan is qualified under Section 401 (a) of the Internal Revenue Code (Code), and therefore, the related trust is tax exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the IRS; however, to the Plan administrator's knowledge, there are currently no audits in progress for any tax periods.

NOTE 6 – TRANSACTIONS WITH PARTIES IN INTEREST

Transactions with parties in interest include the plan sponsor and purchases and sales of Fidelity Investments. Fees paid during the year for services rendered by Fidelity were based on customary and reasonable rates for such services. Other than as described above, the Plan has no agreements or transactions with any parties in interest.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent (100%) vested in any portion of their accounts not already fully vested.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 – SUBSEQUENT EVENTS

The Plan evaluated events occurring between the end of the plan year and September 22, 2025, the date the financial statements were available to be issued. No recognized or unrecognized subsequent events have occurred through this date.
