Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

## Notes to the Financial Statements

### 1. Description of the Plan

The following description of the Haydon Holdings, LLC and Subsidiaries Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), which became effective August 1, 1972 and was amended and restated effective December 31, 2018. In addition, the Plan was established in accordance with the Davis-Bacon Act (the Act), which requires certain levels of fringe benefits to be paid to employees working on federally funded projects covered by the Act. The Plan was also established in accordance with prevailing wage requirements for certain state funded projects. The Profit Sharing Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

#### Eligibility

The Plan covers all eligible employees of Haydon Holdings, LLC and its subsidiaries (the Plan Sponsor and Administrator), excluding leased employees, nonresident aliens, and interns. Participants who are over 18 years of age are eligible to participate in the Plan including an employer match on the first day of the month following two months of service. Participants are eligible for employer profit sharing contributions on the first day of January or July after 1 year of service. Employees who do not meet the above eligibility requirements become participants on the date on which work is begun on a project subject to the Act or similar state law, when such employees' level of pay does not already include certain fringe benefits.

#### Contributions

Participants may contribute up to the maximum allowable annual contribution as defined by the Internal Revenue Code (IRC) including Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated lifestyle fund until changed by the participant. Additionally, effective October 1, 2023, all participants who are deferring at least 1% of compensation will have an automatic escalation of 1% on the first day of each Plan year until the amount withheld from each payroll period reaches 7% of the employee's compensation, unless the employee makes a contrary election. Participants direct the investment of their contributions into various investment options offered by the Plan.

## 1. Description of the Plan, continued

### Contributions, continued

Plan Sponsor prevailing wage contributions are funded based on compensation by specific job classifications as stated in projects subject to prevailing wage laws. The Plan Sponsor made discretionary matching contributions equal to 100% of the first 4% of compensation contributed by the participant during the years ended December 31, 2024 and 2023. The Plan Sponsor may also elect to contribute a discretionary profit sharing contribution, to be determined by the Plan Sponsor, not limited to current or accumulated net profits. During the years ended December 31, 2024 and 2023, the Plan Sponsor made a profit sharing contribution to the Plan of \$324,000 and \$339,000, respectively.

### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution and the Plan Sponsor's contributions, an allocation of Plan earnings or losses, and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. Administrative expenses are charged to each participant's account when a benefit distribution is processed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. If no such direction is made, participant accounts are invested in accordance with default investment alternatives as established under the Plan. The Plan Sponsor's contributions are automatically invested in the same investment options at the same percentage as participant deferral contributions.

### Vesting

Participants are vested immediately in their contributions and the Plan Sponsor's prevailing wage contributions made on their behalf, plus actual earning thereon. Vesting in matching contributions plus actual earnings and employer discretionary profit sharing contributions and earnings on those contributions is based on the years of service outlined in the following table:

If a participant dies or becomes disabled, he or she is automatically 100% vested in all accounts.

## 1. Description of the Plan, continued

### Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant whose vested account balance is greater than \$5,000 may elect to receive either a single lump sum amount equal to the value of the participant's vested interest in his or her account, or a single sum payment of a portion of the participant's vested interest in his or her account. On termination of service, a participant whose vested account balance is not greater than \$5,000 will receive his or her benefits as a single lump sum payment. Hardship withdrawals are permitted by the Plan.

### Forfeited Accounts

All forfeitures are applied to matching contributions, profit sharing contributions and Plan expenses. As of December 31, 2024 and 2023, forfeited accounts totaled \$53,199 and \$66,515, respectively. During 2024, forfeitures were used to reduce Plan expenses and Plan Sponsor contributions.

### Risks and Uncertainties

The Plan provides for participant directed investment options in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

### Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan as provided in the Plan document. All other administrative expenses are paid by the Plan Sponsor.

## 2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value with the exception of fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

### 2. Summary of Significant Accounting Policies, continued

#### Investment Valuation and Income Recognition, continued

Contract value is the relevant measurement for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan's Profit Sharing Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee and insurance company.

#### Contributions

Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld.

#### Payment of Benefits

Benefit payments to participants are recorded upon distribution. As of December 31, 2024 and 2023, there were no outstanding payments to persons electing to withdraw from the Plan.

#### Subsequent Events

The Plan's management has evaluated subsequent events for accounting and disclosure requirements through September 11, 2025, the date that the financial statements were available to be issued.

### 3. Information Certified and Provided by Custodian

The Plan's asset information included in this note and throughout the Plan's financial statements and supplemental schedule was prepared by or derived from information provided by the Transamerica Life Insurance Company Inc. (Transamerica), the custodian of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that asset information provided to the Plan Administrator by the custodian is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) *Rules and Regulations for Reporting and Disclosure* under ERISA, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to asset information in this note and which appears throughout the financial statements and the supplemental schedule.

Transamerica also certified to the completeness and accuracy of \$2,697,620 of net realized and unrealized appreciation in the fair value of mutual funds and \$14,049 of interest and dividends related to the investments for the year ended December 31, 2024.

### 4. Investment Contract with Insurance Company

The Plan has a fully benefit-responsive contract (referred to as the Stable Value Fund) with Transamerica. Transamerica maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value, as reported to the Plan by Transamerica. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (iii) bankruptcy of the Plan Sponsor or other Plan Sponsor event (e.g., divestitures or spin-offs of a subsidiary) that causes a significant withdrawal from the Plan; or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

### 4. Investment Contract with Insurance Company, continued

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average yield and crediting interest rates were approximately 1.58% and 1.25% for the years ended December 31, 2024 and 2023, respectively. Assets allocated to the Stable Value Fund during a contract period have a maturity date (typically a 6-month maturity period). At the beginning of each contract period, Transamerica establishes the following for new deposits, transfers and maturing assets allocated to the Stable Value Fund during that period: (a) a declared interest rate, which will be credited through the end of that period, and (b) a minimum guaranteed interest rate, which will be in effect through the end of the maturity period, typically 6 months. In addition, at the beginning of each contract period, Transamerica establishes the declared interest rate for the existing assets, which will equal at least the applicable guaranteed rate. The rates established are based on the best estimate of the return on investments to be made with respect to the contract period and may fluctuate in following years to reflect actual investment results.

### 5. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Pooled separate accounts:* Valued at net asset value (NAV) per share based on quoted market prices of underlying investments.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with Accounting Standards Codification Subtopic 820-10, certain investments that were measured at NAV per share have not been classified in the fair value hierarchy. The fair value amounts presented in the tables above are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The pooled separate accounts have no unfunded commitments and can be redeemed daily, with no redemption notice period, without specific terms or conditions at the underlying investments' net asset value. The net asset value is updated daily.

### 6. Exempt Party-in-Interest Transactions

Certain Plan investments are units of pooled separate accounts and a stable value option account managed by Transamerica. Transamerica is the custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest. Administrative expenses of \$85,254 for the year ended December 31, 2024 are comprised of fees paid by the Plan to Transamerica for investment management services and withdrawal charges.

Additionally, indirect fees are paid to Transamerica based on investment account values. These fees range from 0.00% to 0.99% of the investment account value. The fees reduce net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

### 7. Tax Status

The Plan uses a prototype Plan document sponsored by Transamerica. Transamerica received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

### **8. Plan Termination**

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.
