## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

### 1. DESCRIPTION OF PLAN:

The following description of the ST Engineering Hackney, Inc. 401(k) Retirement Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan covering all employees of ST Engineering Hackney, Inc. (“the Company”) who meet the age and service requirements of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Company. Ascensus (“Custodian”) serves as the custodian of the Plan.

#### Plan Amendments

On June 8, 2020, the Plan Sponsor’s Board of Directors approved to change the name of the plan from VT Hackney, Inc. 401(k) Retirement Plan to ST Engineering Hackney, Inc. 401(k) Retirement Plan, effective September 1, 2019. This was in conjunction with the Plan Sponsor’s legal name change from VT Hackney, Inc. to ST Engineering Hackney, Inc. on June 21, 2019.

#### Contributions

Participants may contribute up to the lesser of the maximum allowed by law, or 100% of eligible compensation, as defined in the Plan. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans as rollover contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Matching contributions may be contributed at the discretion of the Company’s board of directors. Participants also direct their matching contribution amounts into the various investment options offered by the Plan. Effective June 8, 2020, the Company’s board of directors approved to suspend the discretionary employer matching contribution due to economic conditions related to the global pandemic and was effective on the payroll checks dated June 19, 2020. The Company reinstated the match in April 2022. The Company contributes 30% of the first 6% of base compensation that a participant contributes to the Plan. During the year ended December 31, 2024 and 2023, the Company made \$210,739 and \$203,971 in matching contributions, respectively.

### 1. DESCRIPTION OF PLAN: (Continued)

#### Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contributions and Plan earnings, and is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are always 100 percent vested in their contributions and any rollover contributions in their account. Participants are also 100% vested in the Company's matching contributions plus actual earnings thereon.

#### Notes Receivable from Participants

Participants may borrow from their account up to fifty percent of their vested balance with a minimum of \$1,000 and a maximum of \$50,000. The loans are secured by the balance in the participant's account and bear interest rates at the Prime rate plus 1% and up depending on the loan. The rates were 4.25 percent to 9.50 percent on loans in 2024 and mature through 2029. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

Benefits are paid upon retirement, death, disability, or termination of employment. On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the vested interest in the account or periodic payments over a defined period of time, which may not exceed life expectancy. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution. Employees that terminate employment and have a vested account balance under \$1,000, receive an automatic rollover of their account balance into an IRA account. All fully vested account balances are available for distribution if the participant reaches the age of 59 ½. Hardship distributions are permitted as well.

#### Forfeited Accounts

Forfeitures of the non-vested portion of terminated participants' accounts may be used to reduce the employer's contribution or to pay the administrative costs of the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,872 and \$2,799, respectively. No forfeitures were allocated as additional employer contributions in plan years ending December 31, 2024 and 2023.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee or custodian of the Plan. See Note 4 for discussion of fair value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

#### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the \$4,778 excess 2024 contributions to the applicable participants prior to March 15, 2025. The Plan distributed the \$43,901 excess 2023 contributions to the applicable participants prior to March 15, 2024.

#### Payment of Benefits

Benefits are recorded when paid.

#### Expenses

Certain expenses relating to maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees relating to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### Subsequent Events

The Company has evaluated events from December 31, 2024 through September 18, 2025, which is the date that the financial statements were available to be issued.

### 3. INFORMATION CERTIFIED BY CUSTODIAN: (Unaudited)

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the Trustee, Ascensus Trust Company, as complete and accurate except for comparing such information certified by the Trustee, Ascensus Trust Company, to information included in the Plan's financial statements and supplemental schedules.

### 4. FAIR VALUE MEASUREMENTS:

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements.) Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Stable Value Common Collective Trust Fund:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Common Collective Trust Funds:* Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value.

The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawals from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**6. PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

**7. PARTY-IN-INTEREST TRANSACTIONS:**

Participants are directly charged by Ascensus for recordkeeping services such as loan and distribution processing and other asset-based management commission fees. Custodian fees reported by Ascensus were \$32,511 and \$25,822 for the years ending December 31, 2024 and 2023, respectively. One Digital Investment advisors was paid \$21,678 and \$19,499 for investment advisory fees for the years ended December 31, 2024 and 2023, respectively. All other administrative expenses are paid by the Company.

**8. INCOME TAX STATUS:**

On March 1, 2021, the Plan adopted the Ascensus Non-Standardized Pre-Approved Profit Sharing Plan with CODA which received its latest determination letter on June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore, believe the Plan is qualified, and the related trust is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service and the North Carolina Department of Revenue.
