### ***Opinion***

**Note 1. Description of Plan**

The following description of BayFirst National Bank fka First Home Bank (the “Company”) Employee Stock Ownership Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. BayFirst Financial Corp. (the “Parent Company”) is the parent company of BayFirst National Bank.

***General***

The Company established the Plan effective as of January 1, 2018. The Plan operates as an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (the Code) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan houses units of the Parent Company’s shares as contributed by the Company and holds the stock in a trust established under the Plan. Contributions are allocated to participant accounts based on a percentage of eligible wages.

The Plan purchased Parent Company common shares using the proceeds of borrowings from the Parent Company and holds the stock in the BayFirst National Bank Employee Stock Ownership Trust (“Trust”) established under the Plan. The borrowing is to be repaid by Company contributions to the Trust. As the Plan makes each payment of principal, an appropriate percentage of stock will be allocated to eligible employees’ accounts in accordance with applicable regulations under the Code.

The borrowing is collateralized by the unallocated shares of stock. The Company has no rights against shares once they are allocated under the ESOP. Accordingly, the financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to:

- (A) The accounts of employees with rights in allocated stock (“Allocated”), and
- (B) Stock not yet allocated to employees (“Unallocated”).

***Eligibility***

Employees of the Company are generally eligible to participate in the Plan after attainment of age 18 and completion of two months of service. Certain Company branch cost centers are excluded from eligibility. Participants who do not have at least 1,000 hours of service during such plan year or are not employed on the last working day of a plan year are generally not eligible for an allocation of Company contributions for such year. An eligible employee will still receive an allocation of the Company contributions for a plan year if employment is terminated on account of retirement, death, or disability in such year.

***Participant Accounts***

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant’s account is credited as of the last day of each plan year with an allocation of shares of the Parent Company’s common stock released by the trustees from the unallocated account and forfeitures of terminated participants’ non-vested accounts. Contributions are determined annually by the Board of Directors in addition to the principal payment related to the loan payable. Plan earnings are allocated to each participant’s account based on the ratio of the participant’s beginning of the year account balance to all participants’ beginning of the year account balances. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation of stock. Allocations of stock are based on a pre-determined percentage of an individual’s eligible compensation for the plan year.

***Contributions***

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends, if any, and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. Employee contributions are not permitted. For the year ended December 31, 2024, the Company contributed \$156,878, which consisted of \$156,878 for the loan payments.

***Vesting***

If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on total years of service in the Plan. A participant is 20 percent vested after two years of credited service and are 100 percent vested after five years of credited service.

***Payment of Benefits***

Distributions of benefits are made in cash. In the event of retirement, total disability or death of a participant, benefits will commence no later than the last day of the Plan year following the Plan year on which a participant retires, suffers a disability, or dies while employed by the Company. Distributions related to terminations may commence no later than one year after the end of the fifth Plan year following the Plan year in which the participant separated from service. The full benefits will be paid in either a lump sum, in five substantially equal annual installments, or in as many substantially equal annual installments as permitted under Code Section 409(o)(1)(C)(ii).

***Plan Termination***

The Company reserves the right to terminate or amend the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Employee Benefits Administration Committee shall direct the trustees to pay all liabilities and expenses of the trust fund.

***Put Option***

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants, includes a put option. The put option is a right to demand that the trust buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The trust can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

***Diversification***

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Parent Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth Plan Year, the participant may diversify up to 50%.

***Forfeitures***

At December 31, 2024 and 2023, there were no forfeited non-vested accounts. Non-vested shares are not considered to be forfeited by the participant until after a 5-year break in service. After the break in service requirement is met, the non-vested shares shall be allocated to remaining eligible participants. During the year ended December 31, 2024, the Company allocated 1,029.02 shares to remaining eligible participants, and they did not reinstate any shares for rehires.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

### ***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded on the payment date. Net change in value includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

### ***Payment of Benefits***

Benefits are recorded upon distribution.

### ***Administration of Plan Assets***

The Plan’s assets, which consist principally of Parent Company common shares, are held by the trustee of the Plan. Company contributions are held and managed by the trustee, which invests cash received, interest, and dividend income and makes distributions to participants.

### ***Administrative Expenses***

Plan expenses are paid by the Company. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

### ***Subsequent Events***

The Plan has evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued.

**Note 4. Fair Value Measurements**

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

**Parent Company Common Stock**

The fair value of the Parent Company common stock was based on the closing stock price of the Parent Company on the date of valuation.

**Note 5. Loan Payable**

In November 2021, the Plan purchased 14,154 Parent Company common shares for \$386,288. The Plan financed this purchase through a note agreement with the Parent Company. The loan agreement provides for the loan to be repaid over 5 years with principal and interest payments of \$85,306 due each year starting December 31, 2022. The loan bears interest at the rate of 3.25%. The loan balance was \$162,641 and \$240,142 at December 31, 2024 and 2023, respectively.

In June 2023, the Plan purchased 23,383 Parent Company common shares for \$329,233. The Plan financed this purchase through a note agreement with the Parent Company. The loan agreement provides for the loan to be repaid over 5 years in approximately equal annual payments of principal and interest. The loan bears interest equal to the Prime Rate, adjusted once annually on the first day of each calendar year. The loan balance was \$205,457 and \$263,503 at December 31, 2024 and 2023, respectively.

## **Note 6. Exempt Party-In-Interest Transactions**

Certain plan investments are shares held by the plan sponsor; therefore, these transactions qualify as exempt party-in-interest transactions.

## **Note 7. Tax Status**

The Internal Revenue Service (the "IRS") has determined and informed the Company by letter dated September 30, 2019, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (the "IRC"). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **Note 8. Risks And Uncertainties**

The Plan invests in investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statement of Net Assets Available for Benefits.

**Note 1. Description of Plan**

The following description of BayFirst National Bank fka First Home Bank (the “Company”) Employee Stock Ownership Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. BayFirst Financial Corp. (the “Parent Company”) is the parent company of BayFirst National Bank.

***General***

The Company established the Plan effective as of January 1, 2018. The Plan operates as an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (the Code) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan houses units of the Parent Company’s shares as contributed by the Company and holds the stock in a trust established under the Plan. Contributions are allocated to participant accounts based on a percentage of eligible wages.

The Plan purchased Parent Company common shares using the proceeds of borrowings from the Parent Company and holds the stock in the BayFirst National Bank Employee Stock Ownership Trust (“Trust”) established under the Plan. The borrowing is to be repaid by Company contributions to the Trust. As the Plan makes each payment of principal, an appropriate percentage of stock will be allocated to eligible employees’ accounts in accordance with applicable regulations under the Code.

The borrowing is collateralized by the unallocated shares of stock. The Company has no rights against shares once they are allocated under the ESOP. Accordingly, the financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to:

- (A) The accounts of employees with rights in allocated stock (“Allocated”), and
- (B) Stock not yet allocated to employees (“Unallocated”).

***Eligibility***

Employees of the Company are generally eligible to participate in the Plan after attainment of age 18 and completion of two months of service. Certain Company branch cost centers are excluded from eligibility. Participants who do not have at least 1,000 hours of service during such plan year or are not employed on the last working day of a plan year are generally not eligible for an allocation of Company contributions for such year. An eligible employee will still receive an allocation of the Company contributions for a plan year if employment is terminated on account of retirement, death, or disability in such year.

***Participant Accounts***

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant’s account is credited as of the last day of each plan year with an allocation of shares of the Parent Company’s common stock released by the trustees from the unallocated account and forfeitures of terminated participants’ non-vested accounts. Contributions are determined annually by the Board of Directors in addition to the principal payment related to the loan payable. Plan earnings are allocated to each participant’s account based on the ratio of the participant’s beginning of the year account balance to all participants’ beginning of the year account balances. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation of stock. Allocations of stock are based on a pre-determined percentage of an individual’s eligible compensation for the plan year.

***Contributions***

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends, if any, and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. Employee contributions are not permitted. For the year ended December 31, 2024, the Company contributed \$156,878, which consisted of \$156,878 for the loan payments.

***Vesting***

If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on total years of service in the Plan. A participant is 20 percent vested after two years of credited service and are 100 percent vested after five years of credited service.

***Payment of Benefits***

Distributions of benefits are made in cash. In the event of retirement, total disability or death of a participant, benefits will commence no later than the last day of the Plan year following the Plan year on which a participant retires, suffers a disability, or dies while employed by the Company. Distributions related to terminations may commence no later than one year after the end of the fifth Plan year following the Plan year in which the participant separated from service. The full benefits will be paid in either a lump sum, in five substantially equal annual installments, or in as many substantially equal annual installments as permitted under Code Section 409(o)(1)(C)(ii).

***Plan Termination***

The Company reserves the right to terminate or amend the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Employee Benefits Administration Committee shall direct the trustees to pay all liabilities and expenses of the trust fund.

***Put Option***

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants, includes a put option. The put option is a right to demand that the trust buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The trust can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

***Diversification***

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Parent Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth Plan Year, the participant may diversify up to 50%.

***Forfeitures***

At December 31, 2024 and 2023, there were no forfeited non-vested accounts. Non-vested shares are not considered to be forfeited by the participant until after a 5-year break in service. After the break in service requirement is met, the non-vested shares shall be allocated to remaining eligible participants. During the year ended December 31, 2024, the Company allocated 1,029.02 shares to remaining eligible participants, and they did not reinstate any shares for rehires.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

### ***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded on the payment date. Net change in value includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

### ***Payment of Benefits***

Benefits are recorded upon distribution.

### ***Administration of Plan Assets***

The Plan’s assets, which consist principally of Parent Company common shares, are held by the trustee of the Plan. Company contributions are held and managed by the trustee, which invests cash received, interest, and dividend income and makes distributions to participants.

### ***Administrative Expenses***

Plan expenses are paid by the Company. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

### ***Subsequent Events***

The Plan has evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued.

**Note 4. Fair Value Measurements**

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

The following is a description of the valuation methodologies used for assets measured at fair value.

**Parent Company Common Stock**

The fair value of the Parent Company common stock was based on the closing stock price of the Parent Company on the date of valuation.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Loan Payable**

In November 2021, the Plan purchased 14,154 Parent Company common shares for \$386,288. The Plan financed this purchase through a note agreement with the Parent Company. The loan agreement provides for the loan to be repaid over 5 years with principal and interest payments of \$85,306 due each year starting December 31, 2022. The loan bears interest at the rate of 3.25%. The loan balance was \$162,641 and \$240,142 at December 31, 2024 and 2023, respectively.

In June 2023, the Plan purchased 23,383 Parent Company common shares for \$329,233. The Plan financed this purchase through a note agreement with the Parent Company. The loan agreement provides for the loan to be repaid over 5 years in approximately equal annual payments of principal and interest. The loan bears interest equal to the Prime Rate, adjusted once annually on the first day of each calendar year. The loan balance was \$205,457 and \$263,503 at December 31, 2024 and 2023, respectively.

## **Note 6. Exempt Party-In-Interest Transactions**

Certain plan investments are shares held by the plan sponsor; therefore, these transactions qualify as exempt party-in-interest transactions.

## **Note 7. Tax Status**

The Internal Revenue Service (the “IRS”) has determined and informed the Company by letter dated September 30, 2019, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (the “IRC”). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **Note 8. Risks And Uncertainties**

The Plan invests in investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances, and the amounts reported in the Statement of Net Assets Available for Benefits.
