### Note 1 - Description of plan:

The following description of the OSG Bulk Ships, Inc. Money Purchase Pension Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a money purchase pension plan for employees of OSG Ship Management Inc. and Alaska Tailker Company, LLC (collectively the Company) working as Licensed Deck Officers aboard U.S. Flag vessels and who are not covered by a collective bargaining agreement unless the collective bargaining agreement expressly provides for participation. During the years ended December 31, 2024 and 2023, there were no union employees participating in the Plan. Employees become eligible to participate in the Plan on the commencement date of their employment. The Plan is sponsored by OSG Bulk Ships Inc. (the Plan Sponsor), a sister company to the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

The Company makes contributions to each participant's account in the Plan equal to seven percent (7%) of the participant's daily wage rate for each day of paid employment and paid vacation while an active participant, as defined, plus a set dollar amount per day based on rank for each day of paid employment and paid vacation while an active participant, as defined. The Plan met the ERISA minimum funding requirements during the years ended December 31, 2024 and 2023.

#### Investment options

Participants direct the investment of their contributions into various investments offered by the Plan. Participants may invest in various funds, each with different risk exposure and return potential. The Plan currently offers various mutual funds, a money market fund, and a common/collective trust fund as investment options for participants. Participants may change their investment options daily.

#### Participant accounts

Each participant's account is credited with allocations of the Company's contributions and Plan investment results. Each participant's account is reduced by any withdrawals or distributions and an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account.

### Note 1 - Description of plan - continued:

#### Vesting and forfeitures

Vesting in Company contributions plus actual earnings thereon begins after two years of service, and participants become fully vested at the completion of six years of service. The Plan allows the Company, in its discretion, to determine how to use forfeitures of terminated participants' non-vested accounts. Forfeitures can be used to restore the accounts of participants entitled to a restoration of their interests in the Plan, as defined in the Plan document, reduce the Company's contributions, or to pay expenses of operating the Plan. Forfeited nonvested accounts totaled approximately \$75,000 and \$243,000 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, approximately \$449,000 of forfeitures were used to reduce Company contributions to the Plan.

#### Payment of benefits

Upon termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive a lump-sum, installment direct rollover, or deferred payment in an amount equal to the value of the participant's vested interest in his or her account. A participant may request a withdrawal from the Plan while still under employment of the Company for reasons of financial hardship, as defined.

For termination of service due to other reasons, and if the vested account balance exceeds \$5,000, a participant may elect to receive a lump-sum distribution, have his or her balance rollover to the participant's eligible retirement account, obtain installment payments, or have his or her account balance remain in the Plan. If the vested account balance is less than \$5,000, the Plan administrator will distribute the participant's entire vested balance as a lump-sum distribution as soon as administratively feasible.

#### Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance within the Plan and any other plan of the Plan Sponsor. Note terms range from six months to five years. The notes are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Sponsor (7% as of December 31, 2024). Interest and principal are paid ratably through payroll deductions. Participants are allowed a maximum of two outstanding notes at any point in time under this plan and the OSG Bulk Ships Inc. 401(k) Plan.

### Note 1 - Description of plan - continued:

#### Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The Company reserves the right to elect to pay or have the Plan pay, administrative costs in the future. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits.

### Note 2 - Summary of significant accounting policies:

#### Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### Common/collective trust fund

The common/collective trust fund, at the fund level, is composed primarily of fully benefit-responsive investment contracts held by the fund's trustee. These contracts are not considered fully benefit-responsive to the Plan as the underlying contracts are not direct investments between the Plan and the issuer. These contracts consist of guaranteed interest contracts issued by insurance companies, investment contracts issued by banks, synthetic investment contracts (SICs) issued by banks, insurance companies, and other issuers, and securities supporting such SICs, and other similar instruments which are intended to maintain a constant net asset value (NAV). The Plan has elected to value the collective trust fund using the net asset value (NAV) as a practical expedient to determine fair value.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded when a distributable event occurs.

#### Payment of benefits

Benefits are recorded when paid.

#### Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Risks and uncertainties

The Plan provides for various investment options in a combination of investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the valuation of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### Recent legislative developments

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024 and 2023. Plan management continues to evaluate the impact of the optional provisions of SECURE 2.0 and awaiting additional regulatory guidance from the Internal Revenue Service (IRS) and Department of Labor. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the plan years ended December 31, 2024 and 2023.

Subsequent events

The Plan has evaluated subsequent events through September 17, 2025, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 31, 2024, have been incorporated into these financial statements.

Note 3 - Investments and information certified by the trustee:

Vanguard Fiduciary Trust Company (Vanguard) is the trustee for the Plan. Vanguard holds the Plan's investment assets and executes investment transactions. Management has determined that Vanguard is a qualified institution and the information prepared and certified by Vanguard meets the requirements of ERISA Section 103(a)(3)(C). Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants, and dividend and interest income for the year ended December 31, 2024, was obtained and derived from information supplied to the Plan Administrator and certified as complete and accurate by Vanguard.

Note 4 - Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to (adjusted) quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability.

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds are valued at the net asset value of shares held by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges. Mutual funds are classified as Level 1 of the valuation hierarchy.
- Money market funds are valued at quoted prices and is classified within Level 1 of the valuation hierarchy.
- Units of participation of the common/collective trust fund are valued at the net asset value (NAV) provided by the fund's trustee as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

#### Note 5 - Transactions with parties-in-interest:

The Plan invests in shares of mutual funds, a money market fund, and a common/collective trust fund managed by an affiliate of Vanguard, the trustee of the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services are included in net appreciation in fair values of investments.

The Plan's administrative expenses are paid in part by the Company and in part by the Plan, as provided by the Plan document. In addition, certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

#### Note 6 - Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination participants will become 100% vested in their accounts.

### Note 7 - Tax status:

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC) and; therefore, the related trust is tax-exempt. The plan administrator has determined that it is eligible to and has chosen to rely on the cmTent IRS non-standardized prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC, and; therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
