Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i) as of December 31, 2024 and Schedule of Reportable Transactions (Schedule H, Line 4j) for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and is derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

General

The Consolidated Edison Company of New York, Inc. Tax Reduction Act Stock Ownership Plan (the "TRASOP" or "Plan") was established in 1976 under the provisions of the Tax Reduction Act of 1975.

Effective January 1, 1998, the Plan's investment in shares of Consolidated Edison Company of New York, Inc.'s (the "Company" or the "Plan Sponsor") common stock was automatically exchanged for an investment in shares of Consolidated Edison, Inc.'s ("CEI") common stock. The Company is a wholly-owned subsidiary of CEI. Vanguard Fiduciary Trust Company ("Vanguard" or the "Trustee") is the Trustee, investment manager and recordkeeper for the Plan.

On June 13, 2016, the Plan Administrator amended the TRASOP component of the Thrift Savings Plan, effective January 1, 2016. These amendments clarify the distribution and diversification provisions of the Plan.

Eligibility

For plan years 1985 and 1986, employees, including officers of the Company, on the management payroll for any part of the plan year, as defined by the Plan, were eligible to participate in the Plan for such plan years. For plan years thereafter, only those with account balances remain as participants under the Plan. The last year participants or the Company made contributions to the Plan was 1986.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. The shares remaining in the TRASOP pertain to participants who received allocations of CEI common stock under the TRASOP, but have not received a full distribution of shares.

Vesting

All shares are 100% vested. Participants have full rights to all shares allocated to their account.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. For any allocated share for which a participant has not given instructions, the Trustee will vote those unvoted shares in the same proportion as those shares for which timely instructions were received. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of plan participants and beneficiaries.

Benefits

A participant may elect to withdraw shares or cash while employed by the Company. In the absence of an election for an earlier distribution as an active employee, distribution of a participant's account shall commence no later than the participant's required beginning date, which is April 1 of the calendar year following the later of the calendar year in which the participant attains age 70.5, or the calendar year in which the participant terminates employment. A participant may elect to receive a distribution of his or her account in one of the following forms: five annual installment payments, full or partial lump sum distribution, or monthly payments made for the life expectancy of the participant. Shares allocated to a participant's

account are distributed upon death. The dividend income received on shares held by the Plan is deferred for Federal income tax purposes.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in CEI stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify receive a cash distribution.

Funding Policy and Contributions

Under the Plan, the Company made contributions to the Trust in amounts equal to additional tax credits allowed to the Company under applicable federal income tax laws. Voluntary participant contributions were made in certain years, as permitted under such laws. Contributions to the Trust were used to purchase outstanding shares of CEI's common stock. Dividends paid on shares held in the Trust are either paid out in cash, at participants' election, or reinvested to purchase additional shares of CEI common stock, which are allocated to participants' accounts in proportion to their share balances as of the record date for the dividends. The purchase of shares is attributable solely to dividend reinvestment.

Plan Termination

The TRASOP is subject to certain provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") but is not subject to the minimum funding requirements of ERISA, and benefits under the TRASOP are not guaranteed by the Pension Benefit Guaranty Corporation. In the event of termination of the TRASOP, the Trust will continue until all allocated shares have been distributed to the participants. Any remaining assets, other than shares, will be distributed by the Trust to the participants after the payment of administrative expenses.

2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the TRASOP:

Accounting Basis

The TRASOP financial statements are prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation Policy and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies and procedures are approved by Consolidated

Edison Company of New York, Inc. (the “Plan Sponsor”). See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Administrative expenses are recognized to the extent incurred during the year and permitted by Section 409(i)(2) of the Internal Revenue Code (the “Code”). Such Section limits annual charges payable by the TRASOP for administrative expenses to the lesser of \$100,000 or 10% of the first \$100,000 and 5% of any amount in excess of \$100,000 of income from dividends on the CEI common stock held by the TRASOP. If administrative expenses for any year exceed the limitation, such excess amount will be paid by the Company and is not recoverable from the Plan. As of December 31, 2024 and 2023, no amounts were due to the Plan, as administrative expenses incurred and paid by the Plan did not exceed \$100,000. Additionally, the statements of changes in net assets available for benefits as of December 31, 2024 and 2023 include fees paid by the Plan Sponsor of \$27,000 and \$26,500, respectively, which reflect audit fees not paid by the Plan.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through September 19, 2025, which is the date the financial statements were available to be issued.

3. Risks and Uncertainties

The Plan invests primarily in CEI common stock. The investments are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with the investments, it is at least reasonably possible that changes in the values of the investments will occur in the near-term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

4. Transactions with Parties-in-Interest

The Plan invests in a unitized stock fund, which consists of a Vanguard short-term investment fund component and common shares of CEI. The unit values of the funds are recorded and maintained by an affiliate of Vanguard. During the year ended December 31, 2024, the Plan purchased units in the funds in the amount of \$1,706,033, sold units in the funds in the amount of \$9,789,382 and had a net depreciation in the fair value of the investments of \$732,048. During the year ended December 31, 2023, the Plan purchased units in the funds in the amount of \$1,932,475, sold units in the funds in the amount of \$14,922,680 and had a net depreciation in the fair value of the investments of \$2,993,199. During 2024, the Plan purchased 20,722 shares of CEI’s common stock within the unitized stock fund at a cost of \$1,948,225 and sold 106,276 shares at a selling price of \$9,874,684. During 2023, the Plan purchased 19,883 shares of CEI’s common stock within the unitized stock fund at a cost of \$1,841,933 and sold 163,355 shares at a selling price of \$15,065,038. The total value of the Plan’s investment in the CEI common stock was \$43,988,565 and \$52,642,000 at December 31, 2024 and 2023, respectively.

5. Investments

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no material changes in the methodologies used at December 31, 2024 and 2023.

Shares of CEI’s common stock: valued at last reported sales price on the last business day of the year as reported on the New York Stock Exchange, for reporting purposes.

Mutual funds: valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Tax Status

The Internal Revenue Service ("IRS") has determined and informed Consolidated Edison Company of New York, Inc. by a letter dated December 5, 2017 that the Consolidated Edison Thrift Savings Plan, of which the TRASOP is a part, and related trust are designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
