## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Wireline Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Wireline Group 401(k) Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.



## **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). #### NOTE 1 - Description of the Plan

The following summary description of Wireline Group 401(k) Plan is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

General - All employees of The Wireline Group, Inc. (the Company), as defined in the Plan Agreement, meeting the service requirements, are eligible to become participants in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility - All employees, except for union employees and certain nonresident aliens, are eligible to participate in the Plan on the date of hire. A participant's entry date in the Plan will be the first day of the plan year quarter coinciding with or next following date eligibility requirements are met.

Contributions - Participants may elect to contribute up to 90% of their eligible compensation to the 401(k) Plan. They may choose to do this as either a pre-tax deferral, a Roth deferral, or a combination of both. Participant's contributions are subject to annual maximums in accordance with the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan provides for a discretionary employer matching contribution. Each year, the Company will determine the amount of the discretionary percentage. During 2024 and 2023, the Company made a matching contribution equal to 100% of a participant's salary deferrals, up to 3% of eligible compensation. The Plan also provides for a discretionary employer profit sharing contribution. There were no discretionary profit sharing contributions for the years ended December 31, 2024 and 2023.

Participant Accounts - Each participant's account is credited with the participant's contribution, the employer's matching contribution, the employer's profit sharing contribution, if applicable, rollovers and Plan earnings. Allocations are based upon provisions as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options - Upon enrollment in the Plan, a participant may direct employee and employer contributions in one percent increments in any of the 40 investment options. The options consist of professionally managed mutual funds and a stable value fund, which vary in their respective strategies, risks and goals.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. The Company's matching and discretionary profit sharing contribution is based on years of service. A participant is 100% vested after 5 years of credited services.

Notes Receivable from Participants - Participants may request a loan from the Plan of up to 50% of their vested balance or \$50,000, whichever is lower. The loan term is limited to five years unless it is for the purchase of a principal residence. The loan is secured by the participant's account and bears interest at 2% above prime rate as determined by the plan administrator. Principal and interest are paid through payroll deductions.

Participants' Withdrawals - Upon a participant's retirement date or upon a participant's death or total and permanent disability, all amounts credited to his or her account shall become fully vested. The participant is allowed to withdraw funds from the Plan upon attainment of age 59½. Distributions are payable in the form of a lump-sum equal to the vested balance of the participant's account. Upon termination, the non-vested portion of a participant's account shall be forfeited.

Distribution of the vested portion of a participant's account shall be made upon termination of employment. If the vested portion of the account is less than \$5,000, the Administrator has the option of a distribution without the participant's consent. If the vested portion of the participant's account exceeds \$5,000, a distribution before normal retirement age can only be made with the participant's consent. The non-vested portion of a participant's account shall be forfeited and used to reduce future Company matching contributions or pay plan expenses.

Participants may request that all or a portion of their fully vested account balance be distributed in the case of severe hardship, as defined in the Plan document. The Company must approve any such hardship withdrawals.

### NOTE 1 - Description of the Plan (Continued)

Forfeited Accounts - At December 31, 2024 and 2023, the value of forfeited non-vested accounts totaled \$21,560 and \$1,486, respectively. The forfeitures of non-vested Company matching contributions from terminated participant accounts can be used to reduce the Company's matching contributions or pay plan expenses. For the years ended December 31, 2024 and 2023, forfeitures were used to reduce matching contributions and pay plan expenses in the amounts of \$74,379 and \$50,883, respectively.

SECURE Act and CARES Act - The Plan has implemented certain provisions of the SECURE Act, which was effective January 1, 2020, and the CARES Act, which was signed into law in March 2020. The Plan has until December 31, 2026 to adopt amendments to reflect these provisions.

### NOTE 2 - Significant Accounting Policies

Basis of Accounting - The financial statements were prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions during the reporting period. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are stated at current fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded when received. Unrealized appreciation (depreciation) of investments is the change between market value of investments at the beginning of the year and market value of investments at the end of the year.

Notes Receivable from Participants - Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Participant loans in default are reclassified as distributions based upon the terms of the Plan document. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - The Plan's administrative expenses are primarily paid by the Plan sponsor and are excluded from these financial statements. Fees for the administration of notes receivable from participants and processing of benefit payments are charged directly to the participant's account and are included in administrative expenses. Administrative expenses also include fees for professional services provided to the Plan. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events - Management has evaluated events and transactions through August 12, 2025, the date the financial statements were available to be issued.

The Plan's investments are reported at fair value in the statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels which are described below. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

#### Level 1 Fair Value Measurements

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year end. The fair values of common stock, corporate bonds, and U.S. Government securities are based on the closing price reported on the active market where the individual securities are traded.

#### Level 2 Fair Value Measurements

Level 2 inputs consist of quoted prices for similar assets in active and inactive markets and other observable corroborated market data. Level 2 inputs are only used when Level 1 inputs are not available. This includes, but not limited to, quoted prices for similar assets or liabilities in markets that are not active. The Plan has no level 2 assets.

#### Level 3 Fair Value Measurements

Level 3 inputs have the lowest priority. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available. The Plan has no level 3 assets.

### NOTE 4 - Investments at Contract Value

The Plan's investments include the Transamerica Stable Value Core Option Account, which is considered a fully benefit-responsive investment contract offered by Transamerica Financial Life Insurance Company (Transamerica). Transamerica maintains the contributions in a general account. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Because the contract is fully benefit-responsive, contract value is the relevant measurement attribute. The contract is included in the respective statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

There are no events that allow Transamerica to terminate the contract and which require the Plan to settle at an amount different than contract value, and generally there are no events that could limit the ability of the Plan to transact at contract value.

### NOTE 6 - Information Certified by Trustee

The financial statements, accompanying notes and supplemental schedule were prepared in part from information certified by Reliance Trust Company, the trustee of the Plan, as of and for the years ended December 31, 2024 and 2023, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The information certified includes: cash, investments, notes receivable from participants, investment income, and participant loan interest.

### NOTE 7 - Related Party and Party-in-Interest Transactions

Reliance Trust Company is the trustee as defined by the Plan, and Transamerica provides recordkeeping services to the plan. Therefore, they are considered parties-in-interest. The Company sponsors the Plan and is considered a party-in-interest. The administrative expenses paid by the Plan include plan administration and investment advisory fees. These service providers, along with service providers paid on behalf of the Plan, are all considered parties-in-interest.

### NOTE 8 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, all amounts credited to the affected participants' accounts shall become 100% vested. In the event of plan termination, the administrator shall direct the plan trustee to distribute to the participants all assets of the Plan, net of any expenses properly chargeable to the Plan, which will be prorated among the participants' accounts.

### **NOTE 9 - Tax Status**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the non-standardized profit sharing plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The plan administrator has concluded that as of December 31, 2024 there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits in progress for any tax periods. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **NOTE 10- Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.
