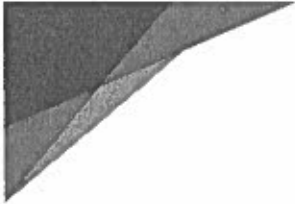

## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of  
MANDEX, Inc. 401(k) & Profit Sharing Plan

### Opinion

We have audited the accompanying financial statements of MANDEX Inc. 401(k) & Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.


### Basis for Opinion

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.



We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

### **Supplemental Schedule Required by ERISA**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

#### NOTE 1. DESCRIPTION OF THE PLAN

The following description of the MANDEX, Inc. (formerly MTS3, Inc.) 401(k) & Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution employee benefit plan established by MANDEX, Inc. (the Company) effective November 1, 1998. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustee of the Plan is Principal Financial Group.

**Participation** - Employees may participate in the Plan on the first day of the month coinciding with or the next month following the date of employment. However, employees who are governed under a collective bargaining agreement are not eligible to participate in the Plan unless such an agreement expressly provides for participation in the Plan. Certain non-resident aliens are also not eligible for the Plan.

**Contributions** - Participants may elect to contribute to the Plan a percentage of their annual compensation, as defined in the Plan. Contributions are subject to certain limitations. If a participant's elective deferrals for a particular calendar year exceed the dollar limitation in effect for that calendar year, as specified by the Internal Revenue Code (IRC), the Plan will refund the excess amount, plus any earnings allocated to that excess amount.

The Plan permits the Company to make a matching contribution equal to a percentage of each participant's elected deferral contributions. However, in applying this matching contribution, only participants' salary reductions up to six percent (6%) of their compensation will be considered. The matching contribution is equal to 100% of each participant's elective deferral up to six percent (6%) of their compensation. For the Plan years ended December 31, 2024 and 2023, the Company made discretionary matching contributions of \$481,568 and \$604,678, respectively.

**Participant Accounts** - Separate accounts are maintained for each participant. Each participant's account is credited with their salary deferral portion, employer matching contribution, and actual net earnings thereon. Net interest earnings and market value increases or decreases in the funds are allocated through various investment options to participants.



## NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Terminated participants' non-vested portions of the employer matching contributions are considered forfeitures. A participant's account may grow from the forfeitures of other participants through "allocation" among participants eligible to share for a plan year. However, a portion of forfeited amounts will be used to reduce the employer's contribution to the Plan.

**Vesting** - Participants are immediately vested and have a non-forfeitable interest in the elective deferral contributions, matching contributions, any rollover contributions made to their accounts and the earnings thereon.

Participants vest in the Company's discretionary matching contribution, applicable to discretionary matching contributions, made prior to January 1, 2014, at a rate of twenty percent (20%) per year, increasing at twenty percent (20%) intervals up to one hundred percent (100%), each year thereafter. Participants become fully vested in their portion of the employer discretionary contributions and respective earnings thereon after five years, upon normal retirement age or upon death or disability.

**Notes Receivable from Participants** - Participants may borrow against the value of their vested account balance within the Plan. A participant may not have more than one loan outstanding at any one time. The total amount of borrowings cannot exceed the lesser of fifty percent (50%) of the participant's vested account balance or \$50,000. Loans bear interest at one percent (1%) plus the prime rate as stated in the Wall Street Journal on the first business day of the month that the loan application is submitted. Participant loans must be repaid through payroll deductions. No loans less than \$1,000 will be made to a participant.

**Investment Options** - Upon enrollment in the Plan, a participant may elect to direct their salary deferral, employer matching contribution and rollover amounts, if applicable, in one or more of the Principal Financial Group mutual funds or pooled separate accounts, or one group annuity contract. Investment options must be allocated in increments of five percent (5%) and combined, total one hundred percent (100%). If a selection is not made to one of these funds, all contributions made on behalf of the participant will be invested in the Principal Fixed Income Guaranteed Option. Participants may change investment options daily via an automated system.

The Company makes copies of each fund prospectus available to its employees. Each prospectus includes descriptions of each of the funds, their associated risks and their earnings history.

## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements are prepared using the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.



## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

**Use of Estimates** - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Investment Valuation and Income Recognition** - Investments are reported at fair value (except for the fully benefit responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are reported on a trade-date basis. Interest income is reported on the accrual basis. Dividends are reported on the ex-dividend date. Net investment gain (loss) includes the Plan's gains and losses on investments bought and sold during the year.

The investments are participant directed. Investments in the mutual funds are carried at fair value which generally represents reported market value as of the last business day of the year. Investments in pooled separate accounts is shown at net asset value based on the value determined by Principal Insurance Company for each investment. Investment contracts held by a defined-contribution plan are reported at contract value which is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in a guaranteed investment contract with Principal Life Insurance Company (Principal), which is a benefit-responsive investment contract presented at contract value. The registered investment companies are valued at the daily closing price as reported by the fund.

**Payment of Benefits** - Benefit payments are recorded when paid.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Investment related expenses are included in the net investment gain (loss) in fair value of investments.

## NOTE 3. INCOME TAX STATUS

The Plan is subject to ERISA and certain provisions of the IRC. The Plan is intended to qualify under Section 401(k) of the IRC. The Plan originated on November 1, 1998. The Plan obtained a favorable determination letter on March 13, 1997, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC.



### **NOTE 3. INCOME TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require management of an entity to evaluate tax positions taken and recognize a tax liability if the entity has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management has evaluated the tax positions taken by the Plan and concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is no longer subject to tax examination for the years before the Plan year ended December 31, 2021.

### **NOTE 4. PLAN TERMINATION**

Although it has not expressed the intent to do so, the Company has the right under the Plan to amend or terminate the Plan at any time in total, or in part, subject to provisions of ERISA. Upon termination of the Plan, all amounts credited to a participant's account will become one hundred percent (100%) vested.

### **NOTE 5. INVESTMENTS**

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include other significant observable inputs including:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

## NOTE 5. INVESTMENTS (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts* - Valued at net asset value (NAV) per share at year end as reported by the insurance company. The NAV is used as a practical expedient to estimate fair value. Share values are based on the current market value or appraised values of the underlying investments.

*Common collective trusts* - Valued at NAV per share at year end as reported by the insurance company. The NAV is used as a practical expedient to estimate fair value. Share values are based on the current market value or appraised values of the underlying investments.

*Registered investment companies* - Valued at quoted market prices as reported by the fund.

## NOTE 5. INVESTMENTS (CONTINUED)

As a practical expedient, accounting guidance permits an investor to estimate the fair value of an investment within the scope of the guidance using NAV. The Plan's investments in certain entities that calculate NAV per share as fair value measurement were comprised of holdings in various pooled separate accounts, the investment objective of which is to seek a total return consisting of long-term growth of capital and current income.

The following table summarizes the Plan's investments in certain entities that calculate NAV per share as fair value measurement as of December 31, 2024 and 2023 by investment strategy:

- a. The Plan's investment in the pooled separated accounts are made up of Principal Life Separate accounts. These investments can be redeemed daily.

## NOTE 6. INVESTMENT CONTRACTS WITH INSURANCE COMPANY

The Plan entered into an investment contract (guaranteed annuity contract) with Principal named the Principal Fixed Income Guaranteed Option (PFIGO) in 2011. PFIGO is a benefit-responsive group annuity contract issued by Principal. The methodology for calculating the interest crediting rate is defined in Article I, Section 2 of the contract under the term "Composite Crediting Rate." Under the terms of the existing contract, the Composite Crediting Rate is currently reset on a semiannual basis and will never be less than the Guaranteed Minimum Interest Rate. The methodology for calculating the Guaranteed Minimum Interest Rate is defined in Article I, Section 2 of the contract under the term "Guaranteed Minimum Interest Rate."

The PFIGO is a single group annuity contract with a fixed rate of interest. The average yield earned by the plan is the yield earned (i.e. interest credited) on the group annuity contract.

The contract meets fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transaction under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment contract value.



## **NOTE 6. INVESTMENT CONTRACTS WITH INSURANCE COMPANY (CONTINUED)**

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by the future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include:

1. Amendments to the Plan documents, including complete or partial termination or merger with another plan;
2. Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
3. Bankruptcy of the Plan sponsor or other Plan sponsor events;
4. Failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; and
5. Premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would also limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation; and
4. A material amendment to the agreement without the consent of the issuer.

## **NOTE 7. EXPENSES**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net gain (loss) of fair value of investments.

## **NOTE 8. RISKS AND UNCERTAINTIES**

The Plan invests in various registered investment companies and insurance company pooled separate accounts. These investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of these investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.



**NOTE 9. PARTIES-IN-INTEREST**

Certain Plan investments are shares of mutual funds managed by Principal as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. The investment in PFIGO also qualifies as a party-in-interest transaction.

**NOTE 10. SUBSEQUENT EVENTS REVIEW**

Subsequent events have been evaluated through September 15, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.
